Sidney Fleener Pleads Guilty and Will Be Sentenced Tomorrow.

This is a case that originated in Lincoln county wherein G. F. Luckey and family in 1900, while crossing a county bridge in said county, the wagon was driven upon a 30 foot span when the bridge fell a distance of 30 feet into the Y-quina river precipitating Mrs. Luckey therein and she was instantly killed. She was aged about 64 years. Therefore the administrator sued for \$5,000 damages for her life. It was first tried in Lane county where a non-suit was granted the county and then a new suit was brought and it was sent to Lane county for trial.

BOHEMIA RAILROAD.

P. J. Jennings, the Promoter, In Eugene.

PROGRESS OF THE SURVEYORS.
Daily Guard, Nov. 5.
P. J. Jennings, the Bohemia mining man and railroad promoter, was in Eugene today on business, returning to Cottage Grove on the 2:38 train.
In an interview at the Hoffman House by a GUARD reporter this afternoon Mr. Jennings stated that the surveyors for the proposed railroad from Cottage Grove to Bohemia are progressing rapidly with their work, having gone 18 miles on the route. T. F. Morphy, of Boston, manager of the railroad enterprise, arrived Sunday night and will soon go over the two routes proposed and decide which one will be chosen. Mr. Jennings said that the one running close to the Booth-Kelly Lumber Co's big tract of timber on Row river will be chosen. In that event a spur will be built running through the tract. Mr. Jennings said that there are 16 men in the surveying crew and they are pushing the work right along. "Plenty of capital is behind the enterprise," he said, "and the road will certainly be built. The survey will be completed about the first of the year, but actual construction of the road will commence at the Cottage Grove end before that."
When asked about the mines, Mr. Jennings stated that the Helena company has all the teams available engaged in hauling ore to Cottage Grove to be shipped to the Felby smelting works in California. They are now taking out some very high grade ore running into the thousands per ton.
The company's proposed smelter in Portland will be looked after when the new railroad is finished. The Bohemia mines can furnish all the ore for a 300-ton-per-day smelter, which is the size of the one to be built, but if the mines of Eastern Oregon, Washington and Idaho wish to patronize it, the capacity will be increased.

THE Y. M. C. A. BUILDING.

Mr. Hanna Is Here to Interest the People in the Matter.

Mr. Stuart B. Hanna, formerly college secretary of the Y. M. C. A. for the Pacific Northwest, and at present general secretary of the city association at Everett, Wash., arrived this afternoon to resume direction of the canvass for funds for the U. O. Association building.
In response to inquiries of a GUARD reporter Mr. Hanna said: "Little has been done for the fund since last May, and local interest in the movement has doubtless largely declined. My Everett duties have tied me down closely since April and all plans and suggestions I made recently to the Oregon state committee have been fruitless owing to their depleted treasury. However, I laid the matter before our international committee, of New York, and now have their full support. The Oregon committee also will back the enterprise, so that from now on everything possible will be done to complete the canvass. We have until Dec 4th in which to secure less than \$3600 with the state for a field and a fair chance for success. Such a building as we aim for is today a necessary part of every college equipment. More than that, no money dedicated to the higher life of men yields so large returns on the investment as that which has been put into these buildings at other student centers. The movement deserves success. If we can but get the facts before the friends of the University they will surely respond. This is our present difficult but urgent task."

RAILROAD RUMOR.

Terminal Grounds May Be Located at Fairmount.

From an S. P. railroad man we learn that it is rumored among the employees of the company that the terminal grounds which are contemplated for Eugene will be established at Fairmount where there is plenty of room. It seems certain now that Eugene will be the end of a division, and when the connecting line between the main road and the Woodburn branch is built between Henderson and Springfield, Eugene will be the terminal point for all trains on the above named branch.
While the Fairmount terminal proposition is only a rumor, such rumors are generally pretty well founded. Fairmount is a good location for the necessary tracks and buildings for a terminal, better than the depot grounds down town, as they would need be crowded.
