POLITICAL CAMPAIGN DRUGG-ERY.

The election will be practically over when our readers peruse this issue of the DAILY GUARD. So far as we are concerned—and we voice the sentiment of the newspaper fraternity of the state—we are heartily glad of it.

A political campaign is to a newspaper what wash-day or house-cleaning is to a woman—just that much more added to the usual work of the day. And if the housewife must occasionally put a poorly prepared dinner on the table through the stress of having to do two day's work in one, so the newspaper is liable to overlook the more important news of the day through "cooking" up the political stew. It only comes once in every two years. For that we should be supremely thankful.

We know it is the common impression that the newspaper is in clover, so to speak, during a campaign. It is just the reverse. With the ending of the campaign the editorial force feels somewhat like the boy turned out of school Friday evening, or as the work-horse is supposed to feel when given the freedom of the pasture and green grass on a Sunday.

PRUSSIAN PEOPLE PAY FOR GLORY.

A Berlin dispatch says that American millionaires who shift the burden of taxation to the middle and poorer classes no doubt contemplate the situation in Germany with secret satisfaction, and say in that good old American slang phrase, "We are not worse."

In the smaller commercial districts of the German empire the burden of taxation is something almost beyond belief. In one case in the district of Volmarstein a taxpayer paid in state and communal taxes and rates on an income of 6,000 marks, [\$1440], no less than 2,126 marks, [\$510], more than one-third of his entire income.

NEW YORK SUMMER MUSIC.

New York will treat its poor to good music this Summer. Classic selections will be played on the recreation piers of Manhattan instead of the usual "ragtime." All of the seven piers are to be opened to the public on Decoration Day, and no band-leader will be permitted to remain at any one pier longer than a week. In some instances the change will be made twice a week, and none will have more than 30 nights' play.

The taste of the different localities will also be taken into consideration. Italian music will be played in the Italian neighborhoods, while Vatarian melodies will charm the Germans and old Irish airs make happy the hearts of those from the old sod.

Senator McLaurin of South Carolina became a political renegade on consideration of controlling the official patronage of his state through President McKinley. His term as senator having expired he could not return to his old home where he was tabooed socially and politically. Of course the people for whom he sacrificed himself were bound to take care of him. President Roosevelt will appoint him to a good position on the court of claims. Little to do and a big salary. Such a straight bargain and sale as this is not creditable to American politics. The man sold out once. There is no assurance he will not sell again—and this time justice.

The days of miracles have not passed—at least not for Frank Miracle. He has been appointed register of the land office at Helena, the Montana capital city.

The Democrats had the advantage to commence with this morning, that is if there is any truth in the old saying, "A rainy day for Democrats."

Supporters of Senator Kuykendall are not proud of the Register declaration that the gamblers, "regardless of party," are backing and offering to bet odds on the reelection of Senator Kuykendall. It has happened that betting money has been furnished by the party or a candidate for the purpose of influencing such voters as have a mania for getting on what they consider the strong side. Are the gamblers the Register refers to handling Dr Kuykendall's money? Stranger things have happened in politics.

The Oregonian insists that its readers should not forget that "great things are involved in this election." Of course! A candidate for governor who was able to get nearly five thousand dollars a year out of the government for just taking whiskey-to-Indian sellers to Portland, then \$23,000 a year out of the sheriff's office of an ordinary county like Umatilla is a "great thing." And he is involved in this election, in fact badly involved—at least will be after Monday.

The Oregonian heads a plea in behalf of Furnish "A Manly Record." That cannot mean anything else than that Mr Furnish acted like a man and left a good big well-filled sack on the editorial table when he called on the Oregonian editor, to impress him with the idea that he was "business" from the ground up, and would like to get a chance to do "business" about the state treasury in the role of governor.

If faithful performance of duty deserves reward Sheriff Withers should be reelected Monday. The public looks at it the same way, that is if the increase of his majority of 58 in 1898 to 794 in 1900 may be taken as an index. We believe that majority of two years ago will be increased Monday. Watch the returns and see if this prediction is not verified.

The weather could not have been more perfect for Decoration Day. But nature, as if in mockery at futile remembrances of the dead, made sad havoc with the beautiful floral decorations within a few hours after they had been placed on the low mounds. It is the way of all the world.

The Democratic party of Lane county has well remembered the work of the State University. Travis for state senator and Hal-Edmundson for representatives, all graduates and representative, give credit to young Democracy.

Blood Vessels of the Eye.

Purkinje discovered a very simple and highly entertaining experiment by means of which the retina, with all its veins and blood vessels standing out in relief against it, can be thrown into the air before one's eyes. It is called the aborescent figure, to its likeness to a many branched tree, and is produced in the following manner: In a dark room at night move a candle backward and forward before the eyes. After a few seconds the air will assume a reddish appearance, and running over it in all directions may be seen the veins and blood vessels in bold relief, while toward the center of the figure there rises up a dark trunk, from which the veins branch out on all sides.

The trunk is visible where the optic nerve enters the eye, and this experiment is chiefly interesting to the student as proving that the parts of the retina which actually receive and produce the sensation of light must lie behind the blood vessels, since these cast their shadow on to it and can be seen as clearly as any other object externally.

They Didn't Interfere.

Governor Bob Taylor of Tennessee had a heart as tender as a woman, and the way he pardoned out convicts was something awful. He was waited upon by a committee of the legislature, who very flatly and in no uncertain way told him that this "wholesale pardoning must stop."

"Governor Bob" looked at the committee, tapped a bell, asked for his pardon clerk and when he came said: "Make out pardons for every man in the penitentiary."

The clerk bowed and withdrew. Then the governor looked at the committee, who were staring as if they thought he was going mad. "Gentlemen," he said finally, "I am governor of Tennessee, and if this committee or any other ever again seeks to interfere with my constitutional right to pardon I'll sign every one of those pardons which the clerk is making out.
