

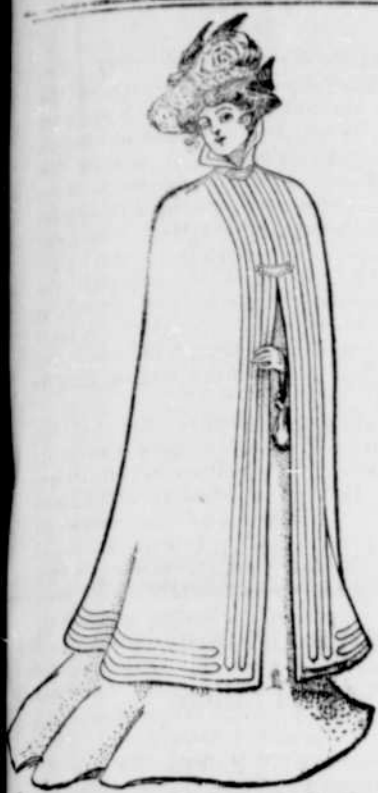

DR. HOPKINS' "WOLF."

"Frate" Crow Says it Was His Pet Coyote That Was Killed.

Just about the time Dr. Hopkins had settled down into the belief that his reputation as a hunter was made by the reported killing of a "gray timber wolf" about Spencer's Butte, in yesterday's GUARD, "Frate" Crow comes to town with the story that it was his pet coyote, and was no larger than a small dog.

Mr. Crow mourns the loss of the wily animal that he considered a pet in a certain sense, for it did not seem afraid in the least and would come within a few steps of him, although he could not handle it. The coyote was a pup when he first saw it about four years ago.

It grew up about his place and at times was so friendly with his dog that they would chase squirrels together. At other times they would fight. The little animal would fight any strange dog that came about, usually holding his own in the scrimmage. Then it was death on the pesky jackrabbit, catching it as he ran and throwing it several feet high twirling in the air. Mr. jackrabbit was dead when he struck the ground.

During his several years of more or less intimate acquaintance with the animal Mr. Crow says he never knew of it disturbing sheep. He says that a ten-dollar piece would be no object if it could restore the little fellow to life.

Smallpox Spread.

Keep your eye out for the yellow flag and don't run into the smallpox on purpose. The light form of the disease is spreading in Eugene so as to let the authorities in maintaining the quarantines which they establish. This is the only way to stamp out this troublesome pest. There are a half dozen flags up.

The following places are labeled with the yellow flag: Jackson's, O. K. and East Fifth, Ike Simpson, Mill street; Gabby's, Oak and East Sixth; and the Body family on Mill and East Fifth streets. This last house contains six cases, the whole family being down with it.

Measles exist at Ware's, Oak and East Fifth, and at Lester's house.

\$400 Surplus on Hand.

Secretary M. S. Wallis of the Carnival Board reports that a surplus of \$400 will be left on hand after all bills of the committee are paid. This is an excellent showing for the board and speaks well for their business management of the carnival. It has not been officially decided what is to be done with the surplus but it is suggested that it be kept intact for a district fair in 1903.

CEMENT CROSS-WALKS ADOPTED

City Fathers Sharp for Improvement of Eugene in Every Way.

At the regular session of the city council last evening all members were present. The usual list of bills were allowed. Mummy Bros were ordered repaid for expenses incurred under rescinded contract to construct the Fifteenth street sewer.

Thirteen thousand three hundred and twelve feet of lumber was used during the past month for repairs to crosswalks, etc. South Willamette culvert bridges were ordered repaired. Also the footbridge across the mill race on Ninth street. An ar light was ordered placed at the intersection of Eighth and Olive streets. Ten new fire hydrants were ordered from the Fraser Iron Works at \$10 each. It was ordered that the city attorney draft an ordinance for building of the west side sewer. Several new sidewalks were ordered built, and Patterson, Mill and Ferry streets between Fifteenth and Seventeenth streets ordered graded. The Eleventh street sewer was extended one block east. A new ordinance providing for the construction of the Fifteenth street sewer was passed.

One of the most important orders of the council was for the construction of four cement crosswalks across Willamette at the intersection of Eighth and Ninth streets. The cost of these crosswalks is estimated to be about \$90 each.

Thus do the city fathers look after the welfare of Eugene, the liveliest interior metropolis in Oregon, barring none. Old buildings give way to new; wooden crosswalks resign in favor of durable cement; new walks are constantly being constructed; new lights placed in position; sewers built and almost every prayer for improvement is granted. Eugene has dollars for growth but not one cent for mosquitoes. It all goes to make a city a bigger, better and more attractive one.

TO RE-OPEN ATHLETIC RELATIONS

Steps to Bring About Peace Between Oregon and Washington Universities.

The Seattle correspondent of the P. and T. Telegram says:

"The University of Oregon has taken the initiative toward the reopening of collegiate relations with the University of Washington. Letters have been received from the faculty and students of the U. O., stating that those responsible for the breach last year have left school, and that the new men who are in charge of athletic affairs this year are anxious to reopen athletic relations.

"The Pearson brothers, the star athletes on the Washington team, were the cause of trouble last year. After their arrival, the Oregon boys charged that the Pearsons were professionals, and demanded that they be excluded from the list of contestants on the Washington team. As there was no time before the meet to investigate the charges Washington refused to exclude the Pearsons. Then Oregon made no effort to win, and was defeated to the tune of 13 to 19, scoring just enough to entitle them to their position of the gate receipts."

Meeting of Directors.

Directors of the U. S. Consolidated Gold Mining and Milling Company held a meeting in Attorney L. M. Travis' office last evening. C. J. Harbelle was elected president, vice I. W. Pope, deceased. The directors will market 100,000 shares of their stock and publish a prospectus. Their property lies in the Bohemia district.

A BOOM IN COAL STOCKS

Prospects of Strike Settlement Send Stocks Upward.

May Arbitrate Strike.

WILKESBARRE, Pa., Oct. 14.—It is now considered certain that President Mitchell of the United Mine Workers will accept the terms proposed by the operators for an arbitration commission, the appointment of the same to rest with President Roosevelt.

The miners all over the coal region are jubilant at the prospect of a settlement. They consider it a victory for their side of the long drawn-out contest.

President Mitchell refuses to talk for publication till he can make a definite announcement as to the decision of the Mine Workers.

[The conference at which the coal operators agreed to arbitration was held at the temporary White House in Washington last night between President Roosevelt, Secretary of War Root, J. Pierpont Morgan representative of the coal trust railroads, and his partner, Robert Bacon.

The committee is to consist of an Army or Navy engineer officer, an expert mining engineer not connected with the coal mining properties, one of the judges of the United States Courts of the Eastern district of Pennsylvania, a man of prominence as a sociologist, and a man who by active participation in mining and selling coal, is familiar with the physical and commercial business. The operators also make it a part

of the proposition that the miners shall return to work as soon as the commission is constituted, and cease all interference with nonunion men. The commission is to name a date when its findings shall be effected and to govern conditions of employment between the companies and their own employees for at least three years.—EDGUARD]
