Fifty Thousand Rose Trees, Covering Four Acres, Make Up Famous World's Fair Beauty Spot.

A million roses will bloom at once in the vast rose garden at the World's Fair. That is guessing, of course, but the foundation of the guess is this: Four acres are set to strong and vigorous rose trees. Thirty of the largest exhibitors have sent their choicest stock and each will strive for first place in the judgment of the jury and people.

This rose garden, the planting of which was begun early in April, occupies one of the conspicuous sites in the City of Knowledge. The center of the garden is at the main entrance to the Palace of Agriculture, a grand structure 1600 feet long and 500 feet deep. It is on a high elevation overlooking the group of main buildings of the Exposition, and looking to the northeast a splendid view of one of St. Louis' most attractive residence districts is spread out before the eye.

When the graders finished their work and turned the site over to the gardeners, every vestige of soil had been removed, and a broad expanse of sticky, yellow clay remained. Surely to the layman a most unfavorable location for a flower garden. But to the practical rose grower it was an ideal spot. The ground was platted with a series of eight collections, forming a great oval 150 feet long and 100 feet wide as the central picture. In the center of this oval is erected a statue of the Goddess of Flowers, in heroic size. Flanking this oval on the north and south, are two great collections, triangular in form. Scores of other collections laid out in plots of ground in various shapes, but all conforming with the general harmony of the main picture, have been provided.

Each collection, while separate and distinct in itself, forms a part of a great and artistic whole, and a belt of beautiful green lawn, from four to eight feet wide, surrounds each collection. Spacious gravel walks are provided throughout the entire four acres of roses, and at various intersections beautiful fountains, sending up streams of crystal water and cooling the atmosphere, are to be met. Seats to accommodate thousands of visitors have been provided and the seats are so distributed as not to interfere with the free passage through the gardens of countless thousands who will revel in the glorious sight. The work of planting the 50,000 roses already growing in this mammoth garden, the largest of its kind ever conceived, occupied the time of scores of expert gardeners and hosts of laborers. For each collection excavations 18 inches deep, of the form and size required for the collection, were dug in the sticky clay soil. Then the excavations were filled in with rich top soil and sandy loam. A dressing of fertilizer, of the kind best adapted to the requirements of the particular rose collection, was spread and then came the work of putting the young plants in their magnificently conceived new home.

Remembered His Own Store Front.

Daily Salem Statesman, (Republican), April 4, 1890: The lower and upper Coquille River in front of Mr. Hermann's store will fare well in the forthcoming river and harbor improvement bill. They get \$30,000, while the upper Willamette gets \$25,000. The main commerce of the Coquille is that done by the store of Mr. Hermann. The whole of it will not amount to as much as the trade of one of the dozens of small towns on the banks of the Willamette. It is high time, after 12 years of this sort of work, the peoples of Western Oregon had their eyes opened.

The Statesman is now trying to send Mr. Hermann back to the place where he got thirty thousand dollars for the benefit of his Coquille store. How can the Statesman figure Mr. Hermann right now when he was so wrong then? "High time the people of Western Oregon had their eyes opened"? If it were possible to get a pry on the Statesman eyes just now

in regard to Mr. Hermann, you could not open even one of them with a crowbar.

One of the interesting exhibits that may be seen in the Horticultural Department at the Louisiana Purchase Exposition at St. Louis, next year, will be the fruits fresh from South Africa. The managers of fruit farms of the late Cecil Rhodes, at Cape Town, have announced their intention of placing fresh fruits on exhibit each week. Even in London this feat has never been undertaken.

Not a few of our people will remember a little old man who first introduced the Percheron horse to this section not a few years ago—W. C. Meyer. He was buried at Ashland Saturday, 85 years of age. Mr. Meyer had a reputation that extended all over the coast as a breeder and importer of fine cattle and horses. The French Percheron was not a success here though—too tender for the climate and the exposure to which he was necessarily subjected. Then, like most big horses, his feet were not sound—in fact there is no fault to be found that the Percheron stock that Mr. Meyer unfortunately became responsible for has pretty well disappeared from the Willamette Valley.

The lockout is complete, both shops and structural work on buildings being affected. Eighty men are thrown out of employment through the action of the bosses.

The men had made no demands. It is alleged in labor circles that this lockout is a part of a concerted plan to burst the Building Trades Council.

Then he varied the program of robbing his partner by securing four thousand dollars from dealers and block owners in advances of \$1.25 a cord on wood contracted for, in consideration of a reduction in the contract price.

Her Head Cut Off.

Spokane Wash., May 28.—Julia Porack, aged 20 years, daughter of Rudolph Porack, a pioneer brewer of Sprague, was run over and killed about 11:30 o'clock last night at the Northern Pacific depot by train No. 3 from the east. She fell beneath the wheels and her head was cut off. Death was instantaneous.

Leasia is Arraigned.

Portland, Or., May 28.—Martin V. Leasia, who murdered his father-in-law, F. H. Drews, last Sunday morning, was arraigned before Presiding Judge Cleland in the state circuit court yesterday. At his own request the murderer was given until Friday morning to obtain counsel and prepare to plead.

Hanged by a Mob.

Newcastle, Wyo., May 28.—W. C. Clifton, murderer of Mr. and Mrs. John W. Church, was lynched by a mob from Gillett last night. The mob battered down the jail door, holding up the sheriff and deputy while, and hanged Clifton to a bridge west of town. Clifton's head was cut off by the fall of 40 feet.
