WOULD DYNAMITE PRESIDENT'S TRAIN

Explosives Found on Track Over Which the Train was to Pass.

Bloomington, Ill., June 4.—A discovery of dynamite yesterday on the Chicago & Alton track near the town of Lincoln, over which the President's special traveled, has led to a suspicion that an attempt to kill him was being made. Anarchists of Chicago are suspected. The police refuse to discuss the affair in any of its phases, although a hundred private officers and secret service men are already working on the case, which is considered very alarming.

Bet Heavily on Election.

Grant's Pass June 4.—More money was exchanged in this city in a betting way at the recent election than has been exchanged for the same purpose since the presidential election of seven years ago. The bets were nearly all made on the results of the county. As Josephine is strongly Republican Reames' majority of 175 came as a surprise to many. A few Republicans and Hermann supporters lost as much as \$100 each, and a number lost from \$10 to \$50.

All on Board Lost.

London, June 4.—A dispatch to the Lloyd's yesterday from Valparaiso reports the loss of the Pacific Navigation Company's steamship Aroquiah Tuesday night with 80 people on board, including passengers and crew. The dispatch adds that several large and scores of small boats were wrecked in the harbor during the gale of the last two days, and that the city of Valparaiso suffered considerable damage.

Eagles' Convention.

The Dalles, Or., June 4.—The Eagles will hold their state convention here Friday and Saturday. There will be delegates from this state, Washington, Idaho and Montana. It is thought there will be 200 delegates in attendance. The lodge is making preparations to entertain the visitors royally. Friday will be a business session, and on Saturday night a banquet will be served.

A Great Rebellion.

Pekin, June 4.—Reports were received here today that the rebellion in the Province of Yunan is spreading in alarming proportions, and it is believed that an uprising will be made that for atrocities has not been equalled since the Boxer massacres.

THE MARIE WARE CASE

(Daily Guard, June 4.)

Anent the arrest of Miss Marie Ware in Portland yesterday, an account of which was given in a dispatch to the Guard yesterday, the following is from the Portland Journal of yesterday:

"They tell me I am to be arrested. Well, here I am!"

Dressed in the height of fashion, with her beautiful auburn locks artfully coiled about her shapely head, and with a smile upon her dainty, rosebud lips, Miss Marie Ware entered the office of Deputy United States Marshal Pres. Worthington exactly at noon today. With the above remark the handsome young woman greeted the officer as he advanced to meet her with the warrant in his hand. Forgery and conspiracy is the charge.

Within ten minutes from the time she entered the Federal Building Miss Ware had been formally taken into custody, had listened to the charges against her, had heard the date of her hearing, had given bonds and gone forth again free. Her brief stay with the authorities was more in the nature of a society call than an arrest. Miss Ware's bonds were furnished by G. F. McClintock and Finley Morrison, who pledged themselves in the sum of \$1000 each for her appearance on the date set for trial.

SAYS SHE'S INNOCENT.

"I have nothing to say further than that I am entirely innocent of any wrong-doing," said Miss Ware, sweetly, when seen after having been arrested and released. "I do not care to make any statement to the press. I have no fear of the outcome."

Her debonair appearance seemed to bear out the truthfulness of her assertion. "You will excuse me," she urged, "but I have not yet had luncheon." She tripped down the street chatting with a young lady companion, seemingly to have not a care in the world.

MC KINLEY LOOKS WORRIED.

Horace McKinley, although pleasant and cheerful, looks worried and seemed to feel deeply the disgrace attached to being brought before the public in the guise of an alleged criminal. His reticence, however, corresponded with that of Miss Ware, with whom he is very friendly.

O'Day & Tarpley, of Salem, are attorneys for McKinley and Miss Ware.

SHE MUST FACE CHARGE.

Authorities interested in bringing to justice those who have figured in the land frauds of Oregon said today that the statement made in the papers to the effect that Miss Ware would not be prosecuted providing she would give testimony against others, without truth. They urge that information has been filed against her the same as against others and that she will be placed on trial in the same way and dealt with strictly in accordance with the law.

Will Move to Salem.

Hon. O. P. Hoff of Portland, who was appointed Labor Commissioner by the State Board on Monday last, came up to Salem yesterday morning, and took his oath of office and held a consultation with the board. Mr. Hoff is a splendid appearing man, is an affable and pleasant conversationalist, and gives one the impression that he is thoroughly competent in every respect to fill the high position for which he has been chosen. The Statesman reporter was misinformed as to Mr. Hoff's occupation, as he is not a conductor, but an agent of the Southern Pacific Company, formerly a resident of Lane county, but more recently of Portland. Mr. Hoff stated yesterday that it was his intention to move his family to Salem and make this his official headquarters and his home. The people of Salem will extend to him and his family a cordial hand of welcome.—Statesman.

VINEGAR FACTORY FOR THIS CITY

Final details for the completion of plans for the establishment of a vinegar factory by E. H. Ingham and J. H. Zimmer, were made known last evening.

Mr. Ingham and J. H. Zimmer, both of whom are well versed in the manufacture of good vinegar, have purchased the Ebbert warehouse, east of the S. P. depot, and the Ingham warehouse is to be moved to the site of the newly purchased house. This will make ample space for the manufacture of the best vinegar that can be made.

The capacity of the plant will be increased with the growth of the business, which promises to be great during the infancy of the industry.

WILL INCORPORATE.

Mr. Ingham informs the Guard that articles of incorporation are now being prepared. He and his father, John Ingham, and Mr. Zimmer will be the incorporators and the company will have a capital stock of \$20,000. Mr. Ingham states that the new factory will be the largest of its kind on the coast.

Satisfactory rates have been made with the Southern Pacific railroad and large shipments will be made.

Another Insane Woman.

Adaline Sackett of Coburg, aged 40 years and single, was examined for insanity before Judge Kincaid this forenoon and sentenced to the state insane asylum. Mrs. L. W. Brown and T. W. Harris were the examining physicians. The cause of insanity is cerebral embolism or hemorrhage, when she was three years old, and she has been weak minded ever since. She was taken to Salem this afternoon by Deputy Sheriff Bown, with Mrs. Jennie Barnard as guard.

SALEM AWARD-ED CONTRACT

High School Will be Built by Welsh & Maurer.

Meeting of the School Board This Morning Decided the Matter—The Bid was \$24,250.

The school board met this morning to act finally on the bids submitted by contractors for the construction of the new High School building which was ordered by the vote of bonds at a recent election. Welsh & Maurer, contractors of Salem, were awarded the contract. Their figures were \$24,250, including the installation of heating and ventilation apparatus. The bid was \$500 lower than others submitted.

After considering what was the best thing for the district to do the directors were impressed with the offer of the Salem men and considering the fact that they agree to install a ventilating and heating plant in the building at their figures, the contract was let at very reasonable rates. Architects Pugh and Carey, who drew the plans, are in the city and have the final details of the specifications completed. Work will be commenced on the building as soon as the schools are out. The first work will be to move the Central building 40 feet to the west. The foundation will then be laid for the finest High School building in the Willamette Valley. Every effort will be made to have the building ready for the opening of the school term next fall.

MANGLED BY A MOVING TRAIN

Jerome Lytle, Former Resident of Lane County, Killed Near Dayton Yesterday.

Jerome Lytle, a former resident of Lane county, born at Coburg, yesterday morning attempted to board the Portland-bound train at Dayton before the train had stopped. He was thrown down and partially under the wheels which crushed his legs in a frightful manner. He was taken up to Portland and to St. Vincent's hospital where he died early in the afternoon. His leg was removed by amputation and he could not survive the added shock.

Uncle Sam Baughman Dead.

MORE SEWERS.

According to the will of the residents of the city the recorder was authorized to advertise for bids for the construction of sewers in different parts of the city. The largest is the 22-inch sewer on Jefferson street, leading from West Eighth street to the river. The call for bids appears in the Guard this evening.

The bids call for construction of a 15-inch sewer between Pearl and Oak streets leading from the main sewer to East Fifteenth street; a 6-inch sewer on East Eleventh street from the east end of present sewer to A street; a 6-inch sewer from the east end of the alley in block 2, of Packard's addition to the west side of Jefferson street.

These improvements will be welcomed by all as a step in the right direction.
