

DELIVERED FROM JAIL

Ten Prisoners Escape From Baker City Jail.

Norris & Rowes' Circus Men Do the Act and But One Pris- oner Remains in the City Bastile.

(Scripps News Association.)
Baker City, July 10.—A big jail delivery took place here last night about 11 o'clock. Out of eleven inmates of the city jail but one remains. The ten made good their escape on the circus train of Norris & Rowe, whose show appeared here yesterday and last night.

At sundown an employee of the show was arrested for attempted burglary of the Hotel Vendome together with a tramp negro. They were locked up pending appearance before the court and later a dozen circus men, armed with crowbars stolen from the railroad tool house broke open the jail and let the inmates free.

The prisoners all escaped on the circus train which was ready to pull out of the city. The alarm was given by a negro who was too drunk to take advantage of his opportunity to escape.

The affair has caused quite a sensation here and officers are making all efforts to locate the men. Most of the inmates were incarcerated on minor charges.

Narrow Escape From Death.

Cottage Grove, Or., July 10.—Tom Aubrey, W. F. & Co.'s agent here and formerly agent for the S. P. Co., at this place was struck by the north-bound overland train No. 12, this afternoon.

Mr. Aubrey was pulling his Wells Fargo truck out onto the station platform, as the train was coming in, and was struck by the locomotive and knocked insensible. He was carried into the depot and a physician summoned. An examination showed that with the exception of a few bruises on the head and body he was not otherwise injured.

2000 Foot F. I.

He was dried in the tannery and taken to his home on East Thirteenth street. Bert Apper, Archie Terrell, Clarence Stevenson, John and Charles Haines and Cham Callaway assisted Mr. Morgan with the rescue.

ISAAC JONES IN AN ACCIDENT

Big Foreclosure Attempted.

Corvallis, Or., July 10.—A sale by the sheriff of 55,000 acres of land, that was to have occurred on the court house steps at Corvallis tomorrow, has been stopped by a temporary injunction. The sale was under foreclosure proceedings, and the amount of the judgment was \$101,000. Of the lands, 23,000 acres lie in Benton, about 2000 in Polk, and the remainder in Lincoln counties. The tract is known as the Coe lands. They were chased and a mortgage given. The mortgage is being foreclosed.

Walkout at Salem.

Salem, July 10.—The linemen in the employ of the Pacific States Telephone & Telegraph Company's office have gone on a strike in sympathy with the striking linemen on the system, the demand for higher wages and shorter hours having remained unsettled. It is expected that the "Central" girls will follow in the lead of the linemen, though denied by the operators here. There were only three linemen here, and Manager W. H. Daney says he will soon fill their places.

Springfield Hoodlums Cause a Runaway—Other Notes From the Neighbor City.

On approaching the village of Sodaville his wagon was stopped by a "city" official and after a short time he was presented with a ban on quarantine notice which the city marshal had manufactured. It prohibited him from driving into the city because he came from Prineville, though the smallpox had been over with there for weeks.

REPORTS GO TO HARRIMAN

An interesting bundle of reports has just been sent to President Harriman of the Southern Pacific, which will probably decide him to build the contemplated extension of the Columbia Southern of the O. R. & N. in Oregon, says the Tuesday's San Francisco Bulletin. This is the road which it is prophesied will one day meet the San Francisco and Eureka, now building north from the California Northwestern terminus, and to the construction of which said Harriman will devote the purchase price paid by Clark for the Oregon Short Line.

The reports are based on investigations made by a party of railroad men headed by President Lytle of the Columbia Southern and the chief engineers of the two roads, who carefully looked over the country for routes for feasible surveys. The trip was undertaken on the suggestion of Harriman, made at a conference with Mohler in this city. At that time Harriman reserved his final decision to build the road until full reports of the conditions of the northern country could be made to him.

Accompanying the report of the railroad officials, which has just been forwarded to the Southern Pacific President, is one of Professor French of the Agricultural Department of the Idaho University, who at Harriman's request investigated the soil and climatic conditions in the section to be traversed by the proposed road. His report on the possible development of the country from which for a time the road would draw its traffic, will have much weight with Harriman.

It included a number of statistics in regard to timber and farming resources, as well as the possibilities of future development and is said to be favorable to railroad construction through Southern Oregon. Should Harriman give his final decision for the road at once, surveys will be sent into the field without delay, and the Columbia Southern will push its way south towards the northern boundary of California, which it is said to be Harriman's intention to reach in the future, and connect with the northern terminus of his Eureka road.

THE BAND HAS REORGANIZED

The Fourth Regiment Band has gained a new lease of life. The members whose terms of service with the Oregon National Guard had expired have re-enlisted and the personnel will be about the same as it was when the band was doing its finest work.

At the meeting of the band members last evening this course was decided the only one which would be conducive to the best interests of the band. Without an organization as an official institution there was danger of becoming a second rate band and no one wanted that. The band will soon be in a condition to give the public the old-time excellence in the way of fine music. The matter of director is not yet settled, but will be to the best interests of the organization.

Note and Comment.

The season of the Willamette Valley Baseball League closes in a few weeks. Although most of the towns in the league started in with comparatively poor teams, they will all, with the exception possibly of Albany, end the season with first-class teams, everything considered. The people of the several towns have shown a sustaining amount of interest and the managers will very likely come out ahead.

But when the season is concluded what are the people of the four principal towns of the valley to do for amusement during the rest of the summer? It is true that a large number will seek recreation at the coast or in the mountains, but there will still be a large number who will be unable to leave town at all or at most only for a short time. The season from now until September will be long enough for another series of games equal in length to the one which is just now about to be finished. It seems to many that it would be a good thing for the directors of the league to get together and make arrangements for another series of games.

A dispatch to the Portland Journal says: The most revolting crime in the history of any country came to light today. At Devlin, W. Va., Monday, a burly negro kidnaped a young girl and took her to the woods and there tied her with ropes and repeatedly outraged her. He left the young sufferer tied to the tree and returned Tuesday with food and again assaulted her. He repeated the terrible crime Wednesday. Thursday a searching party found the poor girl half dead. The men succeeded in resuscitating her and leaving her tied there lay in wait and when the negro came he told his victim that he was going to kill her.

The party rushed out and seized him. They completely skinned him with sharp knives and then tore the flesh from the bones, after which they repeatedly fired shots in different portions of the body. The negro died in terrible agony.
