What Oregon Must Have

The people of Oregon should use good judgment in making nominations for congressmen. For 40 years the "bosses" have made the nominations and Oregon, from this system, has fallen till the men selected by this method, three of them, have been indicted by the federal grand jury, in two instances convicted, and the remaining senator ignored by the national administration.

Governor Chamberlain, through the death of Senator Mitchell, has given the state a senator who is in accord with the administration and there is no doubt that Senator Geary will accomplish much for Oregon.

The people for the first time will nominate a congressman to succeed the bosses' choice, Blinger Hermann. It is to be hoped the people will fall into no trap and not nominate a "stand pat" man who has always worked in harmony with the few bosses that have brought Oregon to its present disgraceful position. Both parties in this district have good, capable men, and nothing else will do for the state. The man who represents this district should be a man above a single word of reproach, morally, financially or otherwise. As soon as any new congressman is elected his record will be scanned and his history will be an open book to the voters that be at the national capital.

This district must send a gilt-edged man to congress if we desire results, and the people must first investigate for themselves and learn not to vote for this nomination because some spellbinder puts himself on the back and says: "I am it, the only 'it' in Oregon." Always stood by the "ring" that has brought Oregon to its present position. I have stood by them through thick and thin. I stand by the president, by the senators, by the people. I'll stand for anything you want if you will just vote for 'is'.

Need Some Hop Laws

Hop buyers seem to be alike everywhere. To the uninitiated it seems strange that this business could not be conducted on an honorable basis, but it seems such is not the case. When a grower sells his troubles begin, for that is where the "skinning" process commences. The dealer who has had samples then must sample each bale and strange to say he finds many bales of inferior quality, but never finds one better than his original sample. He then will not accept those he has so wisely refused unless they are given to him. The original sample is drawn by the dealer and taken at random from the lot and is, of course, as a rule a fair sample, but every grower finds the same experience, knows when he sells how to expect a holdup.

Last year the legislature of Oregon passed a law making five pounds tare on a bale of hops, but some of the unscrupulous have deducted seven pounds tare, evading the state law, and as our energetic law-makers failed to make a penalty for evasion of the law it might as well not be on the books.

Oregon needs a state hop inspector whose duty it shall be to grade or by some means protect the hop growing industry and not allow a set of men the privilege of mulcting the producers.

A Russian Republic

Day by day the revolt in Russia is spreading. And why should it not spread? Ever since the present generation has been alive the Russian government has been a synonym for brutality, oppression, extortion and murder. For the benefit of a few members of one fam-

ily, and their sycophants who make up the autocracy, the people of Russia have been plundered, murdered, tortured and even worse. That the people have been so slow to rise in defence revolt says much for the stolidity of the Russian character.

To us in America this sort of government is inconceivable. We simply cannot understand what it means. If there were an effort to establish it here it would be met by an armed revolt within thirty days.

The Russian peasant, "brothers to the ox," have endured it for these many years. The whole world should rejoice that at last they are rising to overthrow a government which is wholly unworthy.

There are times when revolution is rightful. In Russia this seems to be the right moment. Out of the ruins there may be erected a government that may not be ideal, but it will be a step toward a government for and by the people. Out of the French revolution came the Napoleonic despotism. But through struggle and sorrow, by blood and by fire was finally worked out the French Republic with other European people sharing increased rights and liberties.

Perhaps the world will yet see a Russian republic going on as peacefully and as prosperously as the republic of France is proceeding today.

The Albany Herald says editorially: Eugene reports that smallpox is stamped out. What promised to be a serious outbreak of this disease has yielded to prompt and scientific measures and the university may open, it seems, as announced. All contagious diseases, however mild, should be subjected to strict regulation.

New York dispatches Wednesday told about "call" loans reaching the 95 per cent interest rate, the highest in years, with 30 per cent the lowest for the day. How can men afford to pay such interest? It is only for a day, several days or a week or so that they get the money—anything to tide over their emergency. At 95 per cent, the borrower would pay nearly two per cent, interest for the use of money a week. Pretty stiff interest that.

This is the way the McMinnville Telephone-Register goes after the Oregonian: If there is a more contemptible, hypocritical, lying paper on the face of the earth than the Oregonian, it must be under the direct supervision of the Father of Lies, for under no other circumstances could the unblushing falsehoods of the Oregonian be paralleled, or even remotely approached. Truth and justice and honor and decency are alike unknown in the conduct of that journal. Its sole aim and ambition is to crush all who do not bow in meek submission to its mandates. It never hesitates to publish scurrilous articles regarding the people and the press of the state, and yet when its own rottenness is exposed it howls like a whipped dog.
