WHY EDMUNSON SHOULD BE ELECTED

Four reasons why Leon R. Edmunson should be elected as one of the three representatives from Lane county to the state legislature:

First—Because he received five years of training at the State University here, and afterwards completed his education at the University of Michigan Law School, at Ann Arbor, thus thoroughly equipping him for the intricacies of constitutional legislation.

He is a fluent and able speaker, and a deep thinker, with his legal training will give him the ability not only to advocate in a forceful way Lane county's interests upon the legislative floor, but will also enable him to prepare bills which will stand the tests of the courts.

Lane county should send to the legislature, out of the three to be elected, at least one who is versed in legal matters, with whom the other members of the delegation can advise as to the technical matters necessary for the proper passing of the bills which shall be deemed by the delegation to the interests of this county. Nearly every county has at least one member of its bar in the legislature, and we should be at no disadvantage in this respect.

Second: Because Mr. Edmunson is an ambitious young man, with a bright future before him, who desires an opportunity to prove to the people among whom he was raised that he will at all times stand for the people's rights as against corporate interests, and to prove that he will always fight graft and special privilege to his utmost ability, and to this end carefully scrutinize the bills seeking passage that might subsidize a private concern, to the injury of the plain people.

This is particularly an age when young men who are devoted to the doctrine of "A square deal to every man" are winning successes in life, and Lane county will make no mistake if Mr. Edmunson is given a chance.

Although it is true that he will belong to the minority party if elected, yet it is often to the advantage of a bill affecting our interests to have the support of the minority party as well as that of the majority, in order to assure its passage without opposition of the members of either party from other counties.

Third: Because he is a native son of the state of Oregon, raised upon a farm near Eugene, a descendant of a sturdy family of pioneers, who has all his business interests and future prospects dependent upon the progress and welfare of Lane county. Self interest as well as regard for public duty will impel him to be a faithful worker for the development of the resources of his native home, and for the betterment of its conditions.

Fourth: He has advocated of St. Paul, Minn., which virtually puts into force the principles of the election of United States senators by

a direct vote of the people, and he pledges himself to vote first, last and all the time for the people's choice for that important office, regardless of party affiliations, thus taking out of politics the duties of state representative. His duties will be similar to those of a presidential elector, merely to vote as instructed by the people. He realizes that if he is elected it will be by Republican votes. He solicits Republican votes, because he believes that with the question of the election of a United States senator, left to the people themselves, the office to which he aspires ceases to be a political office and that he can devote his best efforts to the interests of all the people, regardless of party.

JAMES HAYS IS WORTHY YOUNG MAN

James Hayes, one of the Democratic candidates for representative, was born near Stromsburg, Nebraska, March 1, 1876, and has resided in Lane county 19 years, living in the extreme north end of the county.

He has been successfully interested in the hop industry since 1895, and now owns a good farm and hopyard, although he is probably better known as a hop buyer, representing the Clemens Horst Co. since 1901. In 1902 he had charge of the big Horst yards near Salem, during the hop picking season, and his services were so satisfactory that his employers endeavored to secure his services the following year, but he preferred to buy hops for them, and in this capacity he has been working for them each year since, during the hop buying season, and last season he bought as many hops, in the territory in which he works, as all the other buyers combined, which shows the high regard in which he is held by those with whom he does business.

He has recently circulated among the hop raisers a petition, addressed to the Transcontinental Freight Bureau at Chicago, Ill., asking for a reduction in freight rates to Atlantic seaboard points.

On June 23, 1902, he married a daughter of ex-Commissioner Hill, and they have two children. His father is a Republican, but Mr. Hays is of the same political belief as his grandfather, who was a Kentucky Democrat. He received his education at the public schools, finishing in 1893, and afterward completed a commercial course at the Portland Business College at Portland, Oregon.

He is exemplary in his habits, using neither tobacco nor liquor, in any form, and he would make a good representative from Lane county to the next legislature.

JUNCTION EDITOR AFTER THE PROHIB.

The efforts of certain prohibitionists are detrimental to the cause they espouse, to judge from the statements made at the temperance meeting held in the Christian church Friday evening.

The address delivered by Rev. McDonald, of Eugene, was an able one and fully explained the deceptive provisions of the proposed amendment to the local option law.

He was followed by Rev. Thompson, who stated, among other things, that they, meaning no doubt the prohibitionists, would make up their own ticket. For the state senate he said Mr. Bingham was objectionable for the reason that he voted for the Jayne bill at the last session of the legislature, and then he proceeded to disgrace the pulpit with personal allusions to that gentleman.

"For the house he said they had selected Allen Eaton, I. N. Edwards and J. J. Walton.

"It seems to us that these people are making a serious mistake and the action of a few radical members may defeat the cause they champion. There are many men who are not classed as temperance men who will gladly vote against the proposed amendment to the local option law and also against the 'wet' proposition for Junction, and each vote is just as important and will count just as much as a prohibition vote, and why, therefore, antagonize these electors?"

"The prohibitionists in their zeal and unwisdom are handling a double-edged instrument. There are many Republicans and Democrats who will vote with the temperance people in the adoption or rejection of the proposed measures, but if prohibitionists are going to band themselves together to defeat certain legislative candidates party loyalty will dictate punishment or retaliation."

The above editorial by S. L. Moorhead, appearing in the Junction City Times Saturday, May 12, seems to indicate that the issues in the coming campaign are not political so much as prohibition or anti-prohibition. The prohibitionists registered as Republicans, and where they are unsuccessful in the primaries they are throwing their support to Democrats favorable to their cause.

HOW TO VOTE IF NOT REGISTERED

The registration books closed on May 15, 1906, but voters who have not registered can vote at the polls by conforming to Chapter 148, page 259, of the laws of 1905, which provide that "if it appears that the elector is not registered, he may subscribe and swear or affirm to blank 'A,' which blank 'A' can be had at any of the voting places upon election day, June 4, 1906, free by asking for it, and in addition thereto, he shall be required to procure six freeholders of the county to subscribe to the same."

When this is done, the voter can vote the same as a registered voter. Democrats who have not registered, and who vote in Eugene, Oregon, can be accommodated by calling at the Democratic headquarters, over the Eugene Loan & Savings Bank, where there will be a number of freeholders assembled, who will swear to the qualifications of such electors as they may be acquainted with on election day, thus enabling those to vote who have been unable to register.

The oath of qualification to be made by the voter wishing to vote, when not registered, is provided by Sec. 274 of Cotton's Code, and is as follows:

"You do solemnly swear that you are a citizen of the United States, having declared your intention to become such one year next preceding this election; that you are of the age of twenty-one years; that you have been a resident of this state for six months next preceding this election; that you now reside in this precinct; that you have not yet voted in this election, and that your true name is as you represent."

If the elector is not a resident of Lane county, but has been in the state of Oregon for six months, he is entitled to vote for the state officials, and the oath can be modified accordingly.

When one has been away temporarily but has always claimed his residence here he is entitled to vote here. The place where a man sleeps is deemed his residence.

It is probable that the Kaupisch creamery will do a business of \$150,000 this year. It is undergoing a development that promises within a short time to make it the most important enterprise in Benton county. It paid out \$80,000 for butter fat last year. It is now making more than a ton of butter per day. It has a market at fancy prices for every pound of butter turned out.—Corvallis Times.

Mason, Doris & Co. have the contract for constructing a big canal at Klamath Falls. The amount involved is about \$400,000, and something like 700,000 yards of dirt will be excavated. The contract includes much concrete work and a tunnel 3300 feet long, which will pass under the town of Klamath Falls. The system will carry water to Lost River, which later will have to be bridged with an aqueduct.

DOUGLAS' CANDIDACY A DUTY TO PUBLIC

S. M. Douglas, Democratic nominee for county commissioner, came to Lane county in 1880, and was engaged in the dairy business here for twelve years.

He now owns one of the best farms in Lane county, consisting of 500 acres, two miles east of Springfield, on the banks of the Willamette river. Mr. Douglas has the reputation of being one of the most scientific and practical farmers in the Willamette valley. He is entirely wrapped up in his farm work, and could not have been induced to run for a public office except upon the earnest and continued solicitation of a large host of friends.

Even this would have proved unavailing had he not believed that existing conditions made it a public duty for him to enter the race. It was Mr. Douglas who first noticed upon his way to market one day that the Southern Pacific railroad company was constructing four piers, each two feet thick, across the most traveled highway in Lane county, enabling for the public use only a passage way of thirteen feet diagonally across a county road.

He immediately employed A. C. Woodcock, paying him from his own pocket, to represent the people in this matter before the county court, and to object to the appropriation of a public road by a private corporation.

It was Mr. Douglas who circulated the petition, which was signed by several hundred of the leading taxpayers of Lane county, praying the county court to declare at least one row of piling a nuisance and leave a passage-way wide enough to permit the farmers coming and going to town to travel without their lives and property being endangered. This petition was duly presented to the honorable court, and is a matter of public record that can be examined by any one calling at the county clerk's office.

H. D. Edwards, after the presentation of the petition, promised Mr. Douglas in the presence of E. H. Bangs to have an expert engineer pass upon the advisability of compelling the railroad company to leave a roadway of 25 feet, but he has failed to do so. He also promised Mr. Douglas and his attorney, Mr. Woodcock, to give them a hearing before the question should be decided. The court soon afterward gave L. C. Freeland, the railroad engineer, a hearing, together with his friends, without reasonably notifying Mr. Douglas or his attorney of the matter, and the court decided against the people, and that it would

be a stumbling block to progress object to the appropriation of leading county road of Lane county by the Southern Pacific company.

The Merchants' Protective Association, seeing the seriousness of the matter, and the futility of Mr. Douglas' efforts to protect the people's interests in this matter, appointed a committee of Eugene's leading citizens to protest to the court they were as powerless as Mr. Douglas had been to overcome the company's influence. Both the Eugene Guard and the Eugene Bee strongly disapproved of the action of the court in the matter.

But today the matter stands as a corporation willed it, in spite of petition upon record, the Merchants' Association and papers.

But Mr. Douglas has not given up the matter—he sees the need of trying to change the heart of the present court, but wishes to see the membership of the present court, and he is making the order to give the citizens of Lane county an opportunity to make a member of the court.
