The owner estimates his loss at \$600, with no insurance.

CHAS. H. CHICK SUES EX-REGISTER BRIDGES

For Performance of Contract
to Sell McKenzie Timber
Lands

Agreed to Convey to Chick and His Associates 720 Acres for \$14,400, But Repudiated Contract—Suits Against Others May Soon Be Instituted

Chas. H. Chick, who with his associates, Constantine Morton and Everette P. Lewis, of Grand Rapids, Mich., has been buying considerable timber land up the McKenzie river for some time past, today instituted a suit in the circuit court of Lane county against J. T. Bridges, former register of the United States land office at Roseburg, to force the performance of a contract for the sale of 720 acres of timber land lying in township 17 south of range four east, in the upper McKenzie country.

Mr. Chick alleges in his complaint that on August 14, 1906, an agreement was entered into whereby the defendant, in consideration of \$20 per acre, or a total sum of \$14,400, to be paid by the plaintiff, agreed to convey unto the plaintiff and Constantine Morton and Everette P. Lewis within ten days from the date of the contract, the land above mentioned. He alleges that he has deposited with the First National Bank of Eugene the purchase price agreed upon, but that Bridges has refused to carry out his part of the agreement, viz.: to furnish abstract of title to the land and deliver a warranty deed; that he has wholly repudiated the agreement and refused to proceed in any manner in the carrying out of the agreement and has so notified the plaintiff.

Mr. Chick prays for a decree directing and requiring the defendant to perform his part of the contract and that the defendant be required to convey said lands with abstract of title, as provided and required in the contract, with a sufficient warranty deed.

It is said that quite a number of other people owning timber lands in the vicinity of the Bridges' tract who have made contracts to sell to Chick, Morton and Lewis, have repudiated them and that suit against them will also be commenced.

Mr. Chick's counsel in this case is Lark Bilyeu.

BOY ARRESTED FOR HORSE STEALING

Earl Chapman, aged about 18 years, was arrested in Eugene Sunday evening by Sheriff Fred Fisk, charged with the larceny of a horse and saddle from a man named Ward at Clackamas, near Oregon City. The sheriff at the latter place was notified by telephone of the arrest and an officer arrived up this afternoon to take the boy back for trial.

According to the boy's own story, Ward sent him to Arleta with the horse and saddle to transact some business. While there another man who formerly worked for Ward claimed the saddle and his and took it away from him. When young Chapman returned to Ward and told him of the occurrence Ward sent him back with the horse and told him to get the saddle or he would have him arrested. The other man refused to give up the saddle and Chapman, fearing arrest, turned the horse loose and went to the Dalles. He came to Eugene about two weeks ago and has been staying with his mother, Mrs. H. E. Chapman. The boy appears to be honest and tells a straightforward story.

NEW MACHINERY FOR EUGENE STEAM LAUNDRY

A 50-horsepower boiler for the Eugene steam laundry arrived today from Portland. It will at once be taken to the new brick laundry building being put up by Wm. Hodas at West Eighth and Charnell streets. A 23 horsepower engine for the laundry recently arrived and a large amount of new laundry machinery is on hand. The new building is rapidly nearing completion.

Mrs. Lucy Mackey

Mrs. Lucy Mackey died at Pleasant Hill August 22 at 6 o'clock a. m. at the home of her son, Bert Mackey. The deceased was born in Virginia

March 22, 1833, and was therefore aged 73 years and 5 months. She crossed the plains by mule team in 1882 with her husband and family and lived in Oregon since that time until one year ago she returned to Nebraska to visit with her son-in-law and grand children, returning to Oregon August 1, 1906. She was sick on her arrival and never recovered. Her death was caused by paralysis.

Mrs. Mackey was a member of the Christian church for a number of years. A few years ago she took the faith of the Baptist church. She was the mother of eleven children, seven of whom survive her, as follows: Henry C., of Potlach, Idaho; John W., of Holly, Or.; Samuel C., of Lebanon, Or.; Gifford E., of Bridgeport, Wash.; Gilbert E., of Pleasant Hill, Or.; Mrs. Rose Blakely, of Lowell, Or.; and Mrs. Parlee Hennings, of Hicksville, Ohio. The deceased's husband died twenty-two years ago.

LOG CABIN HOTEL BURNED TO THE GROUND

(From Monday's Guard.)

George Frissell's famous Log Cabin hotel at the McKenzie Bridge pleasure resort was burned to the ground Saturday forenoon about 10 o'clock, the news of the fire reaching Eugene late Saturday night by telephone from Leaburg.

The only particulars of the fire that have yet been received here came by phone from George Moody, who drove to Leaburg and called up Geo. Croner, whose wife and son Charles were staying at the hotel. Full particulars are expected to arrive on tonight's mail.

According to Moody's story nobody was at the hotel at the time of the fire except Mr. and Mrs. Frissell and the fire had gained such headway before they discovered it that they were powerless to save scarcely anything. A sewing machine and a bed were about all that was taken out.

The guests at the hotel were all away fishing or up to the springs and none of their effects were saved. Among them were Judge and Mrs. L.

T. Harris, Miss Ida Patterson, Miss Myrtle Kays, Miss Ellen Green, Mrs. Geo. Croner and son Charles and some Berkeley people. The relatives of the Eugene people there sent additional clothing to them on this morning's stage.

The fire was caused by a spark from the chimney alighting on the roof. A strong wind was blowing at the time and the blaze was beyond control in a minute.

The hotel was built ten or twelve years ago by Mr. Frissell, who has conducted it ever since. It was one of the most popular stopping places on the upper McKenzie and was known to tourists all over the coast. The loss is probably \$2500, with only \$600 insurance. It is not known whether Mr. Frissell intends to rebuild the house or not.

MAY STRIKE FLOW OF ARTESIAN WATER

Dr. H. F. McCormack is having a well drilled on his farm west of the city and from present indications there are good prospects of striking a good flow of artesian water. The drill is now down 215 feet and lots of water has been found, but it is proposed to reach a depth of 400 feet. The water is now well up toward the top of the well and rises higher as the drill goes deeper. The work is being done by C. E. Gordinier with one of Kilborn & Gordinier's machines.

FARM RESIDENCE DESTROYED BY FIRE

Saturday evening about five o'clock the farm residence occupied by L. H. Gilchrist and family and owned by Geo. O. Walker, at Walker Station, was burned to the ground, together with most of its contents. The blaze was caused by a defective flue. Mrs. Gilchrist and Miss Ruby Pratt, of Eugene, who was visiting her, were the only persons in the house at the time and they were unable to carry out much of the furniture. The loss is about \$2000, with no insurance, the policy having expired a few days ago.

Royce & Peterson's excelsior factory in this city will close down this evening until the present car shortage is over. C. O. Peterson, manager of the plant, stated to a Guard reporter today that he had not taken the matter up with the head officials of the railroad, as he considered it simply a waste of time, but the local representatives of the company could give him no encouragement, and as he has all available warehouse space filled he can do nothing but shut down. The company's plant at Junction will operate about two weeks longer and it, too, will close down if conditions are no better by that time.

After several months fluctuations in the sugar market, the two big refineries of California have apparently settled down to a parity of values. There still exists a difference between the Atlantic and Pacific Coast quotations of 50c, but so far as known that ratio, approximately, will continue indefinitely.

HOP MARKET STATIONARY.

Apart from the rumors of sales here and there at an advance over the 20c price regarded by leading Portland dealers as top quotation today, there is nothing of an interesting nature reported.

The table showing the world's production, prepared by Klaber, Wolf & Netter, is very generally commented on favorably by the trade, though several hop men expressed doubt that the Oregon yield would run much above 100,000 bales. Mr. Netter, however, has had reliable reports from every section of the state, and in his comment states that his estimate of 115,000 is made on conservative reports.

In view of the announced intention of growers who still hold their hops to hold on until their hops are ready to market, it is doubtful if offers at 2c to 3c advance will tempt them to let go.

FRESH MEATS DULL.

Veals arriving in moderate volume will sell only fairly well, as they are too generally of the large, poor kind, and have been on the way too long. No hogs and few muttons and lambs appear. Quotations are pretty well maintained for best dressed meats, though the heavy sell at nominal prices.

COUNTRY PRODUCE QUIET.

Eggs, if anything, are a trifle weaker today on account of the receipts keeping ahead of demand. No great difference is apparent between Eastern and ranch stock, and a fair average price is given at 21c. Country butter is falling off perceptibly, although no advance in price is named. Poultry was good and steady this forenoon, and dealers were fairly well supplied. The half cent advantage usually given springs was not insisted upon generally. Young ducks, if well feathered and fat, meet with good sale in a moderate way, though inquiry is not active. If well-grown young turkeys could be had there is a fancy trade ready to take them.
