SENSATIONAL NEW YORK MURDER AND SUICIDE

New York, Oct. 27.—L. G. Hampton, assistant secretary of the United States Trust Company in this city, shot and killed Victoria C. Taczkow, a beautiful young woman, at the Hotel Griffon on West Ninth street late last night, then committed suicide.

Hampton was infatuated with the woman, and they were together many times during the past month, having been in the hotel since early yesterday. Whether the tragedy was the result of pact to die together has not been determined, but circumstances seem to show the woman had agreed to die with her companion. Hampton was sixty years old and leaves a wife and two children. Miss Taczkow was 25 years old, lived with her father and invalid mother, and was employed in a Fifth avenue department store.

The couple registered at the Hotel

Griffon as "Mr. and Mrs. Sinclair, of Burlington, Vermont." The first positive identification was made by the woman's brother. He had been notified that a young woman wearing jewelry bearing his sister's initials had been murdered and went to the police station, where he identified articles of clothing. One pair of earrings with gold buckles bore the letters "V. I. T." the other "L. G. H."

Young Taczkow told the police that Hampton had been very attentive to his sister for some time and had told the family he intended to marry the girl "when his mother died." The brother said he didn't know much about Hampton, who seemed to be honorable in his intentions and fond of the girl. He spoke of his sister as a good girl who never remained out all night, and the family thought they knew where she was every minute of her time.

SINK MULKEY DROWNED IN WASHINGTON

Sink W. Mulkey, who was born and raised in Lane county, being a brother of B. G. Mulkey and Mrs. Marquis, was drowned at Sedro-Wooley, Wash., yesterday. He and two other men named Simpson and Jewell were rowing across the Skagit river, which was badly swollen by heavy rains, when their boat was struck by a log and capsized. All three of the men were drowned.

Mr. Mulkey was aged 34 years and leaves a wife and three children. Mrs. Marquis, accompanied by her sister, Mrs. West, who arrived here yesterday from Eastern Oregon on a visit, left today for Sedro-Wooley to attend the funeral.

STANDING IN WITH EDMONSON

S. S. Spencer and E. Terpening, who were among the holders of timber land in the 17-4 pool recently sold by Dr. T. W. Harris and Attorney L. E. Bean to the Security Savings and Trust Co., of Portland, and who were named as defendants cestui que trust in the suit instituted by Leon R. Edmunson to compel an equal distribution of the purchase money, today, through their attorney, Lee M. Travis, filed answers to the complaint. Each prays for a decree of the court for the orders and relief set out in the plaintiff's complaint, and for such other and further relief as may seem meet and agreeable to equity.

Mr. Terpening, in his answer, makes further allegations. He claims that Dr. Harris and Mr. Bean conveyed their holdings of land in a separate conveyance in violation of the terms of the pool agreement, and received a higher price for them than for the others. He prays for an additional order that Dr. Harris, as trustee, be compelled to account for the prices of lands deeded by him in the additional conveyances.

Several others who were in the pool and who by law were made defendants in the suit, are preparing their answers, which will be along the lines of those filed by Mr. Spencer and Mr. Terpening. It appears that nearly every one of those in the pool are "standing in" with Mr. Edmunson and will demand what they claim is due them in the sale.</
