AN EARLY PIONEER ELOPEMENT

Love Laughed At An Irate Father While Young Couple Rode Miles for a Preacher.

Saturday's Portland Telegram devotes three-quarters of a page to an emigrant train elopement, that of Geo. R. Snipes and Miss Martha Imbler in the fall of 1853, when within a day's horseback ride of The Dalles, their military post, and the first one for a thousand miles of unbroken wilderness on "the plains."

This was the train headed by Jacob Luce, who became a Lane county pioneer, settling twelve miles west of Eugene, and his daughter, Mrs. A. J. Campbell, mother of the former proprietors of the Guard, was the confidant of the young people in their escape from an unsympathetic father. They remained at The Dalles, and besides a fortune accumulated some fourteen of a family of sons and daughters.

As an illustration of the hardships of the five months' trip entirely cut loose from civilization, this train had but got well started on the plains when Indians ran off part of their cattle, necessitating the lightening of loads by throwing away every article that could possibly be spared. Then the women, old men and children had to walk, made Charles fifteen or twenty miles traveled each day afoot ahead of the train. W. T. Campbell, of this city, was an eight-months-old member of this train, and was carried by the mother in arms and afoot most of the distance. But with youth and hope the pioneers thought little of it, and Mrs. Campbell was accustomed to revert to those days as among the happiest of her life.

CHERRY CROP MUCH GREATER THIS YEAR

Royal Anne cherries are still coming in at the Allen cannery at a lively rate and the season will not end much before the close of next week. Manager W. G. Allen says the crop is much greater this year than last, already the cannery having put up fifty per cent more than during the entire season a year ago. Last year the output of the cannery was 100 tons and the prospects are good for 200 tons or at least 175 tons before the season ends. The cherries are also of an excellent quality, big and also of excellent flavor.

The cannery is now putting up 350 cases a day and employing 75 or 80 persons steadily. Most of these are women and girls, although there are a dozen or more men to do the heavy work. In the store room of the cannery there are on hand 5000 cases of quart cans, 120,000 in all. These will all be filled before the season is over. There have been several times that many already filled, making this year's crop much the greatest in the history of the cannery.

Cherries For Cocktails.
The work of picking cherries with the stems on and putting them up in barrels for shipment to the eastern cities, where they will be sold to be used in cocktails, has commenced, a carload of them having been shipped already. There is a great demand for the Oregon Royal Annes for cocktail uses and they always bring a very fancy price.

Working on Raspberries.
The raspberry crop is coming in rapidly, in fact more so than is desired, the capacity of the cannery is not large enough to handle them properly until the run on cherries is finished. The berry crop, too, is very large this year and there will also probably be a record run on them.

SUMMER SCHOOL IN FULL SESSION

Best Attendance This Year It Ever Had—University Campus Improvements.

Summer school at the university is now in full session, with the best attendance it has ever had. This year there is no library training work, which is due to the fact that the library will be moved from its present situation to the new pressed brick building. Hundreds of new books have arrived during the last few months, to which the summer students have access.

Mowed the Campus.
The lower part of the campus, which was sowed to oats, was mowed today of its crop and with new walks which are being reconstructed, makes the university grounds appear very much improved.

Spokane, Wash., July 7.—Sensational developments followed the arrest of Richard Blair, who says he is a son of Francis Marion Blair, of Portland, Or., when he said that infatuation for Mrs. Frank McQuarrie, wife of Actor McQuarrie, of the Shirley Stock Company, now playing here at the Auditorium theatre, had led him to forge checks to the amount of \$32, which he passed on the proprietors of three saloons in this city.

According to Blair's story he first met Mrs. McQuarrie at the Perkins hotel in Portland about 18 months ago, shortly after she left her husband. She was stranded and in debt, Blair says, and he advanced her money.
