**HEAVY RAILS SHIPPED
AWAY FROM DRAIN**

Heavy rails piled up at Drain for the Southern Pacific's extension to Coos Bay have been taken away, giving rise to the report that the company had abandoned the Coos Bay extension. These rails were taken to the California & Northeastern, to be used in rush work on the line that is to be made the main line of the Southern Pacific around the Siskiyou mountains. Other rails will be substituted for use on the Coos Bay extension. The Klamath Falls line is being laid with 86-pound rails, the heaviest rail that is now being used in ordinary railroad construction. The builders received orders from E. H. Harriman, it is said, to push construction on the Klamath Falls line, and as there were no heavy rails to be secured in the market the rails at Drain were appropriated. It is reported that the Coos Bay line will be laid with 65-pound rails.

The builders expect to complete the Klamath Falls line to Dorris this fall, and to Klamath Falls by next spring. After the road reaches Dorris it will encounter three or four miles of heavy work and two tunnels. These will be handled during the winter months.—Portland Journal.

**SUMMER SCHOOL
CLOSED YESTERDAY**

The university summer school closed its session yesterday and about forty students who attended are getting ready for their vacations. Most of the professors, twelve or fifteen, who were engaged in the summer work, will leave either for Newport or the mountains.

The session was very successful, and what added greatly to its success was the pleasant and quite cool weather a good part of July. Courses were offered in all the main branches of the regular college work. The library training usually offered was not given, on account of the fact that the new library was not ready, and the books in the old one are being made ready for removal.

**ATTACKS UPON
MANY WOMEN
AND CHILDREN**

New York, Aug. 3.—The attacks on women and children which have caused such consternation still continue. An additional case, that of a young girl on the East Side, was brought to the attention of the authorities today. She was passing through a hallway of her own home when attacked by a miscreant. The police are baffled. Some believe the attacks are all the work of one man, and others point to the widely separated scenes where the attacks have occurred and hold that different individuals are responsible. There is a marked decrease of women and children on the streets at night and every incident is the basis of the gathering of a mob and the beating of suspected men, but no important arrests have been made. Three young girls and two women have been killed and a score attacked.
