HOP GROWERS MEET TO FORM ORGANIZATION

PROMINENT HOP MEN OF CALIFORNIA ADDRESS MEETING AT COMMERCIAL CLUB

LANE COUNTY GROWERS PRESENT ALL ENTHUSIASTIC OVER PROSPECTS OF SUCCESS OF ORGANIZATION - BY-LAWS COMMITTEE APPOINTED

(From Tuesday's Guard.) A routing meeting of the hop growers of Lane county was held at the Commercial Club today for the purpose of taking preliminary steps toward organizing an association to affiliate with the general organization being formed all over the coast. The first session was held this forenoon and was called to order by Manager Hartog. M. Levinger was elected chairman and Dr. W. L. Chesbro secretary.

W. E. Lovelad, a prominent Sacramento hop grower, was the first to address the meeting. He explained the purpose of forming the association of which he was a member had met with great success in Washington. A. L. Shinn, an attorney of Sacramento, who was instrumental in organizing the fruit growers of California, also spoke at the forenoon session. Mr. Shinn characterized the hop grower as the disease of the hop industry. He fills the market up with short sales and afterward buys the hops from the farmer at less than the cost of production.

In the afternoon E. F. Woodward, a banker and hop grower of Santa Rosa, spoke on the financial details of the organization. He told how the organization would advance money to the grower, how the organization would market the crop over the entire year instead of forcing the crop on an unwilling market within 30 days after harvest.

M. H. Durst, of Alameda, Cal., was also on the program for an address for this afternoon. A committee on by-laws was appointed as follows: Stephen Sneed, W. P. Chesbro, Len Stevens, R. O. Brady, J. Seavey and Geo. A. Dorris. The committee will probably adopt the same by-laws that other organizations on the coast have and a meeting will soon be held to perfect organization.

The growers present at the meetings today were all enthusiastic over the success of the organization.

San Francisco, Dec. 30.—Inquiry at the flat occupied by Rev. J. Knode Cook and Loretta Whaley revealed the fact that the couple had fled with the child. San Francisco, Dec. 30.—Rev. Cooke and his companion lived in this city under the name of Mr. and Mrs. Gerald Balcom. They left their flat last night in a peeling rain. The police have not been requested to detain them and are making no effort to locate the pair. Minneapolis, L. I., Dec. 30.—District Attorney Coles said today that he had received no official notice that Jere K. Cook and Floretta Whaley had been found in San Francisco. As soon as notified he will ask the authorities at San Francisco to arrest Cook on a warrant issued shortly after his disappearance. Cook is charged with abduction. Mrs. Whaley, the grandmother of Floretta, said she would welcome the girl home and send money for her return if necessary.

TAFT DEFENDS ROOSEVELT AGAINST FINANCIERS' ATTACKS

Boston, Dec. 30.—Greeted with cheers as "the next president of the United States," a topic which he carefully avoided in his own remarks, Secretary of War William H. Taft tonight delivered his first public speech since his globe trotting tour at the annual banquet of the Boston Merchants' Association, at the Hotel Somerset. The banquet closed a long and strenuous day for the secretary of war, during which he delivered a brief address before 400 members in the morning and attended a reception and spoke before a gathering of Jews of the city at the Elysium Club in the afternoon. During his visit to Boston, which ends tomorrow morning, Mr. Taft is the guest of Samuel Carr, a Boston banker and relative of Mrs. Taft. After alluding to his New England ancestry and to the lack of public interest in the Philippines, Mr. Taft began a discussion of the recent panic, its causes, effects and relation to the policy of the administration. He attributed panics in general to the conversion of loanable capital into investments less and less convertible and to waste of money in unwise enterprises, extravagant living, wars, etc. For eight or nine months there were many indications that this loanable capital was near exhaustion, until the soundest railroads and other enterprises could not borrow money. This condition extended all over the world.

MARRIAGES AND DIVORCES IN LANE FOR 1907

CUPID WAS BUSIER THAN THE COURTS—265 LICENSES ISSUED AND 30 DIVORCES GRANTED During the year 1907 just coming to a close Cupid has been very busy in Lane county—more so than during the year previous. In 1905 County Clerk Lee granted 233 marriage licenses, but this year, up to noon today, he has issued 265. June, July and December were the best months for weddings this year. 31 licenses being issued in June, 36 in July and 29 in December. By months the number issued was as follows: January, 14; February, 17; March, 19; April, 19; May, 16; June, 31; July, 30; August, 25; September, 24; October, 21; November, 20, and December, 29. There were only 30 divorces granted in this court this year, although the number would have been greater had the regular November term of circuit court not been postponed on account of the holidays. The docket for the next term contains quite a large number of divorce cases.

DEMANDS THAT HARDEN BE SENT TO JAIL FOR LIBEL

Berlin, Dec. 31.—In the hearing of the Harden-Von Moltke libel suit today Count Hugo Von Moltke stated that he resigned from the army as the result of articles published by Harden. The state attorney in opening his pleadings demanded the imprisonment of a sentence of four months' imprisonment against Harden. He declared that Harden attacked Von Moltke and Prince Zu Eulenberg on the word of two hysterical women, wife of Von Moltke and her mother, both of whom he declared were untrustworthy and possessed of abnormal tendencies. He declared that Von Moltke had been completely cleared, as had Zu Eulenberg. The state attorney declared he had received a letter threatening him with death if the verdict was unfavorable.

Washington, Dec. 31.—In accordance with a strong recommendation of Prosecutor Hony and United States Attorney Baker, of the District of California, the attorney general today recommended to the president the pardon of S. A. D. Puter in order that the latter's testimony may be utilized in connection with the prosecution of the Oregon land fraud cases. Portland, Dec. 31.—S. A. D. ARRESTED UNDER NUISANCE LAW

Charles Mayhew, one of the seven men who were convicted in the justice court last week for selling liquor in violation of the local option law, was arrested today on the charge of maintaining a nuisance. This arrest is under the ordinance passed by the present council declaring a place where liquor is sold a nuisance. The penalty is a fine of not less than \$25 and not more than \$200. The case was set for trial in the police court Thursday at 10 a. m. One of the tracts in the Blair Street addition was sold yesterday through the Oregon Land Company to Cliff Abrams, a well-known logging contractor, for \$440.
