OLIVE STREET ORDINANCE PASSED BY CITY COUNCIL

An adjourned meeting of the city council was held last night at which the matter of opening Olive street from West Twelfth to West Seventeenth street was brought up. After the report of the viewers, as recently published in The Guard, was read, an ordinance was ordered by motion to measure up the actual area of pavement in front of his property, and if the amount assessed is greater, the city make the amount of excess charge good.

The matter of planting uniform kinds of trees on certain streets in Fairmount coming up, Mr. Calkins moved that Linden trees be planted on Columbia avenue and walnut trees be planted on Walnut avenue under the direction of the street commissioner. The motion carried.

The matter of getting ready to pave Eleventh street was referred to the city attorney to prepare an ordinance to hurry the matter up.

A petition from E. W. Polock asking the city to take some action toward opening up Willamette street or some other street across the railroad track was read. By motion the matter was indefinitely postponed.

Portland, Or., Jan. 20.—Central committee from all the counties of the state except Columbia, Coos, Crook, Grant, Klamath, Lake, Lincoln, Tillamook, Union and Willamette, gathered at the Imperial yesterday at 2 o'clock in answer to the call issued by State Chairman Sweek some time ago. The deliberations of the organization were short, but things were doing while the session was on.

Perhaps the most important action taken was the endorsement of Bryan as the choice of the Oregon Democrats for the next presidential candidate. Senator Mill Miller was the one who brought up the question, and in a short speech brimming with enthusiasm he asked that the committee give its indorsement to the famous Nebraskan. Senator Miller contended that the fortunes of the Democratic party were on the flood tide, and he predicted a presidential victory for the party in November.

The state convention will be held in Portland June 16 and will be composed of some 215 delegates. The basis of representation was fixed by the committee at one regular delegate from each county and one delegate at large for each 250 votes cast for Chamberlain at the last election.

The manner of electing delegates to the state convention was left to the different party county organizations. REPORTED PLOT TO BLOW UP OUR ATLANTIC SHIPS

Washington, Jan. 20.—The reported plot to blow up one or more ships of the Atlantic fleet at Rio Janeiro is regarded at the White House as a repetition of one of the many schemes being presented to the secret service by persons who claim to possess information which they are willing to part with for a consideration. No credence is given here of the existence of an actual plot.

It is understood this information originated at Paris, from which point it was communicated to the secret service bureau and through the medium to Admiral Evans and the authorities of the South American countries.

Rio Janeiro, Jan. 20.—There have been several arrests in connection with the alleged plot to destroy the American fleet now in the harbor. Of the band who presumably organized the plot five Italians, one Canadian and two Germans have been arrested.

MARY RODNEY MEMORIAL HALL AT UNIVERSITY

The Portland Journal speaks of the proposed new Mary Rodney Memorial hall as follows:

A movement that will meet with the interested support not only of Episcopalians but with many who are interested in higher education, has been set on foot by Bishop Scadding and Professor Luella Clay Carson, of the University of Oregon.

An effort will be made to erect at the State University at Eugene a memorial hall to Miss Mary B. Rodney to be used as a residence for young women attending the University.

A meeting has been called by Bishop Scadding of the Oregon diocese to be held in the parish hall of St. Stephens Pro-cathedral, corner of Thirtieth and Clay streets, Friday afternoon at 3 o'clock.

Miss Carson, who is head of the English department and also dean of women at the University, will be present and will state the need. All women interested in the movement, whether Episcopalians or not, are invited to attend.

Miss Rodney was one of the first and foremost educators of Oregon for many years and was for a long time at the head of St. Helen's hall. She was a sister-in-law of the late Bishop B. Walter Morris, and was an earnest worker in the cause of higher education.

It is especially fitting that a memorial to her should be erected at the leading educational institution of the state, and it will be the first memorial dedicated to this pioneer educator. A large attendance is expected at the meeting.
