AN IMPOSITION.

(La Grande Observer.) Petitions are being circulated in various counties of the state with a view of submitting to the voters of the general state election in June, the question of the sub-division of the present county of Wasco. This may be legal and in case the required number of petitioners are secured the question will be submitted to the voters of the state. The question naturally arises, What interest the voters of the state outside of Wasco can possibly have in this purely local matter? What right, morally, have the voters outside of Wasco, to vote on the sub-division of this county.

It is just possible that the best thing the voters can do, if they are forced to vote on this question, is to show it under so deep that it will act as a precedent in keeping down other attempts. If this policy continues, the ballot will be weighed down with proposed city charter amendments. This is purely a county seat fight, wherein no one not a resident of Wasco is interested, and it is an imposition to attempt to place it on the general ballot.

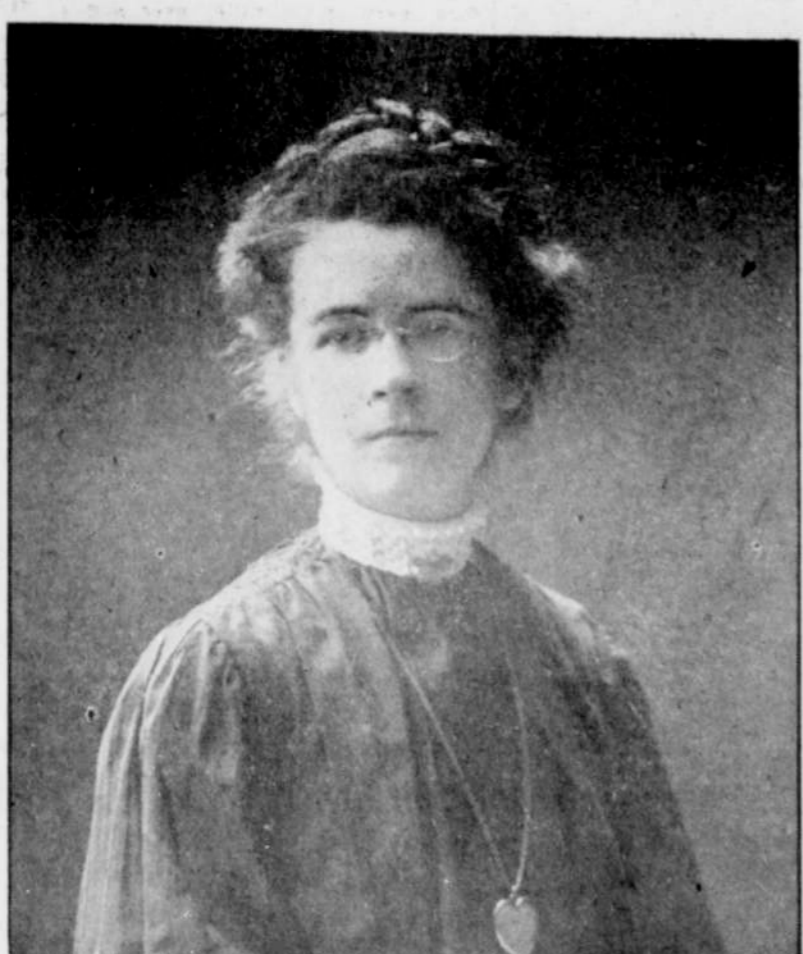

At the conclusion of the Hall-Mays conspiracy case this week, Special Prosecutor Heney will return to San Francisco to resume the prosecution of municipal graft cases that he left temporarily in order to conduct the defenses of the ex-district attorney. Before adjourning this term of court Judge Hunt will probably be asked to dismiss the indictment against George C. Brownell, who is charged with subornation of perjury. If any of the other indictments are to be dismissed, it is not known. All the remaining cases will then be set for trial at the April term. On order of Judge Hunt yesterday all jurors summoned for the term, except those on the Hall-Mays case, were excused from further attendance on the term.
