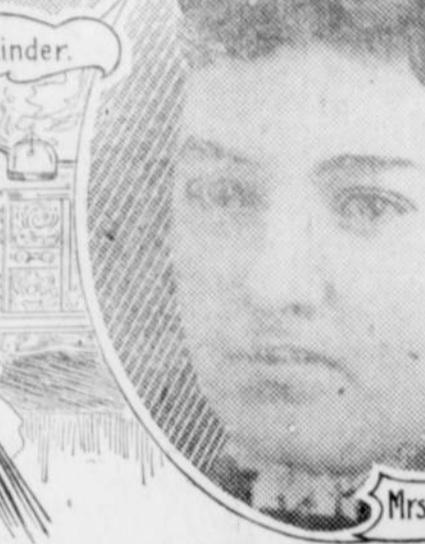
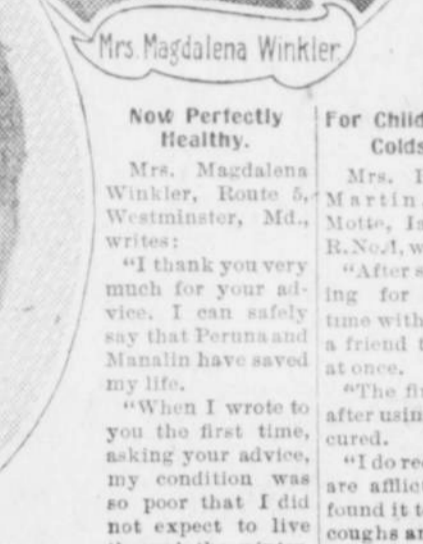

**PROGRESS ON ALSEA AND CORVALLIS ROAD**  
 Track laying on the Corvallis & Alsea railroad has been much delayed for the past two weeks by lack of ties. The road now reaches a point seven miles south of Corvallis.  
 The line from the present end of the grade has been finally located at a distance of several miles. It will neither go to Bellfontaine nor Morrow. It passes two and a half miles south of the former and two miles northward of Morrow. It passes a spot known in the vicinity as the Four Corners. The information is that a station will be located there. The route via the town of Bellfontaine was found to be impracticable. By taking a route further south three-quarters of a mile of track is saved, and many difficult cuts and fills avoided, as the surveys are well established. The company claims it is far better, for 5 per cent of those who subscribed for the stock.—Corvallis Times.

**POLITICIANS SAY CHAMBERLAIN WILL GO TO SENATE**  
 (By Associated Press.)  
 Portland, April 18.—Returns from various sections of the state indicate that yesterday's primary elections resulted in the selection of H. M. Calkins over Senator C. W. Fulton for the Republican nomination for United States senator; that W. R. Ellis in the second congressional district has defeated former Governor Geer, and George S. Shaver.  
 There seems to be no question that Statement No. 1 candidates are in the majority on the legislative ticket, which means in all probability that Governor George E. Chamberlain will be elected senator at the next session of the legislature. However, no news can be obtained from a number of isolated counties, and when the returns from those counties are in the face of the situation, so far as Statement No. 1 is concerned, may be changed, but it seems to be the opinion of party leaders of both sides that Chamberlain will win out.  
 In the first congressional district W. C. Hawley had no contest. Robert S. Bean is nominated for justice of the supreme court by both parties.  
 In Multnomah county Calkins is about 2500 ahead of Fulton and Shepherd is about 1500 ahead of Ellis.  
 The returns from outside counties are greatly in Ellis' favor and he is expected to win out by 2000 votes.

**BEAN, CALKINS AND EATON FOR REPRESENTATIVES**  
 (From Saturday's Daily Guard.)  
 According to the returns received at The Guard office up to this afternoon, Louis E. Bean, Winsor W. Calkins and Allen H. Eaton are the nominees for representative on the Republican ticket. Drew Griffin is the nominee for sheriff. E. U. Lee for clerk, B. F. Keeney for assessor, Walter B. Dillard for school superintendent, Robert E. Eastland for county treasurer, G. R. Christman for county judge, C. M. Collier for surveyor, Hugh M. Price for commissioner and W. T. Gordon for coroner. The last four candidates were without opposition and received the entire vote of the party.  
 Probably the closest fight was between Allen H. Eaton and L. N. Edwards for representative. Last night when the returns began to come in they were about even for a long time, but finally Eaton began to forge ahead, and this afternoon he leads Edwards by a good majority, with twelve or thirteen small precincts to hear from yet.  
 After Edwards' race, A. C. Jennings, and C. J. Dodd received the smallest vote.  
 For county clerk there was no doubt as to the outcome from the first. It is nearly every precinct gave E. U. Lee a majority over O. F. Callison. An occasional precinct, however, gave Callison a majority, among them being North Junction, Lee's home precinct, which Mr. Lee says, always goes against him.  
 Drew Griffin is easily in for sheriff by several hundred votes, although I. T. Nicklin ran well in a number of precincts and for a time at the beginning of the count it looked as if the vote would be much closer than it is.  
 B. F. Keeney wins easily over D. P. Burton, for assessor, and P. D. Newell comes third.  
 Walter B. Dillard, for school superintendent, won handsily over H. G. Baughman, his majority being well up in the hundreds.  
 F. T. Plank is the nominee for constable for the Eugene district, winning over Geo. Fisher by over 100 votes. R. S. Bryson is the nominee for justice of the peace, he being the only candidate in the field.  
 The Democrats' ticket, as nominated at the polls, is as follows:

**CONGRESS MAY GO AFTER PAPER TRUST IN EARNEST**  
 Washington, April 18.—In the event the attorney general does not show that something substantial has been done to prosecute the paper trust, providing its operations are in violation of the law, congress may do some trust fighting on its own account. Speaker Cannon and Chairman Payne, of the ways and means committee, contend that the tariff question is to do with the high price of print paper; that if a scarcity of the raw product is not responsible, then the fault lies with the paper trust, which by combination regulates the output and prices.  
 Lilley Does Not Know.  
 While Expert Curvish was testifying today regarding the anonymous letters which have been written in connection with the submarine boat investigation, Representative Lilley gave out a statement denying all knowledge of the authorship of these letters.  
 Hobson Not Discouraged.  
 "The fight for the big navy will go right on," said Representative Hobson, of Alabama, after an interview with President Roosevelt.  
 "No battle was ever won or lost on the skirmish lines, and we have only just begun. If John Sharp Williams had not made the matter a party question in the house, there would have been many more Democrats voting in favor of four battleships. The question of a navy is broader than the party."

**HENEY WILL NOT RETURN TO OREGON**  
 San Francisco, April 16.—To the editor of the Evening Telegram.—In your issue of Tuesday last you state that friends of mine say that I will return to Portland to oppose Fulton's election if he secures the nomination at the primaries. Any such statement is unauthorized and unfounded. I have given what facts were in my possession to the Oregon public about Fulton and have no further interest in his election or defeat, and have no intention of again repeating them in connection with his candidacy for any office. I felt that I had a public duty to perform, and having performed it, my task is finished.

**FOUR WORKMEN DROWNED IN RIVER**  
 Winnipeg, April 18.—By the upsetting of a scow while crossing Battle river, swollen by freshets, nine Grand Trunk workmen were thrown into the water and four drowned.

Deceased was a cousin of his mother, and his estate, valued at \$12,000, was distributed among Mr. Martin's mother and her four children, 65 per cent of the amount having been received today.

**PORTLAND POLICE KILL AND CAPTURE ROBBERS**  
 Portland, April 16.—Of the three thugs who last night committed a series of crimes on both sides of the river, one, an unidentified negro, is dead, Fritz Rathke, another of the robbers, is in jail with a bullet wound in his leg, and Eddie Ives, the third man, is in jail, a self-confessed robber. Patrolman Charles D. Hanson, who shot the dead robber through the heart, is being cared for in the hospital, one of the robbers having shot him through the arm.  
 The police were kept busy last night trying to locate the three highwaymen, who had robbed several saloons and citizens, and about 1 o'clock this morning G. W. Stevens rushed into the central police station saying he had been held up and robbed at the east end of the Burnside bridge. He furnished the police with an accurate description of the trio and a squad of police was sent out to patrol the district. Patrolmen Nelson and Vessey came upon the robbers walking along the railroad

**FEAR CAUSES ADLER TO KEEP SILENT**  
 Portland, April 16.—Adolph Adler, who was arrested yesterday after presenting a written demand on Sigmund Sichel, a prominent Jewish resident, for \$400 for aid of the suffering Jews, will not divulge the names of the persons who sent him to Sichel, but in an interview today said hundreds of men in this country subscribe to Nihilistic tenets, and that if he revealed their names the heads of his family in Austria would be killed.  
 Adolph Adler, a foreigner of education and good appearance, bearing passports from the Austrian government, was arrested at 3:30 o'clock yesterday afternoon after presenting to Sigmund Sichel, a prominent business man, a letter demanding \$400 for the benefit of Russian Jews who have been exiled to Siberia. Death was fixed as the alternative of prompt payment. Adler had in his pocket a similar letter addressed to Ben Selling, but did not get to deliver it.  
 Representing that he was the unwilling agent of a secret order of Nihilists, having headquarters in New York city, Adler said he had been compelled to write and deliver the letter. When threatened with arrest the fellow showed no concern, saying he would welcome being taken into custody, as he was in mortal fear of his employers. After the police had surrounded Mr. Sichel's store at 92 Third street, where the letter was tendered, Mr. Sichel suggested to Adler that they go to the police station. Oddly enough the visitor consented to this willingly and at once went to the office of Chief of Police Grizmacher. There he asked to be placed under arrest. A charge of attempting to extort money was lodged against him.

**PIONEERS CELEBRATE GOLDEN WEDDING**

 Mr. Howard has been one of the most enterprising pioneer business men of the county. Fourteen children have been born to this couple, thirteen of whom are living: Carrie Eden, of Oakland, Cal.; B. F. Howard, Arvilla Powell, Ipha Lee, and Mabel Baker, of Junction; Mabel E. Hodges, of San Francisco; Wm. V. Howard, of Spokane; Andy M. Howard, of Portland; Lane L. Howard, of Roseburg; J. D. Howard, Dora Sovern, Rozella Starr and Nora Dixon, of Eugene, all of whom were present except J. D. Andy M., Wm. V. and Mrs. Eden.
