LUMBERMEN FILE NEW BOND IN COURT

Seattle, April 20.—Bonds in the sum of \$700,000, or three times the amount required by the last order of Federal Judge C. H. Hanford, were filed by members of the Pacific Coast Lumber Manufacturers' Association and the shingle mills in the federal court this afternoon. The bond is to protect the Northern railroads, including the Great Northern, Northern Pacific and Union Pacific against loss from lumber and shingle shipments should the interstate commerce commission uphold the new tariffs.
