INDICTMENTS

RETURNED BY GRAND JURY

(From Monday's Guard.)
The regular term of circuit court convened this forenoon with Judge Harris on the bench. After the roll of jurors was called the following grand jury was chosen to enquire into the several criminal cases: David M. Purkerson, T. P. Schenck, B. G. Crow, J. D. Cochran, S. T. Baker, R. Hansen and Soren Madison.

The following trial jurors were excused and others chosen to take their places: A. W. Dugan and Joel Smith, on account of sickness in their families; Andrew Brund, on account of being an exempt fireman, and Henry Reynolds, on account of deafness. Thomas H. Hunsaker, a juror on the panel, was found to be out of the county.

Enter Pleas of Guilty.
This afternoon Judge Harris overruled the demurrers in the cases of the state vs. Harvey Jones, Wm. Twilley and Fred Craig, charged with contributing to the delinquency of Addie Watts, a minor, and each entered a plea of guilty.

Andy Graham, of Cottage Grove, who had pleaded guilty to the charge of allowing gambling to be conducted in his place of business, was fined \$100 and costs this afternoon. The amount was paid.

G. M. Whitson, accused of forging checks, was arraigned this morning and the time set for entering a plea set for Tuesday at 9 a. m. The demurrer to this indictment was sustained, but the case was re-submitted to the district attorney.

Liquor Cases Continued.
The case of the state vs. O. B. Linn, James Baldwin and Gus Seightman, charged with selling liquor in violation of the local option law, were continued for the reason that the defendants are not in custody.

First Jury Trial.
The first jury case to come up at this term was that of C. P. Houston vs. J. F. Whiting, appeal from the Junction justice court, to recover money. The following jury was chosen: Charles Frisbee, O. T. Warblington, D. T. Copenhaver, W. B. Blachley, Church Stevens, Wm. J. Bushnell, H. Edmondson, I. E. Barnest, J. F. Brewer, Jos. Strome, C. B. Blanton.

The grand jury this forenoon returned three indictments for selling liquor, one of them being against R. Barker, the other two being secret indictments. It is said, however, that they are against the J. Jacobs, the West Eighth street store keeper, who has been in similar trouble several times before.

Barker appeared in court this afternoon and waived time for pleading and pleaded guilty. Sentence will be pronounced Saturday morning at 10 o'clock. He gave a bond for his appearance at that time. He is accused in the indictment of selling to Verne Willson two quarts of beer on February 5, 1908.

The jury in the case of C. P. Houston vs. J. F. Whiting, to recover money, returned a verdict yesterday afternoon in favor of the plaintiff for \$25.

Jury Cases.
The next case called was that of Andy Graham vs. Ernest Purvance, to recover \$19.98. This was an appeal from the justice court of Cottage Grove. The following jury returned a verdict for the defendant: Wm. P. Drury, Loren Edwards, L. L. Goodrich, Albert Erdman, Henry Denhart, T. B. Davidson, Frank Knowles, Howard Pope, A. E. Wood, A. M. Hendricks, Geo. McLean, Palmer Ayers.

The case of the Allen Fruit Company, of Eugene, vs. the Weber-Bussell Canning Company, of Seattle, to recover money for cherries alleged shipped by the plaintiff to the defendant last summer, was begun this morning and the following jury chosen: Henry Denhart, Frank Knowles, F. E. Bristow, Howard Pope, C. B. Blanton, Loren Edwards, M. H. Harlow, Wm. P. Drury, Jos. Strome, Albert Erdman, T. H. Davidson.

Defendant Pleads Guilty.
David Farmer, the alleged bigamist, this morning withdrew his plea of not guilty and entered a plea of guilty. Time for sentence was set for Saturday at 10 a. m.

Whitson Pleads Not Guilty.
G. M. Whitson, alleged forger of checks, entered a plea of not guilty this morning and his trial will come up later, probably some time this week.

Equity Cases Disposed Of.
J. M. Nichols vs. J. W. Williams; appeal from Junction Justice court. Judgment for \$32.

Allee Walsh vs. W. N. Backsman; to recover money. Demurred to complaint overruled. Defendant given time to answer; reply 10 days to reply.

C. M. Kissinger vs. Mary V. Kissinger; to make deed. Dismissed without prejudice.

The First National Bank of Cottage Grove, Oregon, vs. J. V. Walker and R. S. Walker; to set aside deed. Demurrer withdrawn; leave to file answer Monday.

F. H. Cook vs. L. L. Williams; to recover money. Motion to strike out amended complaint sustained. Plaintiff given permission to file second amended complaint.

Mathias Wilhelm vs. Leland Spencer, Anna Spencer, Execy Justice and Lulu Malita; foreclosure. Decree of foreclosure; judgment for \$1300, interest at 6 per cent from September 24, 1906; attorney fee of \$129.

FRUIT PROSPECTS IN LANE COUNTY ARE SULENDIO

The recent warm weather has been the needed thing for strawberries and other small fruits in this section, while a little rain would be welcomed at any time by the farmer, indications point to a splendid all-around crop in Lane county.

The berries and small fruits are coming along nicely. Cherries are well-formed and the trees in most localities are loaded. The Royal Anns, which are most important of the cherries in this section, promise an especially good yield, and if prices are as good as last year the growers will make thousands of dollars from the one variety, which grows more perfectly in this section of the Willamette Valley than any other place in the world.

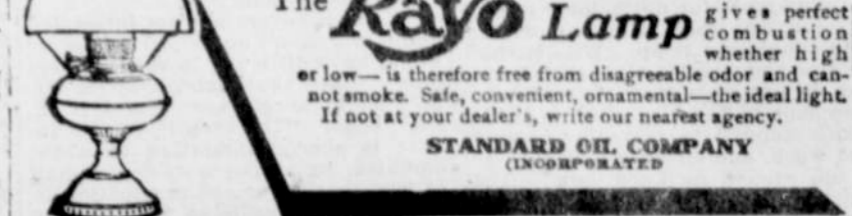
Later fruits promise, with one possible exception, a big yield. In some sections Italian prunes will yield from a quarter to a half crop, owing to the early frost which did great injury to this one variety of prunes. In other places the frost did not affect Italians at all. Other prunes, especially the Petites and silvers, were not injured in any section. Peaches are looking well and a bumper crop of pears and apples
