Judson Harmon, the nominee for governor, and ex-Governor James E. Campbell will be the chief speakers at the formal opening of the Ohio Democratic campaign, which is to take place at Mansfield late in September.

The Democrats of Blackford county, Indiana, have formed what they term the Thirty-Cent League, an organization which purposes to make a canvass of the farmers, laboring men and others for thirty-cent subscriptions to the Democratic campaign fund.

Prior to 1824 no record of the so-called "popular vote" for president of the United States was made. But from 1824 to 1904 the popular vote increased from 352,062 to 13,510,708. The vote of the nation in 1824 was less than the vote of Kansas in 1904.

George N. Tillman, who has been nominated for governor of Tennessee by the so-called Evans-Sanders wing of the Republican party of that state, was a candidate for the same office in 1896, on which occasion he polled nearly 150,000 votes against "Bob" Taylor.

The Democrats believe they have a chance to carry California for Bryan. The state was carried for Cleveland in 1892 by 44 votes, but one of the ten electoral votes was cast for Harrison. In the three succeeding presidential campaigns the state was carried by the Republicans.

Believing Illinois to be a doubtful state, the Democratic campaign committee will put some of its foremost speakers on the stump there. Among those to be heard are Judge Alton B. Parker, of New York; Governor John A. Johnson, of Minnesota; Senator Gore, of Oklahoma; Governor Folk, of Missouri; and Senator Cuberson, of Texas.

Gifford Pinchot, who is believed to be slated for a cabinet position in the event of Taft's election, is chief forester of the Department of Agriculture and one of the leaders in the movement for the conservation of the nation's natural resources. In 1892 he began the first systematic forestry work in the United States at Biltmore, N. C.

The state of Washington will hold a general primary early next month for the selection of candidates for governor and other state officers, for judges of the supreme court and members of congress. The voters also will express their preference for United States senator to succeed Senator Levi Anthony.

Bishop Alexander Walters, president of the National Afro-American council, has expressed his preference for William J. Bryan, and urges the negroes throughout the country to vote the Democratic ticket at the November election. The basis of his preference against the Republican party is the failure of congress to pass a bill to have lynchers tried in the federal courts.

BATTLE-SCARRED VETERANS MARCH IN PARADE

Commander of the Grand Army of the Republic, who reviewed the annual parade of veterans at Toledo.

Toledo, O., Sept. 2.—Cheered by a continuous mass of people that lined the streets for blocks, twenty-five thousand age-worn veterans of the Grand Army bravely covered the route of the big parade today. The parade was the big spectacular event of the national encampment and in honor of the occasion the day was observed as a general holiday in Toledo. The city departments, the banks, and many commercial institutions were closed. During the early hours of the forenoon the railroads and interurban lines brought thousands of new visitors into the city from points in Ohio, Michigan and Indiana. Before nine o'clock the downtown streets were thronged. Along the line of march at every available point viewing stands had been built and soon they began to fill with spectators.

The parade formed on Sixteenth street. The line of march led through Madison avenue, thence to Collingwood street, Jefferson and St. Clair streets and Madison avenue, thence to Fifteenth street, where the veterans were dismissed. The official reviewing stands were located in Madison avenue between Thirteenth and Fourteenth streets. Occupying seats on the official stand were the governors of several states, the city officials of Toledo and a

number of invited guests of prominence. One stand was filled for the most part with delegates to the G. A. R. and affiliated organizations and their friends. Another was occupied by disabled veterans who were physically unable to stand the strain of the march. Tears fell from the eyes of many a white-haired soldier as he gazed at his old companions marching past the stand. A hush, almost of silence, marked the passage of the army at this point.

In the formation of the parade, Toledo Post, G. A. R., was given the place of honor, that of escort to Commander-in-chief Charles G. Burton. The line was headed by a squadron of mounted police, followed by commander-in-chief and his staff. Then came a number of carriages containing several of the past commanders-in-chief and other distinguished guests.

Every state and territory was represented in the column, besides the Potomac division, made up of the Old Guard of Washington, D. C., Massachusetts, New York, Ohio, and Illinois were the best represented in point of numbers. Illinois was the first in line and was followed by the departments of the various states in the following order: Wisconsin, Pennsylvania, New York, Connecticut, Massachusetts, New Jersey, Maine, California and Nevada, Rhode Island, New Hampshire, Vermont, the Potomac, Virginia, Nebraska, Maryland, Michigan, Iowa, Colorado and Wyoming, Kansas, Delaware, Minnesota, Oregon, Kentucky, West Virginia, South Dakota, Washington, Arkansas, New Mexico, Utah, Tennessee, Louisiana, Mississippi, Florida, Alabama, Idaho, Arizona, Georgia, Alabama, North Dakota, and Oklahoma.

Ohio, as host of the encampment, brought up the rear. Preceding the Ohio veterans were the Battle-Flag division and the National association of ex-prisoners of war. At a conspicuous point in Madison avenue the veterans were greeted by the sight of a "living flag," composed of 3,500 school children. The decorations along the line of march were the most magnificent ever seen in Toledo. During the night the final decorative touches were made, and this morning the veterans were greeted by the one great display of flags and bunting. Streamers of red and yellow, the official colors of the G. A. R., and flags and pennants of the national colors were the conspicuous features of the decorative scheme.

CALL OF HOP FIELDS SUMMONS MANY FAMILIES
