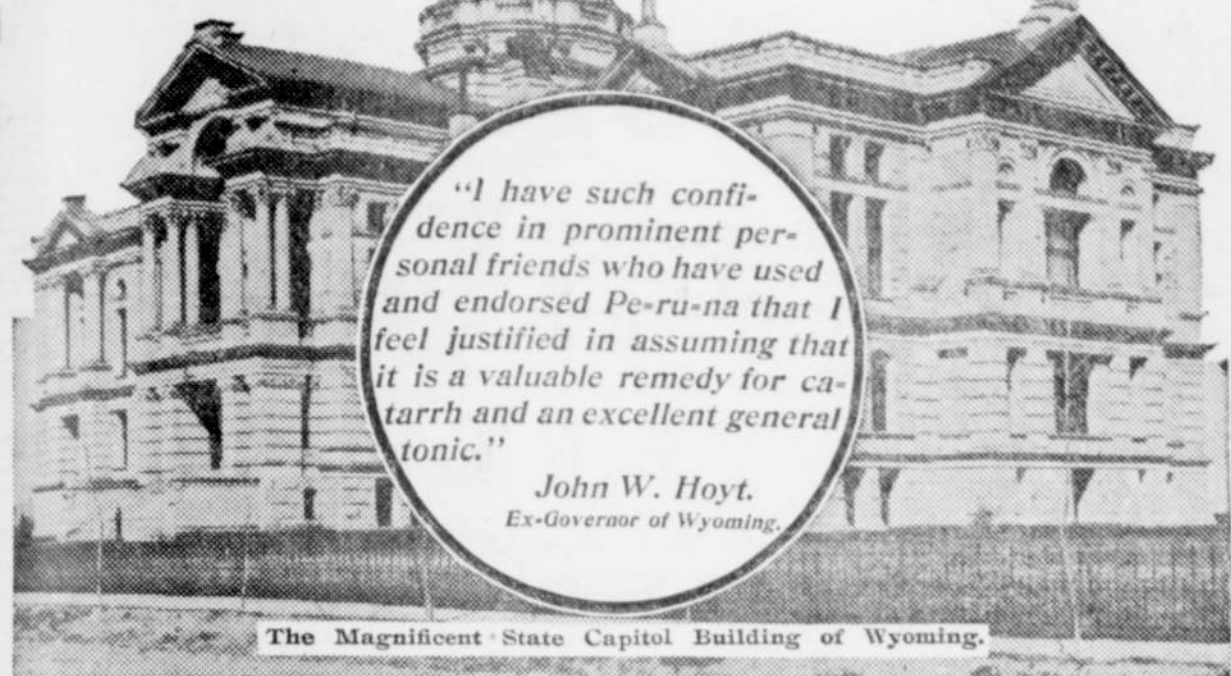

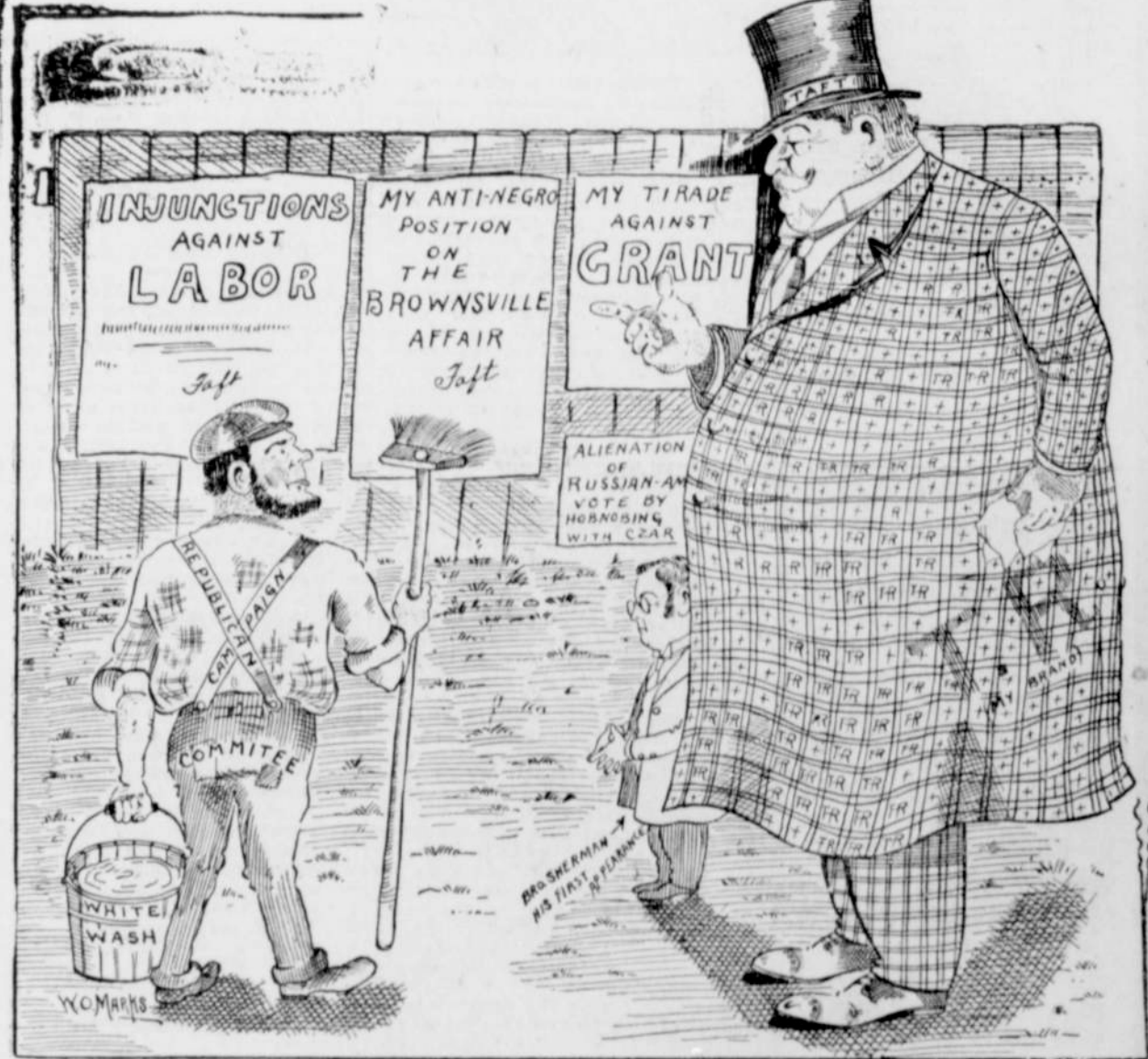

## DEATH OF MRS. IRVIN AT PORTLAND

MOTHER OF MRS. L. BILYEU OF EUGENE, EXPIRES IN PORTLAND.

Surrounded by her immediate family, Mrs. Sarah P. Irvine, one of the early pioneers of Linn County, died Thursday evening at the home of a daughter, Mrs. Allan B. Slason, of this city, at the age of 73 years. Mrs. Irvine had been a long sufferer from heart trouble and for several weeks had been in a critical condition.

Mrs. Irvine was born in Ohio, and with her father and mother, came across the plains to Oregon in 1852. Her father was Dr. Elijah Smith, of Salem, a well-known pioneer. She married, at the age of 19, Robert A. Irvine, a pioneer who afterwards became prominent in politics, representing Linn County in the State Senate for several years. He died at their home in Albany nine years ago.

Mrs. Irvine was a woman of high character and a devout Christian. Her immediate family who survive her are three daughters—Mrs. E. L. Thompson and Mrs. A. B. Slason of Portland, and Mrs. L. Bilyeu of Eugene. Mrs. A. M. Williams of Minerville is a granddaughter and Dr. Lloyd Irvine of this city, is a grandson. She is survived also by the following brothers and sisters—John R. Smith of Lebanon; Hiram Smith, Mrs. Amanda Bosler and Taylor Smith of Salem; Mrs. Eugene Royce of Newport; Elijah Smith, of Lafayette; Mrs. Mary Matser of Forest.

Funeral services will be held this afternoon at 3 o'clock at the home of her daughter, 525 Third street, conducted by Dr. Luther R. Dwyer, of the First Congregational Church. The remains will be taken to Albany for interment. Services will be held at the Grace Presbyterian Church at 2:30 p. m. Sunday Rev. A. Melvin Williams of McMinnville, the husband of her granddaughter and Rev. Mr. Woodley of Eugene, officiating.—Oregonian, Sept. 19.

## NEWS FROM LONG MISSING STEAMER

Tacoma, Sept. 18.—A special dispatch to News from Victoria B. C., says a cablegram received at Bamfield reports that the long missing steamer Aeon at Christmas Island, and the passengers are all safe. Nothing is said as to whether the steamer was wrecked or not.

The dispatch to the News further says that the report of the safety of the passengers was carried to Fanning Island, a few miles from Christmas Island.

The Aeon was a British freighter and sailed from San Francisco in July for Sydney via Apia, Samoa. Although she had no license to carry passengers she took several nautical people, including several women who signed as stewardesses and men, who signed as members of the crew.

Reinsurance on the Aeon is quoted at 55 per cent.
