PORTLAND OFFICER SHOT AND KILLED BY MASKED MAN

Portland, Sept. 23.—Policeman Samuel S. Young was murdered at 10:30 o'clock tonight in the saloon of W. S. Wood, at East Nineteenth street and Umatilla avenue. The proprietor of the resort was the only other occupant of the place when the crime was committed, who brained Wood aside and stepping quickly toward Patrolman Young, who was also approaching the door, said:

"Come on, for this time I have got you."

The masked man, carrying a revolver in his hand, raised it and leveled it at the officer. While at close range he fired. At the first shot Young turned around and the murderer fired two other shots. One of the three struck the unfortunate policeman in the brain, killing him instantly.

POET PROSPECTOR VISITS EUGENE

OLDEST METHODIST CHURCH IN WEST TO BE PRESERVED

One of the most important resolutions introduced at the Methodist Episcopal conference at Salem was one by Rev. Abbott, of Portland, relating to the preservation of the oldest Protestant church west of the Rocky Mountains. The church is located at Oregon City, and is at present being used as a paint shop and is badly in need of repair. The resolution called for a committee of five to see about buying the church and placing it on a lot by itself. At present it is located behind the Methodist church in that city. It is proposed to make a Methodist shrine of the historic building. The building came around the Horn in sections in the early days. The men behind the movement think that with some little repairing it can be made so that it will last for many years yet. Besides, the place has been made a sort of museum for the relics of the early days of the church.

FORCE S. P. TO RUN TRAINS ON S.-W. BRANCH

Salem, Sept. 24.—The railroad commission has requested Attorney-General Crawford to start suit by mandamus or otherwise to force the Southern Pacific to operate trains between Tallman and Crabtree on the Springfield-Woodburn branch. The bridge between these two points of the Southern Pacific has washed out several times. Since the last time, about two years ago, the Southern Pacific has made no attempt to build it up again.

MANILA PREPARES FOR BATTLESHIP FLEET

Manila, P. I., Sept. 26.—The city is in a fever of excitement over the impending arrival of the American battleship fleet, and, in fact, has been so for many weeks, while the extensive preparations for the reception and entertainment of the welcome visitors have been carried on.

The arrival of the fleet is only a few days distant and the details of the plans for the reception and entertainment are practically completed.

The fleet, coming from Australia, is expected to reach Basilan Island, off Mindanao, next Monday or Tuesday and will probably reach Manila on Thursday of next week.

Everything will be done to make the entire time as pleasant as possible to the men and officers of the American ships. Corridor Island will have a great "Welcome" sign, visible at a great distance. Arrangements have been made to have a large fleet of inter-island boats meet the fleet at the harbor entrance and to conduct it in to the anchorage. One handsomely decorated boat will contain the fleet committee, the Governor-General and other prominent officials. The Merchants Association and other prominent organizations have also chartered boats and will send large delegations to meet the fleet. The Philippine squadron will, most likely, join the big parade of battleships from the Cavite side.

Among other things a grand water parade has been planned, which will have many attractive features. Women in launches will go in and out between the vessels, carrying flowers. According to program the arrival of the fleet will be the signal for the ringing of all the church bells in the city, the blowing of steam whistles

and the thundering of a welcome by the guns of the forts and batteries. The first shore event will be a monster parade, at the conclusion of which a grand dinner will be served to the men at the moat site along Bagumbayah.

In the afternoon there will be field games on Wallace Field, baseball at Paco Park and open air concerts at the Plaza Moraga, Santa Cruz and the Botanical Garden. For the evening all the theatres in town have been engaged and free performances will be given for the benefit of the visitors. Later a grand ball will be given to the officers of the fleet.

Americans and natives are rivaling in their efforts to decorate their houses in the most tasteful and attractive manner and it is safe to say that the city will present a gay and brilliant picture during the visit of the American fleet.

The festivities will extend through the entire time which the visitors are expected to remain here according to the official program and all classes of the population are joined in their efforts to give to the visitors unmistakable proofs that their country is ready to receive them in the most hospitable manner.
