ROOSEVELT WRITES ON LABOR QUESTION

Washington, D. C., Oct. 21.—Campaign literature was enriched today by a letter from President Roosevelt addressed to Senator P. C. Knox in which Roosevelt pays his respects to President Gompers of the American Federation of Labor. Speaking at Philadelphia Tuesday Knox took issue with Gompers on the question of organized labor in the present campaign and the president's letter is in support of Knox's view.

Mr. Bryan has frankly questioned Mr. Taft during the progress of this campaign to make clear his stand on public matters in which the public are entitled to be enlightened. In turn, with equal frankness, and with equal propriety, Mr. Bryan should silence and make definite and certain his own position in regard to the matter which concerns not only business men and every decent law-abiding citizen, whether a wage-earner or not, just as much as it concerns Mr. Gompers and that part of organized labor stands with him.

There is none of the generalities of vague expression of sympathy for labor. Let Mr. Bryan simply confine himself to the anti-injunction plank of his own platform and tell us, definitely and clearly, whether he accepts or rejects the statement of Mr. Gompers that this plank pledges him to the principles of the bill for which Mr. Gompers stands; and whether, if elected, he will endeavor to have his personal stamped into law. This is asked honestly in the interest of that large voting public which believes sincerely in the promotion of every legitimate right and interest of labor but which believes also that from the standpoint of the best interest of labor it neither requires or is entitled to more than justice and that the right to destroy business should not be formally recognized in the law of the land.



MORE PROOF OF D. B. McLEAN'S INNOCENCE

Facts learned by Sheriff Stevens and his deputy in Portland this morning make it practically a certainty that D. B. McLean, of Eugene, now in custody at Vancouver, Wash., on suspicion of being the assassin of Butlerworth, is innocent of the crime. Philip Rosenmyr, who conducts a pawnshop at 26 North Third street, has informed them that at 9:10 o'clock Tuesday night a man giving the name of H. D. McLean, and answering to the description of the prisoner exactly, was in his shop. The pawnbroker was not "led" by these officers in giving his story, and convinced them he was furnishing nothing but facts.

The man came in here Tuesday night about 9:10 o'clock," said Rosenmyr. "I can fix the time by figuring back from closing time, 10 o'clock. He appeared to be a 'Rube' and was drinking a good deal. He took several hatcases on to Erickson's saloon and purchased them a round of drinks. He told me his name and that he was from Eugene, and talked some about buying a watch.

He exhibited a side-ejector revolver of late pattern, caliber .32-20, and it then contained 22-29, and also showed about eighty dollars, and carried the money in a buckskin pouch purse, with a drawing string. The description given by the pawnbroker fits McLean exactly, and the revolver and purse found on him are the same kind as mentioned by Rosenmyr. Harry Morrison, proprietor of the New Grand Central Hotel, informed Deputy Leonard that he knows McLean, as the prisoner said, but not intimately. A search of the grip left at the hotel revealed that it contained only an old watch and a pair of patent leather shoes, just as the suspect asserted.

Taking these facts and information received from Eugene in conjunction with the fact that Butterworth was shot with a ball from a .32-caliber revolver, while the calibre of McLean's weapon was .32-29, or .32 Winchester—both are used indifferently—the sheriff and his deputy do not hesitate to say they believe McLean had nothing to do with the affair.

Tom Condon, who conducts a lodging house at St. John, and formerly was proprietor of a hotel at Eugene, also corroborates the prisoner's statement of their acquaintance.

On receiving the information gleaned by Sheriff Stevens and Deputy Leonard shortly before noon today the J. Fitzgerald, District Attorney Cameron's chief deputy, advised the Multnomah officers to inform Chief of Police Scierat that so far as they are concerned the man need not be held any longer.—Oregonian.

COTTAGE GROVE HAD BAD FIRE MONDAY NIGHT

Last night about 9 o'clock flames were discovered issuing from the big store of Garman & Hemenway at Cottage Grove and before they could be extinguished the establishment was in ruins.

People at the hotel across the street from the store first noticed the flames as they were bursting out through the front of the building. The alarm was given and the volunteer fire department responded in quick order. The firemen, assisted by hundreds of citizens, did all they could to stay the blaze, but they were unsuccessful. Practically the entire stock of goods, occupying both floors of the building, was gutted, nothing but the bare brick walls standing.

Oliver Veatch is the owner of the building, which was erected at a cost of over \$10,000. There was little insurance on the structure. The loss to the stock is estimated all the way from \$40,000 to \$50,000, with but \$20,000 insurance.

"PURITY HELPS" ROASTS "OLD BILL OBEDIAH"

MORSE KNEW HE HAD "BUSTED" BANK

New York, Oct. 26.—After the admission of the testimony of John W. Gates, ex-Justice Morgan J. O'Brien, Charles Schwab, John H. Flieger and W. E. Havaway, to the effect that as directors of the National Bank of North America they had never authorized the honoring of the overdrafts by Charles W. Morse, the vice-president of the bank, and had never known of the existence of such a practice, the prosecution late today rested a case in the United States court here against the former banker and promoter and his fellow defendant, A. H. Curtis, who are being tried for alleged violation of the National banking laws.

Today's session furnished a number of sensations, not the least of which was the declaration by W. W. Lee, a former vice president of the bank, that on the day of the institution's collapse, Curtis, the president, had said to him:

"Repudiated Loan

"I have just told Morse that he has busted the bank,"

Mr. Lee was questioned at length concerning the happenings behind the closed doors of the bank during the evening hours of October 16, 1907, the day of the collapse. After the accounts of the day's transactions had been closed, it was discovered, Mr. Lee testified, that Mr. Morse had overdrawn his account \$211,000. In order to make good this deficiency Morse had turned into the bank a quantity of securities for the most part stocks and bonds not listed on the stock exchange, and of doubtful value, as collateral for a loan of \$211,000. This loan the directors repudiated on the following day.

EX-BANKER MORSE WINS DECISION OF TRIAL JUDGE

New York, Oct. 27.—The conspiracy count in the indictment upon which Charles W. Morse and Alfred H. Curtis are being tried in the United States circuit court was dismissed by Judge Hough today, after exhaustive arguments by the counsel for defense and by District Attorney Stimson. This leaves Morse and Curtis to face only the charges of violating the National banking law.

LONG TOM RIVER, ONCE NAVIGABLE, NOW CREEK

Solid Bridges Replace Draws on Public Roads—May Again Be Opened to Traffic

Monroe, Oct. 26.—Long Tom river, a stream which a few years ago was declared navigable, over which one of the oddest drawbridges ever constructed was placed and upon the opening of which several thousand dollars was expended by the government, is again a quiet country creek. Bridge carpenters are at work building a solid bridge across old Long Tom, at the Potts lane, and the queer old drawbridge a few miles north is also a thing of the past.

Just why these things are so is not very easily explained. The quantity of water is as great as is needed to carry on light boating, and the country through which this stream winds its way is large enough to support a line of freight boats. The citizens of this portion of the country, however, are enthusiastic over a railroad, and apparently are not able to see the benefits to be derived from an open river, with a small boat or two carrying the products of southern Benton and northern Lane counties to market, at a minimum cost of transportation.

It is almost a surety that within 10 years this waterway will again be opened to traffic, despite the fact that a railroad is now being constructed into this same section of the state. Just as soon as the larger ranches are divided into smaller holdings—and this is rapidly taking place—a greater demand than ever will be heard by the man who can figure out another scheme to open the Long Tom river to navigation.

WASHINGTON WINS OVER WHITMAN COLLEGE

Seattle, Wash., Oct. 24.—Washington defeated Whitman College here today 6 to 0. The touchdown came near the close of the game when Quarterback Coyle returned a punt of 35 yards to the four-yard line, and Muckelstone carried the ball over after two ineffectual attempts.

Both elevens played about the same class of football, neither showing superiority over the other until near the end, when Washington smashed the line for gains, using Willis and Babcock as the battering rams.

Grimm and Mattson at end played remarkable games, getting into nearly every play. Muckelstone did great work on defense. For Whitman, Captain Borleske, half; Lewis, end and Schmidt, quarter, were stars. Washington was not sure in tackling, and needs improvement in offensive work. On defense Washington played considerably lighter than its opponents, but was fast and hard fighting all through the game.

O. A. C. Defeats The Dalles, Oregon Agricultural College, Corvallis, Oct. 24.—The football team from The Dalles went down to defeat this afternoon before the Oregon Aggies, in a very poor exhibition of football, 10 to 0.

LIBERALS WIN GREAT VICTORY IN CANADA

Toronto, Oct. 27.—The result of yesterday's elections shows that the Liberal government has been sustained by a majority of fifty with several elections set to be held. All the ministers were re-elected, while seven of the opposition's chief lieutenants were beaten.

The figures as announced today are 132 Liberals and 82 Conservatives. The standing at the dissolution of parliament was 139 Liberals and 75 Conservatives.

Washington, Oct. 27.—Information has reached the Isthmian canal office in this city of explosions of dynamite in the canal October 15th in which twelve were killed and eighteen injured.

The first explosion was at Chubasco cut, in which five were killed and eight injured; the second at Mindi, where seven were killed and ten injured. W. J. Davis, engineer, and George Goodly crane man, were the only white men killed.

BRYAN HOBSONIZED BY NEW YORK WOMEN LAST NIGHT

Madison Square Garden, N. Y., Oct. 26.—At the close of a trying day's day of out-door speaking in a drizzling rain, of fast-flying trips by automobile and special trains, of receptions and formal dinners, and of three big evening meetings in different sections of the city, Colonel Bryan addressed in Madison Square Garden tonight the most notable gathering of his three campaigns.

The candidate began his long day with a dash through mud and rain to Paterson, N. J., in an automobile. He spoke in a downpour for twenty minutes and then thousands of the audience was drenched to the skin. Returning to the city he was the guest at a reception at the Waldorf-Astoria hotel, where two impulsive ladies threw their great coats over him and kissed him. He had made a flying trip through the Westchester county, returning to New York. Bryan was the guest of honor at a reception and dinner at the Democratic Club. Then began the evening tour, which took him to the Hamilton Park, Cooper Union, Palm Garden, and thence to Madison Square Garden.
