WASHINGTON WINS NORTHWEST CHAMPIONSHIP

The University of Washington holds undisputed title to the football championship of the Pacific Northwest. The Washington State College team might dispute Washington's claim because of having played the Seattle team a tie game were it not for the fact that Pullman is hardly entitled to consideration in view of its performance against the other Northwest colleges. Washington showed superiority at all stages of the game. Eakin had the advantage over Wolf in punting by a few yards on each kick. In addition, Eakin got his kicks higher, giving his ends plenty of time to get down. The Washington ends nailed the recipient of a punt in his tracks time after time, while Oregon's punts were always returned from 5 to 15 yards. Washington was stronger, both on offense and defense, than the visitors. There was a finish to her open plays that did not show with the Oregonians. Washington handled the forward pass beautifully, although she did not use it a great deal.

FOREIGN WARSHIPS GATHER IN FORCE AT HAYTI'S CAPITAL

Port au Prince, Dec. 1.—The American cruiser Des Moines arrived here today, and her presence augments the force of foreign sailors and marines landed for the protection of the city, particularly the foreigners, in case of a clash between the rebels and the troops of the government, which is apparently bound to come in a very short time. The arrival of the Des Moines was preceded by the arrival of the French cruiser Duguay Trouin and the United States cruiser Tacoma. The British cruiser Seylla and the Italian cruiser Fieramosca are expected shortly.

The night passed without a serious outbreak, though the people are nervous with excitement.

LaPorte, Nov. 26.—Ray Lamphere, charged with the murder of Mrs. Belle Guinness and her three children by setting fire to the Guinness home, was found guilty of arson by the jury tonight. Within five minutes after the verdict the defendant was sentenced to state's prison for an indeterminate term of two to twenty-one years, fined five years and disfranchised five years.

Attorney Woodson, for the defense, said tonight that a motion for a new trial would be made and should it be refused an appeal to the supreme court would follow. The supreme court is two years behind with its

work, so this case could not be reached until after Lamphere had served the minimum time of his sentence. Worden declared the verdict ridiculous. "If he was guilty at all," said the attorney, "he was guilty of murder. He should have been acquitted."

Harrisburg, Or., Nov. 29.—The business men of Harrisburg and the principal farmers of the adjacent district met yesterday in the City Hall for the purpose of drafting plans for the development and betterment of this section. CHIEF OF POLICE BIGGY WAS DROWNED IN BAY

San Francisco, Dec. 1.—The police commissioners met at 6 o'clock this morning and appointed one of their number, A. D. Cytler, to succeed Chief of Police Biggy, who was drowned in the bay last night, the appointment to be temporary.

The waters of the bay and the shore line are being searched but the body has not been recovered. The commissioners are also making an investigation into the circumstances connected with the death of Biggy and have taken the depositions of Commissioner Kiel, from whose residence at Belvedere the chief was returning when he lost his life, Engineer William Murphy, of the police boat "Patrol," from which Biggy fell into the bay, and Police Captain Conboy, who is conducting the search for the body.

The commissioners will issue a formal statement of the affair later in the day.

KEIL'S STATEMENT

The most important statement made today is that of Police Commissioner Hugo D. Keil, who stated that he was advised by telephone by some man from San Francisco that "a gentleman is coming over in the launch to see you. You know who it is."

Keil's informant declined to give his name, and the commissioner watched at the landing until he sighted the boats of the launch. Biggy came ashore in a small boat. He complained of being cold and was given whisky and cigars. Keil stated that it was a habit of Biggy's to visit him, but he usually had an escort of a policeman or a sergeant. Keil stated that Biggy was very much worried over newspaper attacks upon his administration, especially since the suicide of Haas, and Keil advised him not to take the matter to heart.

On all sides are heard expressions of regret over the loss of Chief Biggy, who in political and business circles was highly esteemed.

DETAILS OF DROWNING

San Francisco, Nov. 30.—William J. Biggy, chief of police of this city, was drowned late tonight while returning across the bay in the police patrol boat Patrol. Chief Biggy had been at Belvedere, a suburb, to call on Police Commissioner Kiel, who lives there. He boarded the launch to return to this city at about 10 o'clock and when the boat was on the bay complained of feeling cold to Engineer Murphy, the only other occupant of the launch. Murphy advised Biggy to go to the cabin in the stern of the boat.

Murphy then went below to attend to his engines and did not see the chief again. He came on deck as the boat neared the city and noticed that the chief had disappeared. Search of the boat failed to locate him. Murphy made all speed to the dock, where he reported the accident and went out into the bay again in search of the missing officer.

Numerous boats were hurried to the scene and a careful search of the bay begun.

ALL FRANCE STIRRED BY STEINHEIL CASE

Paris, Nov. 28.—The Steinheil case continues the sensation of the hour in all France, and no one ventures to say where the revelations will end. The political side looms larger and larger and the interest harks back to the tragic death in Paris in 1899 of Felix Faure, president of France, who died amid the Dreyfus excitement. The most minute details of the scene in the room where he expired in company with Mme. Steinheil is flagrantly published by even the republican papers.

The Royalist and anti-Dreyfus papers are demanding an investigation of the death of President Faure and intimate openly that he was an insuperable obstacle to the leaders of the Dreyfus agitation and was murdered as the result of a plot. The only reason to believe that Faure did not die a natural death was found in the fact that his body decomposed with unusual rapidity. Seven of the best-known physicians of Paris certified that he died of cerebral hemorrhage.

Various episodes in the life of Mme. Steinheil, her alleged love affairs and intrigues are coming to light, and the prevailing belief in Paris is that she deliberately had her husband and her mother assassinated.

LONG EXAMINATION OF MRS. STEINHEIL

Paris, Dec. 1.—Mme. Steinheil, suspected of the murder of her husband, was examined at length today. The interrogation will continue two days.

THREE LITTLE BOYS FREEZE TO DEATH

Ventura, Nov. 28.—Frozen to death in snow that covers the high peaks north of the Santa Clara valley. Wednesday night, the bodies of three Santa Paula boys were found late today after a search of two days. The boys, Clifford Tharp, 17; Cuba Tharp, 9 and John Blaes, 13, started out Thursday morning to see the snow. They went without coats and they had not returned, the community was notified but nothing could be done until daylight. Friday morning searching parties were organized, everybody joining, even to gangs of Japanese laborers, and two gangs were kept up all day. To the search was Henry Newman and W. Hamlin found the bodies at the head of Timber Canyon, ten miles from Santa Paula. The boys had evidently gotten into deep snow, became exhausted and perished from cold and hunger. The fathers of the boys are well-known ranchers.
