NEW YORK WOMAN PAYS DEATH PENALTY FOR MURDER IN AUBURN PRISON TODAY

Auburn, March 29.—Murmuring a prayer for her soul, Mrs. Mary Farmer was quietly led to the electric chair in Auburn prison shortly after 6 o'clock this morning and executed for the murder of Mrs. Sarah Brennan last April.

Father Hickey, following the execution, gave out a statement signed by Mrs. Farmer, in which she declared her husband innocent of any connection with the crime.

There was a touching farewell between Mrs. Farmer and her husband, who said their goodbye, separated by steel bars and an intervening screen.

The crime for which Mrs. Farmer was executed and for which her husband, James D. Farmer, is also under sentence of death, was the murder of Mrs. Sarah Brennan, a neighbor, in the village of Brownsville, Jefferson county, about four miles from the city of Watertown on Thursday, April 23, 1908.

Mrs. Brennan was found on the following Monday in a trunk owned by Mrs. Farmer and in her possession. Mrs. Farmer and her husband were given separate trials, and although the evidence was circumstantial, both were convicted and sentenced to be electrocuted.

Mrs. Farmer came to this country from Ireland in 1900 and worked for a time as a domestic in Binghamton, going from there to Buffalo where she married James D. Farmer in 1904.

Mrs. Farmer and her husband Patrick lived in a house nearby which they had occupied for twenty years and which was owned by Mrs. Brennan. Mrs. Farmer became a frequent caller at the Brennan home and Mrs. Brennan occasionally called on the Farmers.

Months before the homicide, in October, 1907, Mrs. Farmer went to a lawyer's office in Watertown, property and impersonating Mrs. Brennan, had the deed transferred to James D. Farmer, signing the name "Sarah Brennan."

On the day of the crime Mrs. Brennan's husband left early for his work, his wife telling him she was going to visit a dentist in Watertown. Between 9 and 10 o'clock she was seen to leave her home and enter the Farmer house.

Salem, March 29.—After watching four convicts sawing through the prison bars for a week penitentiary guards prevented the men from escaping this morning.

John Branton, a desperate man and the ringleader, in prison for attempted murder, committed suicide with a butcher knife.

Branton, who suicided, was sentenced to the penitentiary from Lane county on June 26, 1905, for a term of ten years, for attempting to kill John Fletcher near Cottage Grove.

CHARGE AGAINST WALKER IS 20 DEGREE MURDER

(From Monday's Daily Guard.) The charge against Wm. R. Walker, who shot Ed. Lang in the leg at the Campbell & Walker boy yard between Eugene and Springfield Friday afternoon because Lang abused Walker's mother, was changed this afternoon from assault with intent to kill to murder in the second degree.

The inquest over Lang's body was held by Coroner Gordon at his undertaking parlors this afternoon, the following jury having been empaneled: E. O. Lake, Simon Kivahala, J. E. Cross, E. Hanson, J. M. Kitcher and J. S. Miller.

We, the jury, find as follows: 1. That the body before us is the body of Edward Lang, a native of Ireland, about 65 years old.

2. That the said Edward Lang died at the Eugene General hospital on the 27th day of March, 1909. 3. That the cause of death was a gunshot wound above the right knee.

Witnesses Examined The witnesses examined were a follows: Mrs. Mary Walker, mother of Wm. R., who witnessed the shooting; Mrs. Leff, who was on the place at the time but did not see the shooting; Dr. F. M. Day, who attended Lang; Mrs. Sherrill, the nurse at the hospital, who cared for Lang; and Deputy Sheriff C. C. Hammond, who took charge of Walker after the shooting.

Immediately after the inquest was completed Deputy District Attorney G. F. Skipworth made out a new information against Walker changing it to second degree murder. Walker, who was out on \$2000 bonds under the first charge, is now in custody of the sheriff.

Bury Lang Wednesday. The body of Lang will be buried in the L. O. O. F. cemetery Wednesday forenoon. He has no relatives, as far as known, in this country, and of them residing in Ireland.

NEW SENSATION IN CALHOUN CASE San Francisco, March 28.—Five men, two of them trusted employees of Detective Burns and District Attorney Langdon, were arrested yesterday charged with robbing the office of Lodon to secure evidence in favor of Patrick Calhoun, now on trial on the charge of bribing a supervisor. The other three are alleged to be employees of the United Railroads.

The arrested men are: Rex N. Hamlin, confidential employe of District Attorney Langdon; Al McKinley, United Railroads and Reef co-bribe; I. E. Platt, son-in-law of A. Z. Ellerbach, employed in the district attorney's office to investigate jurors; William Corbin, go-between for Abe Reef, and Jerry Van Wormer, United Railroads detective.

Hamlin, who was first arrested, made a complete confession and the other arrests followed.

For a long period Hamlin has been a trusted employe of Langdon and Burns, and was the only man in the office who had a key to Burns' desk and possessed the combination to the safe.

Traced at \$200 a Month. About December 1 Calhoun's agents succeeded in secretly winning Hamlin over to their side. Since then he has been on the United Railroads payroll at a salary of \$200 a month, and it has been his practice to transcribe confidential records and all documents which he thought would be of importance, turning them over to McKinley, who in turn submitted them to the inspection of his superiors.

About two months ago Burns became aware of Hamlin's broken trust and has kept close watch on him. Hamlin has been permitted to handle nothing of moment.

He was not arrested until yesterday, so that ample incriminating evidence might be collected against those who hired him.

When arrested Hamlin was copying an affidavit for delivery to agents of the United Railroads.

Platt, it is charged, sold reports of the investigations regarding members of the jury panel, to John Helms, of the Calhoun detective agency.

All the prisoners have been placed in separate cells in the city prison.

Almeda Clay Welch was born at Essex, New Jersey, September 16, 1834. She came with her parents to the town of Bureau county, Ill., in 1850. On March 2, 1863, she was married to James Phelps. To this union were born four boys, Francis, L. of Page, Neb.; George W., of Chicago, Ill.; Giles H. and Charles W., of Eugene, Or. In 1883 they came to Eugene, Neb., where her husband died in 1888. In 1903 she came with her son, Giles, to Eugene.

In her 74th year she was converted to the Methodist church. At the time of her marriage she joined the Congregational church with her husband. When they came to Nebraska they joined the Presbyterian church, there being no Congregational church at that place, and at the time of her death she was still a member of the Presbyterian church.

She had been in poor health for a number of years. She died at her home in Eugene March 24, 1909, aged 74 years, 6 months and 8 days.

Four sons, two brothers, Charles W. Welch, of Tampico, Ill., and William L. Welch, of Eugene, Or., and the sister, Mrs. Jacob Kinney, of Waterloo, Ia., mourn the loss of a faithful Christian, mother and sister. The funeral will be held at Gordon's undertaking parlors Sunday afternoon, March 28th, at 2:30 p. m. and the remains will be laid to rest in the L. O. O. F. cemetery.
