PROHIBITED FOR THE
FOURTH'S CELEBRATION

Don't buy cannon fire crackers. If you are a boy, don't sell the delightful dangerous king of misemakers, if you are a merchant. If you do you may pay \$10 to the city treasury. The city council decided last night to enforce the old ordinances, providing that no cracker longer than four inches, or a dynamite cracker or bomb shall be sold or fired in Eugene. Notices will be posted, and all cases will be prosecuted. The penalty is a fine from \$1 to \$10.

The council also instructed the chief of police to prohibit the popping of crackers on the park plazas, especially during the speech-making of the two days' celebration.

ASSESSMENT
OF S. P. CO.
IS RAISED

A few weeks ago The Guard mentioned a meeting of Western Oregon assessors in Eugene, held for the purpose of raising the assessment on the Southern Pacific company's property in the respective counties represented by the assessors at the meeting. At that time it was desired that the figures agreed upon by the assessors be kept from the public for awhile, but now that all details have been agreed upon by the several assessors along the line of the Oregon and California division, the result of the deliberations here are made public.

The assessment on the roadbed and right-of-way has been advanced from \$28,000 to \$35,000 per mile. In conjunction with this raise the company's rolling stock has been raised in valuation from \$2,000 to \$3,000 per mile.

The bonded indebtedness of the Southern Pacific road, according to its own statement, is \$59,000 per mile, or just \$21,000 more than the total made by the assessors of the several counties. They have also increased the valuations of the Pullman car company. Last year the assessment was \$300 per mile. This year it is \$500.

No raise is made this year in the assessment on the company's timber lands because of the quiet condition of the market. Last year's valuation will stand, which is 45 cents per 1000 feet of merchantable timber and \$1 per acre more on the land.

"BUFFALO BILL'S"

LONG DRAWN-OUT TRIAL
OF PATRICK CALHOUN CLOSES
AND IS GIVEN TO JURY

San Francisco, June 19.—Not alone because of the exceeding bitterness that has marked many of its stages, but because of its length, has the Calhoun trial been a notable one in western history. Between January 12, this year, when the attempt to secure the first jurymen was instituted, and today, when the case went to the jury, five months and a week had elapsed and 158 days had intervened. Of this period 110 days had been devoted to court sessions. Three months and two days were necessary to obtain a jury, which consisted of thirteen men. Of the 2,310 citizens summoned by the sheriff, 1,423 were actually subjected to interrogation by the attorneys in the case. The typewritten record of the case amounted to 2,500 words when the jury was completed. The judge, attorneys and witnesses have added another million and three-quarters words to the bulk of the manuscript, and the estimated cost of the trial will exceed \$50,000.

HENEY'S BITTER CLOSE.

Francis J. Heney had ninety minutes in which to close his argument in the trial of Patrick Calhoun today. He made direct charges of witness fixing and perjury, and in referring to the dynamiting of James L. Gallagher's home in Oakland by alleged agents of the defense, he said:

"Now that A. A. Moore, of the defense, has assured me that the defendant and his associates wish me a long life, I shall take added precautions for my own protection and make as certain as I can that I shall not be shot in the back or dynamited in my bed. The evidence here shows that it is often possible to prepare a defense in advance, and it is idle to overlook warnings of this sort."

Judge Lawlor finished his instructions to the Calhoun jury at 11:43 and three minutes later the jury retired. Court then adjourned until 3 o'clock.

GOTHAM MURDER INVOLVES
FAMOUS FAMILY IN SCANDAL

New York, June 19.—The murder of Miss Elsie Sigel, granddaughter of General Franz Sigel, whose body was found last night crowded into a trunk in a room of a Chinaman apartment house, is the most remarkable case before the New York police for years. One odd phase, in spite of the fact that jewelry and clothing of the girl were identified by the mother, and the body has been identified by friends, is the fact that the father, Paul Sigel, has failed to identify the body.

The police are searching for the Chinaman, William L. Leon, in whose room the body was found, also Chung Sin, who occupied the room near Leon.

The Chinamen are said to have sailed for Vancouver, B. C., on a steamer via Panama, and the authorities are trying to intercept the vessel at some intermediate point. In Leon's room over 1,500 letters from women, many of them of an endearing nature, were found. Many from "Elsie" are of the love letter variety.

In one of them "Elsie" reproached Leon for causing trouble between her father and herself. "Just think of the sacrifice I have made for you," she said.

A notebook belonging to Leon containing the names and addresses of hundreds of women was found in Leon's room. The police believe that "Elsie" has been a captive some time. It is stated that Miss Sigel has been engaged in missionary work among the Chinese in this city for several years, having become interested therein through the activity of her mother in behalf of the Orientals. She is a young woman about 20 years old. Leon was greatly enamored of the girl, but did not like her to receive the attentions of other men.

Several Chinese were examined by Coroner Harburger today at the preliminary inquest over Elsie Sigel's death and three of them were, in default of \$1,000 bail, held as material witnesses. The autopsy indicated that the girl had been asphyxiated. The organs also indicated that poison might have been administered.

CONTINUE WORK
ON RAILROAD
FROM KLAMATH

Klamath Falls, Or., June 19.—Klamath Falls is not long to have the distinction of being the end of the railroad line, and, in fact, that claim was only true for a short time. While this city is the end of the service for the present, there has been no cessation in the construction of the line beyond this city. The road has been steadily traveling northward and the indications are that instead of any let-up, the future is to see renewed efforts in rushing the work to make main line connections across the mountains at Eugene.

The Berger-Bean Hardware Co. have received another carload of the popular auto-buggies, making the third carload shipment for this season.

REAL LEADER
OF BAD GANG
IS ARRESTED

Omaha, June 19.—Advice have been received here of the arrest at Buhl, Idaho, of F. W. Martin, said to be the fifth man wanted for alleged connection with the Union Pacific mail robbery here May 22. Martin is now confined in prison at Twin Falls.

Martin Real Leader.

Omaha, June 19.—Martin is said to be the real leader of the gang. He is 42 years old and has served two terms in the pen, one in Idaho and one in Montana, one for safe blowing and the other for horse stealing at Walla Walla. He has operated for years in the Northwest.

WILL ESTABLISH
A FURNITURE
FACTORY HERE

The American Mill & Lumber Co., which recently erected a new building for its planing mill and sash and door factory at Seventeenth and Willamette streets, which is 200x50 feet in dimensions, has about completed plans for starting a furniture factory, either in a portion of the mill building or in a building adjoining to be erected later. A representative of the company is now in the east negotiating for an expert in the making of furniture and to buy the necessary machinery.

MYSTERY OF STEN
LUND'S OPERATIONS

Dr. Selover Telegraphs Chicago Contracting Co. is Responsible Concern.

The operations of Sten Lund, the railroad promoter, representing the Chicago Contracting Co., is more of a mystery than ever. He came out to Cottage Grove with some real capitalists, including President Davis, of the Pullman Co., and this fact, together with certain letters and telegrams he displayed, induced local parties wishing to secure the building of the Eugene-Siuslaw railroad to enter into negotiations with him. When he left the city after a week's stay here the proposition to bond the road was pending before the Commercial Club, but shortly after three or four small sight drafts drawn upon himself, aggregating probably \$60, which he cashed here, were returned unpaid. This fact effectively disposed of his railroad proposition.

One of Lund's victims who cashed a \$10 draft, was Dr. F. E. Selover, who is now in Chicago. Yesterday he wired to F. E. Dunn: "Have thoroughly investigated the Chicago Contracting Co. and they are O. K." This information only adds to the mystification of those who had dealings with him here. The man's acts were so contradictory that they are unable to class him either a railroad builder, a promoter, or a bunko operator. There seems no positive proof that he did or did not belong to either class, and those who became acquainted with him will not believe that he was mentally unbalanced.
