hand of the cleaner this part of the process must never be forgotten. The gown in question was made with many gored skirt hung from a medium high waist line with a shaped belt that came well up under the arms and back but dipped slightly in the front. As this gown was intended for business, and except in the warmest weather, a coat is needed on the cars for early morning and evenings or cool, damp days, a coat was added which was very plain. An applied stitched collar was used, as the regular coat collar never sets quite as it should after it has been to the cleaner or wash tub. Stitched applied cuffs were also the finish of the sleeves. Outside of the stitching, tan linen buttons was the only form of decoration. With this suit was worn a hot waist in tan made with clusters of tucks. Of course any waist may be worn, but thus the idea so popular of having the waist match the suit is carried out.

Fabrics that are very much liked are English zephyrs. These goods are made from Egyptian yarn and the dyes used are of the purest and most lasting. The weave is very fine and even, and because of its durability and fine coloring makes the material one of the greatest favorites of the season. A dainty little house dress was developed from one of these, having a very small check of dark and light blue with an alternating over-stripe of black and white line half an inch apart. The dress was made up after the demi-princess idea with the new panel effects, a white lace yoke with lower half sleeves of lace, a belt of black satin and narrow black ribbons outlining the yoke and sleeves gave a decided air of distinction to the gown.

I should here say a word about the panel front, which in its latest development is wider at the bottom than at top, an idea that is helpful to a figure over-large at the hips. Although called a house dress this is a more appropriate little summer frock for church, garden parties, etc., while at the country seat or summer resort.

Swiss muslins have come into their own again and those with the new sombre embroideries are extremely beautiful, indeed, muslins, organdies, handkerchief Hues and dimities all show these lovely embroidery designs, and the bordered goods are especially chic when made up. Nearly all the muslin goods are made up over linings of the white or dull off-shade which resemble the pastel tones somewhat and covered with the muslin over-dress gave the "veiled" effect so much sought today.

A pretty gown of this description was a fine white Swiss embroidered in tiny silk sprays in white, and made over a green silk. A well-mercerized cotton material that is a clever imitation of brilliant-mesh, is much used for motor coats, just coats, and traveling wraps, the same being known by the name of motor-cloth brilliantine. A similar motor cotton suiting which has a linen finish, is the same on both sides and is liked for the same purpose and for separate skirts because it is light, cool and dust shedding.

SOCIALISTS OBJECT TO CZAR'S VISIT

Hold Great Mass Meetings in London to Formulate Protest

London, July 17.—A great mass meeting of the Socialist, labor and radical parties will be held tomorrow in Trafalgar square as a protest against the coming meeting between King Edward and the Russian Emperor, scheduled to take place during the Cowes regatta. James Kier Hardie, labor leader in parliament, will be one of the speakers. Mr. Hardie declares that the czar is so hated in this country that he dare not set foot on British soil. "He would be mobbed in the streets," said Mr. Hardie. "If he dared to appear in public."

The Socialist member of the house of commons, Victor Grayson, said: "I am glad that the Russian monarch, the emperor, will be six miles out of the danger zone when he comes to England. I would count it a disgrace to the traditions of this country to introduce that loathsome person into our life. If the Russian emperor must be allowed to live he must keep to his own shores."

On the other hand, there are other circles just as keenly interested in promoting friendship with Russia, and therefore determined to make all possible capital out of the first visit of the Russian monarch to England. They resent very bitterly the attacks being made on the czar and his system, and they are moving heaven and earth to get the government to prohibit the protest meeting.

But so far the government has no ground for interfering. The right of public meeting in Trafalgar square to discuss any subject short of sedition is firmly upheld, and no government dare abrogate it, more especially when it knows that the sympathies of the majority of its own party are on the side of the protest.
