GEOGRAPHIC SOCIETY VOTES GOLD MEDAL TO EXPLORER

Washington, Nov. 3.—Commander Peary was today voted gold medal by the National Geographic Society for having reached the North Pole. The board of managers of the society today accepted unanimously the report of the sub-committee, who had examined the explorer's records and proofs and found them corroborative of his claim that he reached the pole.

The society adopted a resolution that the question of whether or not any explorer had reached the North Pole prior to 1909 should be referred to a sub-committee of experts, with authority to send for papers or to make such journeys as might be necessary to inspect the original records. This indicates that the society proposes as soon as possible to pass upon the records of Dr. Cook.

It was also decided that a medal will be given to Captain A. Bartlett, who was declared by the society to have displayed "able seamanship, pertinacious effort and able management" during the Peary Arctic expedition.

TAMMANY REALLY DEFEATED ALTHOUGH CANDIDATE FOR MAYOR HAS BIG MAJORITY

New York, Nov. 3.—Complete returns for mayor show: Gaynor, 250,678; Bannard, 177,662; Hearst, 153,843. Gaynor's plurality, 73,016.

The forces of fusion will be in practical control of New York City's government after January 1st next. With the exception of mayor, the fusion sweep was complete, not another Democratic candidate on the city or county tickets winning success.

The fusion forces, by electing their candidates for the presidencies of all five boroughs, will give the opposition to Tammany thirteen out of the sixteen votes in the important board of estimates. This board will have in its hands during its term of office the expenditure of practically one billion dollars.

Charles F. Murphy, leader of Tammany, would not discuss today's report that, in view of the loss to Tammany of the board of estimates and apportionment, he would resign as Tammany's leader at the December meeting of the county and executive committees.

Later in the day, when pressed for a statement, Murphy entered a point blank denial.

"I have no intention of resigning," he declared.

BIG MAJORITY AGAINST HENEY FOR DISTRICT ATTORNEY

San Francisco, Nov. 3.—The election of P. H. McCarthy, Union labor, for mayor, by a plurality of about seven thousand, is conceded and the majority for Charles M. Fickert, for district attorney, over Francis J. Heney, may reach fifteen thousand. The Union labor party elected a majority of the board of supervisors, while the other offices are divided among the republicans, democratic and union labor parties.

KENTUCKY GOES STRONGLY DEMOCRATIC

Louisville, Ky., Nov. 3.—The dawn following election found a democratic party in possession of the legislature by over a two-third's majority. Sufficiently strong to pass any measure over the governor's veto. The new legislature will choose a United States Senator.

NEGROES MAY STILL VOTE IN MARYLAND

Baltimore, Nov. 3.—Returns are still far from complete, but it appears the proposed amendment to the state constitution disfranchising the negroes, has been defeated by from twelve to fourteen thousand. The Democrats claim the legislature.

FRANCE GROWS EXCITED OVER WOMAN'S FRAUD

Madame Steinheil Charged With Murdering Her Husband

Paris, Nov. 3.—Intense interest is exhibited in the case of Madame Adolphe Steinheil, whose trial for her life on the charge of the murder of her husband and mother-in-law, Madame Japy, commenced today. The alleged motive for the crime was hatred of her mother-in-law and a desire to rid herself of her husband that she might marry Maurice Liorde, a wealthy merchant, who became infatuated with her.

The latent attractiveness of the woman, combined with the mystery of her career, and her connections with persons high in public life in France, had fed popular imagination and led the public to believe that startling disclosures are imminent.

Only one hundred persons, whose business does not actually require their presence in court, were admitted to the trial. Places in the line commanded as high as two hundred dollars outside the court room door.

During the examination Madame Steinheil protested her innocence and declared repeatedly her original account to the effect that the crime was committed by three men dressed in long, flowing coats, with the assistance of a red haired woman, was true; that her subsequent statements were due to a "suggestion" from the police journalists and others.

MURDER BY WHOLESALE IS NOW SUSPECTED

Winnipeg, Man., Nov. 3.—What may prove a wholesale murder case has been discovered near Quill Lake yesterday, by the finding of the body of George Thoburn in the cellar of his farm house. The unconscious form of his son was also found, having been badly beaten, Mrs. Thoburn, her two year-old child and Mrs. Thoburn's mother are still missing.
