

OREGON FACULTY INVESTIGATING O. A. C. RIOT

The faculty of the University held a meeting late yesterday afternoon to consider the trouble at Corvallis Saturday, and appointed a committee who today have been making careful investigation of all charges and counter charges of the Oregon students and who will probably meet with a similar committee from Corvallis tomorrow to confer and arrange some understanding of the situation.

While many students here are not inclined to regard the fights that occurred after the O. A. C. game last week, notably the one at the depot, seriously, they regarded them only as the action of a few of the rougher college students who could not be controlled. The reports that have been sent from Corvallis during the past week in regard to the affair, showing practically everything and making gross counter charges, have caused a decided prejudice among the students and feeling has become more intense rather than showing any relaxation. The college paper that was issued today publishes interviews from eight of the most prominent upper classmen and the prevailing expression was that Oregon should sever relations with O. A. C. since this sort of affair has happened practically every time Oregon has played at Corvallis. It is the opinion that Oregon harms itself by being drawn into such affairs, and if they cannot be prevented, as A. C. almost admits they cannot, it seems necessary that athletic relations be severed. An editorial in the same paper suggests that hereafter the games be played in Portland where there is an ample police force. It is the gross denial that Corvallis now makes that have stirred up the sentiment here. The statement, backed by the Corvallis chief of police, that no blows were struck in the affair or any of the frays, but that the fighting consisted only of shoving, is ridiculous.

The Oregon students admit that blows were struck by themselves. In one instance at the depot three O. A. C. men found Harold Hall, a husky freshman from Baker City, standing practically alone with an arm band and a rooster's hat in evidence. They failed to realize that he was from eastern Oregon, and three of them were routed by three consecutive blows that probably left identification marks. The "rioting" on the street earlier in the evening consisted of individual fights. An Oregon man would be accosted by one of the Corvallis students and would endeavor to take advantage in their numbers by appropriating his colors. That student would invariably resent such proceedings, and a fist encounter would follow, which would be stopped by friends of both parties. No sooner had this stopped than somewhere else in the crowds that thronged the streets would another occurrence break out.

Oregon Rooters Not Guiltless
The University of Oregon does not deny that all of its rooters were guilty, nor maintains that many of them turned the other cheek. After having their colors snatched from behind or taken away by force, ill feeling prevailed and not only were blows struck by the Oregon men, but there were instances where those who had lost their lemon and yellow actually went into the fray to recover it or its equivalent in orange. The fact remains that the O. A. C. students began the rowdiness and maintained the aggressive part. They outnumbered the Oregon rooters and took advantage of this to tantalize them. It is possible and even probable that no one realized the extent to which the riot would reach, nevertheless Corvallis took the initiative. The trouble was started in a small way and gradually reached the proportions that were stopped by the serious injury of Harold Bean.

Warning Given
Still that this was premeditated by a certain class of O. A. C. students is admitted. An O. A. C. student, living in Springfield, and home the day before the game, made the statement to a Guard reporter that he was not only afraid of trouble but expected it, for there was a certain bunch that had declared their intentions of "starting something that would be remembered if O. A. C. was beaten." He also advised that any Oregon students arriving in Corvallis the night before the game keep as much out of sight as possible, for, he said, they did not intend to take any chances of Oregon students painting their colors on the college buildings, the way the O. A. C. students did at Eugene last year. If any Oregon student was seen on the campus that night, he would have his hair shaved and be thrown in the fountain. Such was the prevailing spirit that gave rise to the disgraceful student melee that followed the football game.

The fact that the Oregon students did not deny trouble was shown by the fact that when the O. A. C. rooters between the halves of the game led a goat past the Oregon bleachers with the big tantalizing sign, nearly fifty feet in length, "Oregon can't get our goat," that the Oregon men overlooked this challenge.

Attacked Co-eds
Several instances where the O. A. C. ruffians attacked unprotected Oregon co-eds have developed, although the latter hesitate to relate because of notoriety. In one case where a tally-ho lead of University girls was leaving the grounds several O. A. C. men endeavored to spit on the bunch that covered the carry-all, but actually spat upon the occupants. There have been a number of cases where arm bands and pennants were snatched from girls as they were leaving the game.

The affair of Saturday night might have been overlooked but for the attitude now assumed by the Corvallis college in framing up ridiculous defenses such as that the Bean boy fainted and made the statement that he was not hit, when actually he did not recover consciousness until nearly to Albany, and the malicious counter charges that have since been invented have formed a breach between the two colleges that cannot be easily mended.

W. T. BAILEY SELLS OVER 500 ACRES OF HIS TIMBER LAND

W. T. Bailey, ex-county commissioner, who lived for many years at Meadow, but who has made his home in Eugene for the past several years, has recently sold 525 acres of fine timber land near where he lived at Meadow, to a number of Eugene men, including L. H. and E. O. Potter, L. D. Forrest and F. W. Osburn. The price paid for this land was \$20,000. This timber lies about five miles below Meadow on both sides of the Siuslaw river and will be easily logged. Mr. Bailey has 452 acres of as fine timber left, and is now figuring with other purchasers for the sale of a part of it.

FIGURES ON TRIO OF BAY CITIES; OAKLAND IS CREDITED WITH 150,174

Washington, Nov. 17.—The population of Great Falls, Mont., is 13,958, as announced by the census bureau.

Oakland, Cal., has a population of 150,174; Berkeley, Cal., has 40,434, and Alameda has 23,383.

Oakland's increase is \$2,214, or 1.42 per cent. Berkeley's increase is \$2,420, or 2.06 per cent. Alameda's increase is 6919. Great Falls shows a decrease of 989.

ASSESSMENT ROLL OF LANE TOTALS \$36,500,000

Assessor B. F. Keeney informs the Guard that this year's assessment roll for Lane county will total approximately \$36,500,000, as compared with a total of \$22,096,920 last year. This increase is due largely to the increased value placed upon nearly all classes of property this year in an effort to assess it as near its cash value as possible, yet there have been many improvements in property and arrivals during the year, which helps to swell the total assessed value of the property within the borders of the county.

The board of equalization has finally completed its work after having considered 53 complaints. Of these, 35 were from people owning property in Eugene or immediate vicinity, three were from Coburg, four from Lorane, two from Junction City, and were made in some instances, but a number of these, Assessor Keeney says, would have been reduced by him had the property owners made their appearance before him while it was in his power to make the changes.

Among the large land holders who wanted their assessments reduced was the Southern Pacific company on its congressional lands in this county, but the board refused to make any changes in the assessment as placed by the assessor. These lands are divided into four classes, each assessed at \$5, \$10, \$15 and \$20 per acre respectively.

The state tax commission places the assessment on the company's roadbed and rolling stock as well as on the property of other public service corporations doing business throughout the state, and no report on that class of property has yet been made.

JOHNSTONE FALLS FROM AIRSHIP

Dashed to Pieces and Gathered Up by Crowd for Souvenirs

Denver, Nov. 17.—With one wing-tip of his machine crumpled like a piece of paper, Ralph Johnstone, the brilliant young aviator, holder of the world's altitude record, today dropped like a plummet from a height of 300 feet into the inclosure at Overland Park aviation field, and was instantly killed.

When the spectators crowded about the enclosure reached him his body lay beneath the engine of the biplane with the white planes that had failed him in his time of need, draped about it like a shroud, once too often, but he played the game to the end, fighting grimly to the last second to gain control of his broken machine. Fresh from his triumphs at Belmont Park, where he had broken the world's record for altitude with a flight of 9714 feet, Johnstone tried to give the spectators an extra thrill with his most daring feat, the spiral glide which had made the spright aviators famous.

As he started the second circle the middle spur which braces the left side of the lower plane gave way and the wing tips of both upper and lower planes folded up as though they had been hinged. For a second Johnstone attempted to right the plane by warping the other wing-tip.

Spectators Force Smash
Then the horrified spectators saw the plane swerve like a wounded bird and plunge straight toward the earth.

Johnstone was thrown from his seat as the nose of the plane swung downward. He caught on one side of the wire stays between the planes

NEW "WET" TOWNS "WET" AT ONCE
Attorney-General Holds Towns Voted "Wet" May License Saloons Immediately

Salem, Or., Nov. 17.—Attorney General Crawford has held in an opinion written yesterday that the city councils of towns that have voted "wet" in counties that went "dry" under the local option law at the election last week can license saloons by ordinance without another vote being taken on the matter. This is true, says the attorney general, for the reason that the new Home Rule amendment to the constitution will go into effect as soon as the returns of the election are canvassed and the governor's proclamation has been issued, while counties that have voted "dry" will not be dry until January first.

The law provides that the county courts shall make an order that no liquor shall be sold in a county where the official returns show that the people have so voted. This order cannot go into effect until January 1. For instance, in Wallowa county, the county court will order that no liquor be sold in that county on or after January 1. The governor will issue a proclamation, probably, before that time, declaring that the Home Rule has been enacted into law by the people. It will go into effect at once, allowing the city of Joseph, in Wallowa county, through its city council, to license saloons despite the vote making the county "dry."

Also the attorney general holds that it will be the duty of the county courts to redistrict the cities where election districts include part of the county and part of the incorporated city, so that on matters of local option the cities will vote in the general election independent of the voters who may be in the same election precincts as city voters.

COUNTY ROADS ARE GETTING SOFTER

Springfield, Nov. 18.—With only a few days of rain, the roads around Springfield have assumed their winter appearance and already some of them are deep with mud, except where work was done last summer or recently. The rural mail carriers are obliged to stay in their wagons several hours longer because of the slower progress. The road up the McKenzie has become quite soft in places between there and Springfield and the regular ruts have filled with water. The carrier on Springfield route No. 2 reports that the distance from Hendricks' bridge to the Watterville corner is in very bad shape. This carrier has been on the route for several years and declares that he knows every mud hole and rut on the road for they always are in the same place and do not seem to be repaired. This piece of road to Watterville is one that is much traveled and is not at all in good shape. The road on the other side of the river between Hendricks and Hayden bridges is in fairly good shape and the carrier on route No. 1 finds the roads up the Mohawk in fairly good condition. But this Mohawk road is always a good road in the winter because of the work that has been put on it.
