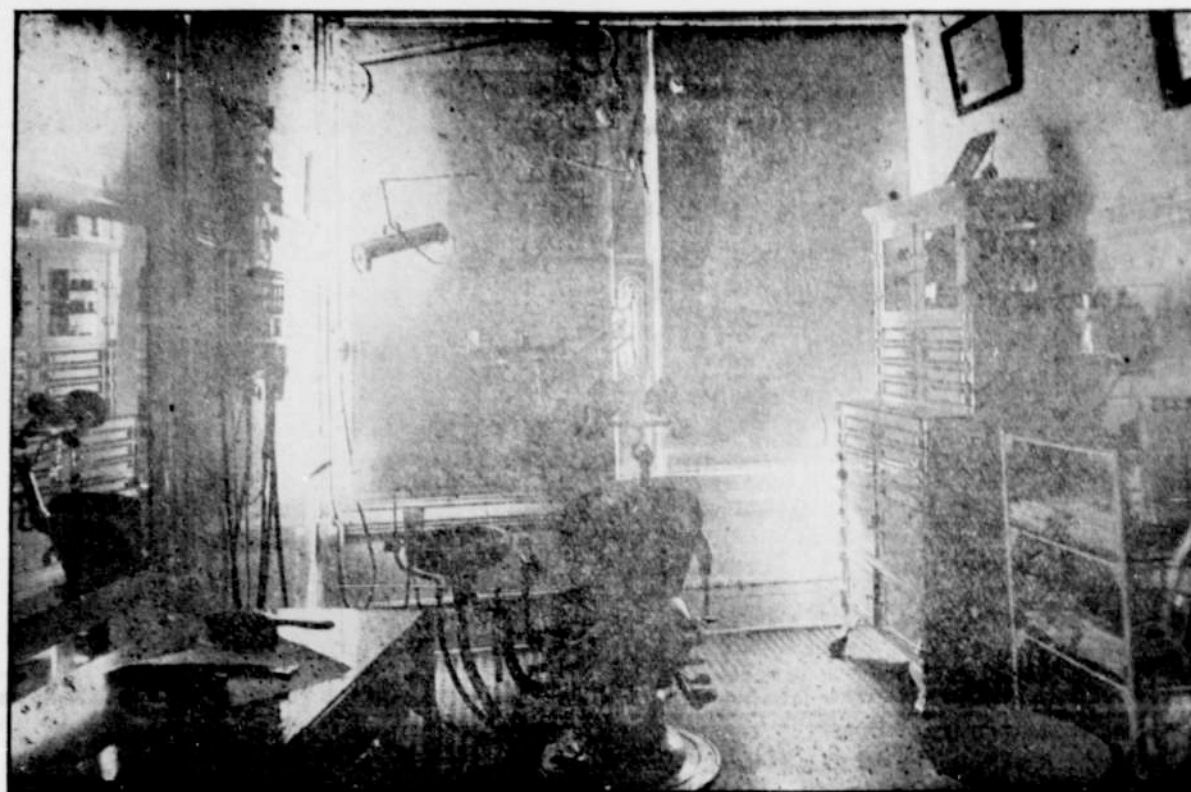

\$400,000 DEAL IN BOHEMIA MINING PROPERTY

Negotiations for the purchase of the interest of the Wheeler estate in the mines of the West Coast Mines Company in the Bohemia gold mining district formerly known as the Oregon Securities Mines, were closed here Thursday, and thereby a controlling interest in the Champion, Halena mine and other adjacent properties, the best equipped in the district, having a 30 stamp mill, an electric power plant, roads, tramways and buildings—came into the immediate control of Kelso, Wash., parties. It is the intention of the purchasers to inaugurate work at once at the Champion mine, preparator to starting the 30-stamp mill. They will expend approximately \$15,000 in development work and in making betterments.

W. P. Ely of Kelso, Washington, was very active in bringing about this big deal involving, it is said, something like \$400,000, and others interested in the deal are E. S. Collins, G. T. Hogg, of Kelso, Washington, F. A. Byerly, and G. L. Buland of Castle Rock, the same state. It is said a recent blast in one of the tunnels of the Champion mine revealed some very fine ore which is very encouraging to the new company. It is expected that the company will employ a considerable number of men, but the plans for operating have not been fully perfected.—Cottage Grove Leader.

SOUTHERN CALIFORNIA INDIAN DIES AT GOOD OLD AGE OF 115 YEARS

Los Angeles, Dec. 14.—Metowir, 115 years old, a member of the Kowakapi tribe, is dead at the home of his daughter, Mrs. C. A. Pachito, of Los Angeles. His funeral will be held under the rites of the Catholic church.

Metowir was born in 1795 on what is now the Meso Grande reservation, near San Diego. The aged Indian spent the last thirty years of his life at the home of his daughter. He was in excellent health until a week ago. One of the last acts of his life was to make a great Indian bow and a dozen arrows for his great-grandson, Philip Pachito, seven years of age.

RAILROADS ASK FOR MEDIATION

Chicago, Dec. 15.—Western railroads have appealed to United States Commissioner of Labor Charles P. Neill and to Chairman Martin Knapp, of the interstate commerce commission, to act as mediators in the wage controversy between the railroads and the Brotherhood of Locomotive Engineers.

This action on the part of the railroads operating south, west and north of Chicago follows the refusal of the engineers to accept an offer of 9 1/4 per cent increase over the old scale.

RECORD BREAKING CROWD AT ANNUAL POULTRY SHOW

Great crowds thronged the rooms where the annual show of the Lane County Poultry association is being held all day today, and the attendance promises to be a record-breaker. Secretary Keeney this afternoon said that he expects the association to come out considerably ahead on the show this year, judging from the attendance today. In former years the people of Eugene have seemed to lack interest in the shows and the association has barely broken even, one year going behind. But the large number of birds and their superior quality has evidently attracted the attention of the people and as a result hundreds have visited the exhibition.

GOVERNOR BALDWIN FAILS TO ATTEND

Man Roosevelt Attacked Declines to Accept Advances

New Haven, Conn., Dec. 14.—Colonel Roosevelt, as the guest of the chamber of commerce, made his first public address since the recent elections. He was cordially greeted by a gathering of 600 men, representative of the business and commercial interests and professions of the state. The banquet was of more than ordinary significance through the presence as a guest, of the man who was recently in controversy with Judge Baldwin, the governor-elect, who had also been invited to attend. Judge Baldwin was not present, and the place assigned to him

at the banquet table bore mute evidence of his absence.

At the beginning of his address, Colonel Roosevelt said he wished to propose two toasts. One was to the president and the other to the chief justice. After the toasts were drunk the colonel said he was glad to say here what he had said at many other gatherings.

He said during the last part of the last century the people were mostly concerned in the accumulation of wealth. Now the people had come to see they must concern themselves with the equal distribution of wealth. Continuing he said bodies like this chamber of commerce had been taught to regard Roosevelt as a modified anarchist. If they would take the trouble to read what he has said, and not what certain representatives of the press have said, it will be found he has preached only the doctrines on which the republic is founded. He said he is a radical, but a radical who desires to see the radical program carried out by conservatives. He declared the nation should regulate transportation and urged for the passing of legislation to benefit labor.

MONTANA MAN BUYS BIG RANCH NEAR DEERHORN FROM STOREY & LAVAKE

J. H. Steele Will Place Lot of Blooded Cattle on Place in the Near Future

The rapidity with which farm lands in Lane county advance in value is evidenced by the sale, just made, of a ranch consisting of 1,096 acres near Deerhorn, on the McKenzie, by J. O. Storey, president of the Portland, Eugene & Eastern railway, and T. A. Lavake, the latter recently from La Crosse, Wis., to J. H. Steele, a wealthy cattle owner of Montana. Three months ago Mr. Lavake, who is an old friend of Mr. Storey's, they being well acquainted with each other when they both lived at La Crosse, bought half interest in the place for \$20,000. His share of the proceeds of the sale just made is \$42,500, a profit of \$22,500 in that short time. The price received for the entire place was in the neighborhood of \$80,000.

Mr. Lavake is delighted with Eugene, and his part of Oregon, and he and his family are here to stay. Naturally he is well pleased with the profit made on this land in such a short time. In speaking of the sale today, he said he would like to have some of his friends in Wisconsin learn of the opportunities for investment in this state, and will do all he can to induce many of them to locate here, as there are many other just such opportunities for money making as this one of which he took advantage.

SHERIFF'S BONDS OF \$70,000 ARE APPROVED

The county officers who take their oath of office on January 1st are now busy getting their bonds ready and some of them have been filed with the county clerk, that of Sheriff Bown, who was elected to succeed himself, having been approved by the county court today. The sheriff is required to give a bond of \$10,000 as sheriff and \$60,000 as tax collector. His bonds this time were signed by representatives of the three banks of Eugene, and after duly inspecting them the court approved them without hesitation.

No action will be taken on the bonds of other officers who have filed them until Judge Thompson and Commissioner Price return from Cottage Grove, where they went this afternoon to look at a road near that city that needs improving. As soon as they return they will examine the bonds, and will doubtless approve them, as care has been taken to get the names of some of the solidest citizens of the county on them.

EDDY PROPERTY GOES TO CHURCH

Only Small Sums Are Left to Heirs of Christian Science Leader

purpose of more effectually promoting and extending the religion of Christian Science. Mrs. Mary Baker G. Eddy, in her will filed here today, makes the Mother Church of Boston her residuary legatee, after various other bequests are paid.

Among these is one of \$100,000 to the Christian Science board of directors to be held in trust for the purpose of providing free instruction for "indigent Christian Scientists."

Conservative estimates in advance of the official appraisal of the Eddy estate place its value at \$1,500,000.

Son Gets \$10,000.
In addition to previous gifts to her son, George W. Glover, of Lead, S. D., \$10,000 is bequeathed him in the will and the same sum is given each of his five children. Dr. E. J. Foster Eddy, her adopted son, gets \$50,000 and Calvin A. Frye, \$20,000. There are also several bequests from \$1000 to \$3000 each to relatives and to attendants of the Eddy household.

By codicils Mrs. Eddy directs that an indebtedness upon the church edifice of the Second Church of Christ, Scientist, New York, shall be cancelled from her estate and bequeaths her "Crown of Diaz," a diamond breast-pin, to Mrs. Augusta E. Stetson, of New York.
