A CONSISTENT REPUBLICAN. Senator Chandler of New Hampshire is one Republican who believes that his party should fulfill its pledges in behalf of silver. He addressed the senate the other day on the pending financial bill, designed to more firmly fix the gold standard on the country, and said in part:

The passage of the bill, without adequate recognition of the desire and determination of the American people that silver shall be re-monetized, is a defiance of the republican platform of 1896, and without such recognition in the bill I cannot give to it my vote. It would be unqualified gold monometallism, and to advocate or submit to this is the abandonment of republican principles.

Douglas county is gratifying. Lane county silver people are equally harmonious and enthusiastic. The Review says: The complete and harmonious union of the forces opposed to republicanism, as represented by the Hanna regime, effected in this county Saturday, is indeed gratifying to the true friends of reform. The attendance was large and all were enthusiastic and anxious to begin the real work of the campaign—a feeling that betokens victory at the polls.

Influenza, "the gripe," is prevalent throughout Germany, afflicting a very large percentage of the population. In Berlin there is hardly a family without a sufferer. It is said there is nothing new under the sun but the saying is not correct, at least so far as the gripe is concerned. It is only a few years since it made its initial appearance, spreading over the entire civilized world within a few months. It is not contagious, but seems to be epidemic in nature.

The siege of Mafeking is a case in point. The British garrison has kept tally on thirteen hundred projectiles that passed over or fell in the town, yet the number of persons killed or injured thereby number only about half a dozen.
