CONSTABLE FEES CUT DOWN.

Sheriff Withers has made a splendid showing. He has saved to the taxpayers thousands of dollars in the manner in which he has conducted his office. He has been a busy man from July 4, 1898, when he was sworn into office to hunt down the murderers of old John Linn until today. Think of it, he has personally arrested 40 men, of whom he executed 1 and took 15 to the penitentiary; then he hunted down such men as Pete McDonnell, who robbed the jewelry store at Junction.

Again, in tax matters he has made the best collector ever known. Locally he (Withers) has reduced the Eugene constable's office from a sinecure to a place not worth having, thus saving to the taxpayers of Lane county many dollars.
