WM. J. BRYAN ON TRUSTS.

In June North American Review.

"The trust question was in the campaign of 1896, and the menace of the trust was then pointed out, but the warning was unheeded. Now the heavy hand of monopoly is laid upon so many that there is a growing protest against a system which permits a few men to control each branch of industry, fix the rate of wages, the price of raw material and the price of the finished product.

"Until four years ago no Republican of prominence defended the trusts; now the Republican leaders speak of the trusts in guarded terms. The Ohio platform recently adopted demands that 'so-called trusts shall be regulated from time to time and so restricted as to guarantee immunity from hurtful monopoly.' The word 'hurtful' is as broad as charity, and enables the trust defender to shield every trust behind the plea that it is not hurtful. A monopoly is not hurtful to those who operate it, and if they can control the government they will be sure to decide that it is not hurtful to any one."

The Chinese may not be able to dominate the politics of the world, but when the five hundred millions of patient, industrious Chinese laborers are furnished with motive power and labor saving machinery they will be able to dominate the labor market of the world and fix the compensation to be paid to the toilers of all lands. China may not not be able to stand against the combined assault of the powers politically, but that the labor of China when properly utilized by the great captains of industry of America and Europe will become a controlling factor in the industrial world cannot be denied. The labor of the civilized nations of the world will read their doom in the industrial and commercial development of China.

The war on rats in Astoria is being vigorously waged. The News says the receipt of rats at the police station is good, and since the first bounty ordinance went into effect Chief Hallock has paid for over 2000 plague breeding pests. The boys get ten cents for each rat caught, five cents being paid by the

city and the other five cents out of a fund provided by Dr. August Kinney. All day long the lads come to the station with rats, and some East Astoria boys are averaging about 75 cents daily.

The Dalles Times-Mountaineer: "There was a stronger sentiment for woman suffrage than most people thought prior to the recent election. The equal suffrage amendment was beaten only 2137 out of a total vote of 54,667. This indicates that a very large minority of the men of Oregon are chivalrous and willing to give the women equal rights with them at the polls."

Out of 12,000 bicycles in Portland only about one-half have paid the tax. The seizure of an unlicensed wheel by a collector usually creates a scene on the street approaching a Chinese Boxer uprising. The officer gets no sympathy from the crowd in the performance of his duty.

Every female teacher in the Portland public schools is compelled to sign a statement that she is not married, nor expects to be during the year for which she is engaged by the school board. Of course accidents may happen.

Lebanon, Oregon, makes the saloons pay most of the city expenses. For a time the single saloon of the town paid \$700 license. A second one commencing business the license was reduced to \$500.

The general public lost interest in the Sharkey-Rublin prize fight when it became apparent that neither of the contestants was injured sufficiently to preclude him from again entering the ring.

The Canadian house of commons has passed a bill raising the Chinese poll tax from \$50 to \$100. The American congress would render good service by passing a similar law.

The death of a juror occurred during the trial of a criminal case at Portland yesterday. The case came to a sudden close and the jury was discharged.

Strawberry Fishing in Chile.

A singular custom prevails in Chile which in these days of aseptic precautions will cause a shudder among those who see infection lurking in every detail of life. It is called strawberry fishing and is conducted in this fashion:

At the close of a dinner the cloth is removed, and there is placed upon the table an immense bowl into which are emptied half a dozen bottles of Bordeaux wine, four of cherry and two of rum, besides sugar and nutmeg. Into this mixture is put a very large strawberry, which floats upon the surface. The bowl is provided with two handles. These are used to lift the vessel and tilt it so that the strawberry may be brought near the edge and sucked into the mouth. This would appear an easy feat, but it is a difficult one, as the fruit rolls over when touched with the lips. The contestant in the effort swallows a considerable quantity of the liquid concoction.

This is the reason for the game, for the bowl is passed from one to the other many times in succession before the strawberry is captured. When that moment finally arrives, all of the guests have reached a ripe stage of hilarity. This is the game as it is played among the higher classes. Among those of a lower social standing the fiery liquor of the country is substituted for wine. With them strawberry fishing develops into a function compared to what a fighting mixed ale party in this town is the recreation of a group of peace seeking Quakers. —New York Sun.

Lincoln's Coolness.

Thomas F. Prendle, for 35 years a doorman at the executive mansion, used frequently to accompany President Lincoln on his walks about town and has many interesting things to tell of that great man, whom he believes to have been one of the bravest men the world has ever known.

On one occasion Prendle was walking with the president down a flight of steps at the navy department when they came suddenly upon a man who was evidently endeavoring to hide himself in a dark corner at the bottom of the staircase. Observing the stranger and fearing he meant harm to the president, Prendle essayed to place his body in a position to protect his companion.

Mr. Lincoln, however, brave and fearless as always, stepped forward and closely scrutinized the man, who ran rapidly up the steps and, turning squarely around when he reached the top, looked down upon the president, who did not falter, but continued to gaze sharply at him. On their return to the White House Mr. Lincoln said quite calmly, "Prendle, do you know I received a letter last night warning me against a man who exactly answered the description of that man we met on the steps?" —Leslie's Weekly.

Cedars Twenty Centuries Old.

Some cedars are undoubtedly more than 2,000 years old, for, though on good moraine soil they grow about as fast as oaks, on bare pavements and smoothly glaciated overworn granite ridges in the dome region they grow extremely slow.

One on the Starr King ridge, only 2 feet 11 inches in diameter, was 1,140 years old. Another on the same ridge, only 1 foot 7 1/2 inches in diameter, had reached the age of 834 years. The first 15 inches from the bark of a medium sized tree—6 feet in diameter—on the north Tennyson pavement had 850 layers of wood, or 57 to the inch. Beyond this the count was stopped by dry rot and overgrown wounds.

The largest I examined was 33 feet in girth, or nearly 10 feet in diameter, and, though I failed to get anything like a complete count, I learned enough from this and many other specimens to convince me that most of the trees 8 to 10 feet thick, standing on polished granite pavements, are more than 20 centuries of age rather than less. Barring accidents, for all I can see, they would live forever. When killed, they waste out of existence about as slowly as granite. —John Muir in Atlantic.
