It is announced that Hon C W Fulton has declined to again serve as president of the State Senate, owing to his candidacy for the U S Senate. Senator Brownell, of Clackamas, Senator A C Smith, of Multnomah, and Senator Booth, of Lane, are said to be the most prominent candidates for that position.

Southern California has been recently severely shocked by earthquakes. Volcanic disturbances are remarkably frequent this year and at least one of the most disturbing eruptions of history has been recorded. Contrary to general belief the Indian War Veterans' bill applies only to veterans and their widows, and not to children. According to the Crop Reporter published by authority of the Secretary of Agriculture, the total acreage of sugar beets this year is 280,000, divided among 11 states. Michigan leads, with 98,000 acres; California is second with 71,284 acres, Colorado third with 39,449; these three states having four-fifths of the total area devoted to sugar beet raising, which is insignificant when compared with that devoted to any other common crop.
