The leaps and bounds of the Pacific coast lumber business is fitly shown by comparative statements of shipments, foreign, coastwise and rail for 1900 and 1905. In 1900 it totalled 984,000,000 feet. Five years later, 1905, it had grown fourfold to 3,759,000,000 feet.

Secretary of State Root says Hamilton is a "liar." That insurance investigation is stirring things up near headquarters. The secretary probably felt somewhat kinder to Mr. Hamilton about the time he handed over that \$75,000 of New York Life Insurance Company funds for the presidential campaign. The extent of the Northern lumber trade with Southern California, Nevada, Utah, Arizona, New Mexico and Mexico, is shown by a letter to the Tacoma Lumberman from its Los Angeles correspondent, under date March 3. There were then thirty-nine cargoes unloading at its single port, with twenty-six scheduled on the way down. The railroads distribute it. Common 12-inch fir boards bring \$20 dollars a thousand at Los Angeles.

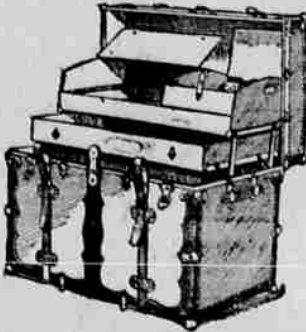
