MORE SUNSHINE, HIGHER TEMPERATURE

Weather Conditions in Oregon Have
Better During Past Week Than
Heretofore.

From the regular weather bulletin issued by the Portland office of the weather bureau for the week ending Monday June 25:

GENERAL SUMMARY.

The rainfall during the week was very light, and ample sunshine prevailed, which caused much higher temperatures during the afternoons. The nights, however, continued cool and on Friday morning light frosts occurred in a number of exposed localities in the eastern and southern portions of the state. In the Willamette valley Sunday was the warmest day of the season, and temperatures of ninety degrees or more were general. In the coast counties foggy nights were common, which were usually followed by clear afternoons. East of the Cascade mountains the temperatures, although higher than the previous week, were slightly below the seasonal average. The prevailing winds were northwesterly and generally light, although on one or two days they were disagreeably high, without being in any way destructive.

WILLAMETTE VALLEY.

Portland, Multnomah county.—The week was dry, sunshiny, and much warmer, especially during the afternoons. No rain fell, except a few small sprinkles on Tuesday and Wednesday mornings. Sunday was the warmest day of the season, with a maximum temperature of ninety-two degrees. The prevailing winds were northerly and light in force.

Forest Grove, Washington county.—Early in the week the weather was cool, but gradually grew warmer toward the close.

Corvallis, Benton county.—Warm and clear weather prevailed, except on Thursday, when the sky was partially overcast and rain occurred.

Eugene, Lane county.—The week was generally warm with cool nights. On Sunday the thermometer reached 90 degrees.

HOLY ROLLERS THINK CREFIELD IS ALIVE

Seattle, June 25.—Yesterday Mrs. Maude Hart Crefield, widow of the Holy Roller leader, said that she believed her husband will appear in court before the trial of George Mitchell, his slayer, is ended. Mrs. Crefield asserts that her husband has already risen from the dead, and insists that the dead Holy Roller was the apostle of God.

She says that since her husband rose from the grave he has been in Oregon visiting his followers and getting them together to come to Seattle to testify that her husband was a true religious worker and never did any one any wrong. The letters that the woman has received from the followers of Crefield in Oregon, contain assertions by the faithful that Crefield has already risen from the dead. Mrs. Crefield's closest confidant is Esther Mitchell, the sister of the accused man. She has been in the custody of the police matron as a witness. She will testify against her brother. She also declares that Crefield is alive and will be in court. She assured Prosecuting Attorney McIntosh yesterday that she would testify that Crefield did her no wrong. She says that her brother never did her any kindness, and that she wants to see him punished to shooting down Crefield.

General News Notes

Mrs. Ledoux has been found guilty of the murder of her husband at Stockton and will be sentenced to hang. The remains of the murdered man were found at the baggage room of the railroad station packed in a trunk, and most of the evidence at the trial was circumstantial.

At Poughkeepsie, N. Y., Cornell University won the annual intercollegiate rowing race Saturday. The race was rowed between showers and slow time was made.

At Sheephead Bay Saturday Jan. B. Brady's Accountant won the \$30,000 Tidal stakes, mile and a quarter, in 2:10.

Robert S. Eakin, supreme judge-elect of Oregon, will not take his seat as successor of Justice Bailey on the bench until January 1. This is in accordance with a law passed by the last legislature making the terms of the supreme judges begin in January. Eakin's term as circuit judge expires in July, 1908, so in January Governor Chamberlain will have the appointment of a circuit judge to fill the remainder of Eakin's term.

To save his heart taken out and particles of sand washed from it as it

beat and still survive has been the experience of O. A. McCartney, a Pasadena, California, contractor. While riding a motor cycle he came in contact with a hay wagon and a wooden rake prong pierced his breast. The surgeons found that particles of sand from the road had been driven in the wound as far as the heart. They took that organ out, washed it thoroughly and then replaced it. Other internal injuries were attended to, the cavity in the body sewn up, and the indications are that McCartney will recover.
