Lumber Demand Better

The San Francisco fire was not required to make the lumber market active—it was good before. Here are some figures that show what the country is doing in that line:

In January, February, March and April the Northern Pacific railroad shipped 18,497 carloads against 22,108 in both 1906 and 1907. The Great Northern 6839, against 7391. The Canadian Pacific 1143 against 1599. In all by the three railroads 26,939 carloads in those months of 1906 against 31,038 during the corresponding months of both 1907 and 1908.

From Portland 3096 carloads were shipped, against 4238 in the previous two years.

Some Values of Irrigation

Bagebrush land in Baker county practically worthless before water was put on it, is now bringing \$30 to \$75 an acre with water rights.

Travelers over the McKenzie road for years have seen an instance of what water does. Pitching rapidly down after leaving the summit of the Cascades in a few miles one reaches the level, elevated Eastern Oregon plateau, and a desolate land it is, volcanic and scrubby pine. But put water on it and see the transformation! Squaw creek and Tumalo creek, rushing swiftly away from the snow fields of the Three Sisters to join the Deschutes, have had their waters put on the seemingly barren, worthless land, and then it blossoms as the rose—the change looks little short of miraculous so valueless does the land appear.

Kansas and Oregon are alike in more ways than in the absence of beverages brewed by John Barleycorn. The Sunflower state, through Governor Hoch, issues a piteous appeal for laborers to assist in saving the great crops of grain and corn now reaching maturity on its fertile farms. Eight thousand harvest hands are wanted at once and the supply is not in sight. Oregon, too, wants men to harvest the crops, work in sawmills and logging camps, and build the new line of rail road that are to develop latent resources and open up new territory to settlement. It is easy to tell what's the matter with Kansas just now, and Oregon is in a position to sympathize with her.

The population of the islands constituting Japan proper is 47,812,027, and that of the island of Formosa 3,069,235. Japan comprises 100 main islands and nearly 500 small islands, making the name of the "Island Empire" peculiarly appropriate. The total area of these islands is about 161,000 square miles. It is noted that there is a close approximation to equality in the division of the population between the two sexes.

It has been decided that the costly city hall at San Francisco is a total wreck and will have to be torn down. The Hall of Justice is also condemned.

It has finally been settled that twenty-seven persons met death in the Suisun, England, train wreck Sunday. Those Englishmen are waking up—getting American methods over there.

The anti-pass provision in the railroad rate bill as passed by congress prohibits broadly and generally any free transportation for interstate passage. The exempted class includes employees of railroads and their families, railroad officers, agents and surgeons and attorneys employed by railroads, inmates of hospitals and charitable institutions, and persons exclusively engaged in charitable work, disabled sailors and soldiers, caretakers of livestock, poultry and fruit, employees on sleeping and express cars and linemen for telegraph companies, postal, customs and immigrant inspectors, witnesses attending in estate commerce hearings and physicians and nurses attending persons injured in wrecks.

Oregon politicians had an unnecessary scare. The anti-pass measure has been declared ineffectual because the enacting clause was omitted by W. S. U'Ren, the supreme source of Oregon law.

Pendleton does not have prohibition, still four saloons were closed there the past month. Hard times, at least the supply greater than the demand.

Excursion to Yellowstone

At 7 a. m. Saturday, July 7th, the Oregonian Yellowstone Park special train carrying the thirty-eight prize winners in the Oregonian voting contest will leave Portland. The special will be run from Portland to Salt Lake City, where sufficient time will be allowed to permit passengers to see the sights of Utah's capital before the journey to the Yellowstone is continued. After spending about a week in the park the return trip to Portland, including side trip to Boise City, will be commenced. The true, big play makes appeal to the PLUSH HEARTS DOWNSTAIRS and to the UNUPHOLSTERED HEARTS UPSTAIRS.

I have heard people who have been to a TRAGEDY say that they were not AMUSED and others who have gone to a COMEDY and have complained that it was not SERIOUS.

The theater has been the great popular place of amusement for ages, and it has an enormous power. Think of the opportunity it has for TEACHING TRUTHS, PATRIOTISM AND VIRTUE. The theater husbands our ideals and gives to life that touch of romance that we all love.

In the plays of today you pay your money and take your choice, unless you are a deadhead and a DEADHEAD HAS NO POINT OF VIEW. I only know of one honest deadhead. He sat through two acts of a very bad play and then WENT OUT AND BOUGHT A TICKET SO THAT HE COULD HOOT WITH THE OTHERS.

THE DEADHEAD IS THE STOMACH PUMP OF A PLAY WHICH HAS POISONED THE PUBLIC.

The public is making the demand upon us: "Give us our own life. WE HAVE HAD ALL THE LORDS AND LADIES WE WANT. Show us our own social predicaments, not those of England nor the social triangle of France."

France has played us every tune until the husband and the wife have become a social barrel organ. We have troubles of our own, say these audiences. Give us these, and we will whistle you into popularity.

In modern plays I feel the value of REFLECTING THE LIFE AND ENVIRONMENT of those about me—their emotions, play, idleness and business. Even a good play can be written false to life.

The great play appeals to the heart and mind. Shakespeare did this. Some eclectic audiences demand literature in the drama and stay away from the theater. More DRAMATISTS write plays that have VALUE AS LITERATURE than do LITERARY MEN who write plays that are GOOD DRAMAS.

TECHNIQUE WILL NEVER KEEP A PLAY ALIVE—IT MUST BE A HUMAN DOCUMENT. THE AMERICAN PUBLIC DEMANDS A REFLECTION OF AMERICAN LIFE.

ART IS A POOR, BEDRAGGLED WORD, almost taking on the use of the word "lady." It has become the boarding house keeper of our vocabulary who has seen better days.

The EVERYDAY INCIDENTS of life in the big cities ARE MORE MELODRAMATIC than anything seen on the stage. I cannot live there twenty-four hours without seeing dramas of sorrow and gladness of every shade.

A CRY TO ARMS

By Henry Timrod



THIS stirring appeal for aid to the cause of the Southern Confederacy came with many other voices of southern hope and aspiration, from the pen of Henry Timrod, whose untimely death in 1857, at the age of thirty-eight, is still lamented by the critics who see in his work the unfulfilled promise of high poetical achievement. "If he is to be called a poet of promise rather than performance," says one authority, "it is only in view of the poor opportunity he had and in the conviction that had fortune been more kindly he would have richly repaid her in what he gave the world."

Ho! woodmen of the mountain side!
 Ho! dwellers in the vale!
 Ho! ye, that by the whanging tide
 Have roughened in the gale!
 Leave burn and byre, leave kin and cot,
 Lay by the bloodless spade;
 Let desk and case, and counters rot,
 And burn your books of trade!

The foeman roves your fairest lands
 And till he flies or fears,
 Your fields must grow but armed hands—
 Your sheaves be sheaves of spears!
 Give up to molder and to rust
 The useless tools of gain—
 And feed your country's sacred dust
 With floods of crimson rain!

Come with the weapons at your call—
 With market, pike or knife—
 He wields the deadliest blade of all
 Who lightest holds his life.
 The arm that drives its unthought blows,
 With all a patriot's scorn,

Might brain a tyrant with a rose,
 Or stab him with a thorn!
 Does any falter? Let him turn
 To some brave maiden's eyes,
 And catch the holy fire that burns
 In those sublimed skies.
 Oh! could you like your women feel,
 And in their spirit march,
 A day might see your lines of steel
 Beneath the victor's arch!

What hope, O God! would not grow warm
 When thoughts like these give cheer?
 The life's exulting leaves the storm—
 And shall the palm tree fear?
 Not rather let its branches court
 The blast that sweeps the plain;
 And from the life's royal port
 Learn how to breast the rain.
