A NUMBER OF CANDIDATES FOR POSTMASTERSHIP

Will G. Gilstrap and E. R. Mummy Said to Be Out for the Appointment and J. L. Page is a Candidate to Succeed Himself - Office Pays \$2500 a Year.

Postmaster J. L. Page's term of appointment as postmaster of Eugene expires next April and already there has been considerable talk as to his probable successor. It is said that Mr. Page will be a candidate for reappointment and there are two other avowed candidates for the position not to mention the several dark horses who would like the job and whose names may be sprung later.

Will G. Gilstrap, who, by the way, has again assumed the editorship of the Register, is said to be after the job, with the endorsement of the old Mitchell faction of the Republican party. He is known to have had his wires laid for some time past, ever since he concluded not to run for sheriff, realizing that he would have a hard time defeating Fred Plak.

Another candidate mentioned is E. R. Mummy, chairman of the Republican county central committee, and who conducted the Republican campaign in the county this spring to the apparent satisfaction of his friends and the party in general. He will rely on this record and on his past work for the party as an endorsement for the position.

While these two men are working for the place, Jim Page is not going to let any grass grow under his feet. Everybody concedes that he has served the people well in the capacity of postmaster and has conducted the office in a business-like manner. It is said he has very strong support and his friends are confident of his reappointment.

The Eugene office now pays \$2500 a year, a raise of \$100 a year having recently been announced by the department at Washington.

PROFESSOR M'KEE GIVEN THREE POSITIONS

Popular Eugene Educator Elected Superintendent of Oregon City Schools, Offered Two Other Positions.

Oregon City correspondence in Portland Journal: Professor Walton C. McKee, who was elected to the superintendency of the Oregon City schools, is a comparatively young man and for the past two years has been principal of the Eugene high school, to which position he was re-elected this year at an increased salary. Mr. McKee was also elected superintendent of the schools at Port Townsend, Washington, and of the three positions he has concluded to accept the superintendency here.

The new superintendent was graduated from the Oregon State Normal school in 1880 and in 1881 was graduated from the scientific class in Saniam academy. He was teacher of history and literature for the two following years. In 1895 he was in the student department of education at the University of California. For three years he was superintendent of the Vallejo, Cal., public schools, where fourteen teachers are employed. Mr. McKee went to the Philippines at the outbreak of the Spanish war, where he was a member of the Field Hospital corps, and was assigned a position in the department of public education, where he worked as a teacher and organizer and principal for sixteen months. After his return to the United States he went to Lebanon, Lin county, and was principal of the schools there for four years. He went to Eugene from Lebanon.

CATHOLICS MAY EAT MEAT NEXT FRIDAY

Notification of the edict has been received in Portland by Archbishop Christie from Apostolic Delegate Mgr. Falconio, at Washington. The priests at the cathedral say that the edict is an unusual one. The day of the feast of Saints Peter and Paul will probably not fall on Friday again for many years.—Journal.

APPLICATION FOR FRANCHISE IN SPRINGFIELD

Willamette Valley Company Wants to Enter the Town from the North by Second Street - Application Now in Hands of Members of City Council

Word comes from Springfield today that the Willamette Valley Co. has made application to the council of that city for a franchise for the construction and operation of an electric railway on Second street, leading from the northern limits of the city. A copy of the proposed ordinance granting the franchise is now in the hands of the members of the council and it will be taken up for consideration within a few days.

By this move it is evidently the intention of the company, in case no franchise can be secured in Eugene, to go around this city and make Springfield the southern terminus of the valley line.

DAN KELLY THE GREATEST ATHLETE LIVING

So Says Bill Hayward, His Trainer. Hayward Toasted at Spokane After the Field Meet as the Greatest Trainer and Developer of Athletes in the Country.

"Big Bill Hayward—the greatest trainer in the country, and the developer of the greatest athletes the Pacific coast has ever known."

This toast, given at the banquet tendered Saturday night by the members of the Spokane Athletic Club in honor of the visiting athletes at the great track meet held there that day, brought a hundred men to their feet, cheering enthusiastically, says the Portland Telegram. Perhaps there never was such an ovation given to a trainer. Certainly there never has been in the Northwest.

The team of stars that Hayward took with him to Spokane as representatives of the Multnomah Athletic Club was not only the greatest collection of athletes that ever ran a track in the Northwest, but it numbered men who that day equalled and broke records as though they were nothing. Hug, Kelly, McKinney are all the product of Hayward's training.

It was a great meet, according to the members of the team, who reached Portland this morning, tired but happy. Best of all every member of the team was glad, not because he had made such a splendid showing, but because he had done it for the honor of the Multnomah Club. It was the old club spirit that won the meet.

KELLY GREATEST LIVING ATHLETE.

"As for Dan Kelly—he's the greatest athlete living today," said Hayward. "No living athlete equalled his performance that day. Think of doing the 100 yards in 9.3-5, then making three broad jumps, none under 23 feet, and the highest at 23 feet 9 inches, and running the 220 in 21.1-5, tying the world's amateur record. The track began with a turn, the most trying situation one could imagine. The record was made on a straightaway. Kelly, had he been pressed, could have made it in 21.1 I have not the slightest doubt."
