Eugene will have to get a move on if she is the first town in Western Oregon to pave streets. The following is from the Albany Herald: "Initial steps were taken last night at the meeting of the city council toward the paving of First street, when on motion the city attorney was instructed to prepare an ordinance providing for paving First street from the west line of Ferry street to the east line of Washington street, and also Ferry, Broad and Ellsworth streets from First street to Second street. The matter of paving Albany's thoroughfares has been discussed by the council from time to time, but no definite action has ever been taken until last night, when the subject was again brought up by Mayor Wallace in his annual message."

Judge Landis, of the United States district court, sitting in Chicago, has rendered himself ineligible for a place on the Standard Oil Company's list of "good judges" by handing down an adverse decision in the attempt to quash the indictments found against the Standard for violating the law. No wonder his illness says "life is only a series of trials."

Not a few of the trusts would welcome a return to the good old times when investigations were only made by friends, all of whom could be counted on in advance to turn out an artistic job of whitewashing while they waited.

Governor Hughes said in his inaugural address: "We are a government of laws and not of men," which is true, but the best laws are no good unless the men charged with their enforcement have the will and the nerve to do their duty.

POSSIBLY A STEAMER ON UPPER RIVER

THEIR HEARING IS RESTORED IN THREE MINUTES

Portland Market Report.

Portland, Jan. 9.—The Oregon Onion Growers' Association, which several months ago fixed a minimum price of 85 cents for its product, stands in a good way of realizing its hopes before the season ends.

The San Francisco market has lately been advancing steadily and has now reached a point where shippers can operate with profit in Oregon onions at the combine price.

A considerable movement is already under way and it would be larger if transportation facilities were better. The car shortage, however, restricts business.

Quite an amount was sent south on the last steamer, and what space is available on the boats to follow will be taken for this purpose.

The association recently sold four carloads for February delivery and dealers are offering for future delivery above the price fixed by the combine.

Hop Market.

The hop market was quiet yesterday, with no important transactions reported. A few small lots were bought by small dealers at 8 to 11 cents. A considerable amount of this kind of "bargain" business has been going on since New Year's, and it is said that many more of the low grade hops could be sold if the growers would take up the offered prices.

There is only a moderate inquiry for choice varieties and the best selections are held above the market. A feature of the late trading in the East has also been the buying of the poorer grades.

The government's figures for November, just received, show a production of 4,174,221 barrels of beer, against 3,786,267 barrels in November, 1905, or an increase of 287,954 barrels.
