SOFT DRINK PLACES WILL BE CLOSED UP

Under the Ordinance Just Passed
by the Council It Will Be Next
to Impossible to Sell Liquor.
Officers Are Compelled to Search
Suspected Places

Mayor Williams has not yet signed the ordinance passed Monday night regulating the places where intoxicating liquors are sold, but it will go into effect within ten days after its passage if the mayor does not sign it at all. This measure, it is thought, will effectually do away with liquor selling if it is possible to do so entirely. It provides that it shall be the duty of the officers to search all places where it is suspected that liquor is being sold, and if any is found the liquor itself shall be sufficient evidence that the traffic is going on.

Chief of Police Farrington informs the Guard that several proprietors of "soft drink" places have told him that they will close up just as soon as the ordinance goes into effect, as it will be no use trying to evade the local option law any longer under the new measure passed by the council. Others declare that they will continue to do business and trust to luck or good fortune to keep them out of the clutches of the law.

KIDNAPS A MANIAC

Woman Rescues Demented Husband From Middletown Insane Asylum.

TAKES HIM ACROSS THE SEAS

Emil Martini, Crazy Painter, Is Heir to a Fortune in Germany, and Wife Carries Him Over There to Get It.

Emil Martini, an insane inmate of the state hospital at Middletown, N. Y., was kidnapped in a sensational manner and is now believed to be in Germany to claim a fortune left him by a relative.

Martini had been confined in the state hospital for six months, being afflicted with general paresis. He had been a well known painter and decorator. On pleasant days it is the custom of the hospital attendants to take the least violent patients for a walk around the grounds. One of the walks runs along the public highway, separated only by a fence. For several days a woman had been seen loitering near this spot, and one day as a group of patients, among whom was Martini, reached the spot near the highway a closed carriage dashed up.

A woman sprang out and beckoned to Martini, who leaped away from his attendant, David Everett, climbed the stone wall and was helped into the carriage by the woman. The driver whipped up the horses and drove rapidly away. The other patients became so excited that the attendant could not report the escape for some time.

When an effort was made to locate Martini it was learned that he and the woman had taken a train for New York and were supposed to have boarded a steamer the next morning for Germany.

It is said that Martini was recently left a fortune by a relative in Germany and that his presence was necessary to secure it. The woman who took him away is believed to have been his wife.

When search was made for Mrs. Martini she could not be found, and

her home in New York city was closed. Later it was learned that she had sought legal advice as to how to get her husband out of the state hospital. Her attorney advised her to institute habeas corpus proceedings, as she claimed he was not insane.

She is understood to have instructed

her lawyer to commence proceedings, but when the latter looked into the matter he found that Martini was insane beyond a doubt and that habeas corpus proceedings would fail to free him. When told this Mrs. Martini seemed in despair and went to Superintendent M. C. Ashley of the hospital. The latter is said to have told her that her husband was in a dangerous condition, but that she could take him away if she would be responsible for his actions while at liberty. For some reason Mrs. Martini refused to do this, although she is believed later to have adopted the desperate means of abducting him.

Martini was popular in New York city. His mental derangement first showed itself in a form of kleptomania. He would enter stores and pick up anything in sight and take it home.
