**ROBBERY OF
HARDWARE STORE
AT JUNCTION**

Three Men Discovered at Their Work by Flint Baker, Night Clerk at Hotel, Who Captured One of Them, But Couldn't Hold Him Till Officers Arrived

J. H. Miller's hardware store at Junction City was broken into by three men last night and robbed of about a dozen safety razors and a few knives. One of the burglars was captured by Flint Baker, night clerk at the Junction City Hotel, but succeeded in making his escape before an officer arrived. Sheriff Fisk received the particulars of the burglary by telephone this morning, and at once began to work on the case, but so far has no trace of the burglars.

Young Baker, upon going into the street for some purpose, saw a man in the doorway of the hardware store and as he acted in a suspicious manner, drew closer to see what he was doing there. Before he reached the store the man began to run and took down an alley. Just then two other men came out of the store and also ran.

Makes Daring Capture.

Baker went back to the hotel and got his pistol and went down the alley in the direction which the robbers took. He suddenly met one of them face to face and ordered him to throw up his hands, which he did. He then marched him to the hotel office and began to telephone for the marshal and the robber, seeing that Baker was not an officer, attempted to seape through the rear door of the office. Baker stopped him, but the robber then made for the front door and after a struggle succeeded in escaping from his captor. Baker threatened to shoot the fellow several times, but the threats had no effect, as he seemed to think the gun was not loaded or Baker did not have the nerve to shoot. After the robber's escape Baker fired three shots at him, but missed his mark, and the robber disappeared in the darkness.

Working on Safe.

An investigation of the robbery showed that a panel in the front door of the store had been broken open, the robbers effecting their entrance that way. The razors and knives were all the goods that were missing, although the safe would have been broken open had they not been interrupted, as they were working on it at the time of discovery. The fellow that Baker caught was young and heavy set, and he could easily identify him if caught again.

**LEVINSON'S
ADDRESS AT
UNIVERSITY**

The university assembly was addressed this morning by N. J. Levinson, Sunday editor and ex-city editor of the Oregonian, on "The Practical Day's Work in the Modern Daily Newspaper."

The speaker took up every side of the gathering of the news which is daily dealt out to the world, beginning with the famous Associated Press service, of which the Guard is a member. The Associated Press, he said, has a representative in every county seat of the United States with scarcely an exception. It has connections with the Canadian newspapers, and keeps special representatives and correspondents in Washington and the chief capitals of the world, besides having its service extend to Australia and two or three other countries.

He then took up newspaper work as a profession.

Mr. Levinson, who is an interesting talker, among his remarks on this side of newspaper work, said that newspaper work, while very attractive from some standpoints, did not receive the same remuneration that the same amount of brains would secure in other fields.

Miss Eve Stinson sang a beautiful solo, before the address, entitled "A Japanese Lady."
