THE CITY CAMPAIGN

There are now two strong tickets in the field for the city offices. J. D. Matlock and F. W. Osburn are both well-known men of high standing, but supposed to represent different views as to the conduct of municipal affairs. The former is outspoken in favor of municipal ownership of public utilities and the latter is understood to stand in opposition to that principle, or at least to hold more conservative views on the subject.

The Guard trusts that the campaign, no matter how strenuously it may be waged, will be conducted quietly and cleanly outside of the newspapers. If so, fewer scars will be left when the contest is over and the opposing factions will sooner be able to get together and unite in all movements that will contribute to the city's growth and welfare. So far as this paper is concerned in advising a campaign outside of the newspapers it is not afraid to express its convictions or desires of shirking a plain duty, but it is convinced that Eugene has already had more than its share of undesirable advertising resultant upon the defects of its water supply. Familiar as we are with the newspapers of the Northwest, having a large number of them upon our exchange list, we are thoroughly aware of the avidity with which the unsanitary conditions in this city have been advertised throughout the country, and a city campaign fought out in the newspapers would at this time work an almost irreparable injury to every material local interest.

Again we urge, let us have a clean, quiet campaign, hoping that when the votes are counted the result will express the honest convictions of a majority of the people.

Whatever else may be said of Booker Washington, it cannot be denied that he gave the negroes good advice when he told them to buy land instead of whiskey, cheap jewelry and other gewgaws. We are not sure what Booker meant by "other gewgaws," but assume from his knowledge of the race that he intended to include razors.

The assertion of the St. Louis Globe-Democrat that the marketable value of the country's wealth increases \$10,000,000 every day, would have been more impressive if it had been accompanied by a diagram showing the exact proportion of water in the increase.

Bound of big things as the country is, it will not enthuse over the deficit of \$100,000,000, which Chairman Tawney, of the house committee on appropriations, predicts for the next fiscal year, if congress don't put on the brakes during the closing days of the session.

PORTLAND MARKET REPORT.

Portland, Or., Feb. 28.—Export flour advanced 5 cents a barrel in the city today, as a result of car shortage, and is now quoted at \$3.30. Scarcity of such wheat as is used in the manufacture of this grade is given as the reason for the advance by the Portland Flouring Mills.

There is plenty of this wheat up country, according to advices, but the scarcity of freight cars renders its shipment to Portland uncertain. Orders for flour for the Orient are coming in freely, but cannot be filled on time in consequence of the scarcity of wheat, and no one seems to know when the shortage is to be relieved.

The advance in the export quotation does not affect the local markets, which are considered fairly steady.

Eggs Still Decline.
Fresh ranch eggs have taken another drop and are today quoted at 18 1/2 @ 19c a dozen. Receipts continue heavy and there is no demand for export, according to dealers.

Eggs, however, are as high as they usually are in the Lenten season, and the price is expected to decline as the spring approaches. Cold-storage men are getting ready to put eggs away when the price has declined to 16 cents, and that figure is expected to be the "bottom price" this season, as the local demand usually increases with the continued decline in the wholesale values.

"When eggs retail at 25 cents a dozen, and under, the consumption increases enormously," a prominent dealer said today, "and we do not look for eggs to retail at lower than 20 cents a dozen this year, as cold-storage men will take all that comes in when the wholesale price gets down to about 16 cents."

Lots of Hay Left.

Hay quotations are considered weak, as a result of the heavy stocks held over in the Willamette valley. The season for feeding stock was short in the valley this year, although stocks were pretty well depleted in the storm that visited this section last month.

Potatoes Not Exported.

The potato market is in bad shape from the exporters' point of view, and prices paid in the country have dropped materially. The San Francisco and Los Angeles markets are said to be stocked with potatoes from Minnesota and Wisconsin, and dealers in Portland are advised not to ship to those points for the present. Prices have kept up thus far this season as a result of car shortage in the east, but this short-

age is on the point of material relief, according to reports.

Lumber Is Firm.

Lumber quotations continue firm, and some dealers fear another advance, resulting from a scarcity of logs. City mills are all short of logs at this time, as the bad weather has caused a shutting down of many logging camps. Logs are now quoted at \$12 @ \$15 a thousand, which is a higher price than has been known here for many years. With the starting up of the camps next month more logs will be put into the streams, but the supply is likely to give out before the new product reaches the city.

Market Notes.

Chickens continue in good demand at top prices. Receipts are light and stocks soon disappear from front street sidewalks.

An advance of 25 cents a hundred is marked in the case of Graham flour. Cracked corn has gone up 50 cents a ton.

California vegetables are scarce again. The cargo brought up by the steamer of Sunday night was exhausted right away.

In onions a decline has taken place of 10 @ 20c a hundred.

In turpentine 2 cents per gallon advance is noted. Demand for paints and oils cause prices of these commodities to be considered firm.

Ripe bananas are abundant in the city and have to be sold at the hawkers' low figures in order to force them out of the market. Four cars of green bananas are due here toward the close of the week.

A good demand exists for hops, but the prices offered are not satisfactory to the growers.
