THE CITY CAMPAIGN
At the outset of the city campaign the Guard stated that it would endeavor as far as lay in its power to eliminate the bitter discussion that has filled the columns of the newspapers in preceding elections. We felt this to be a duty, even at the expense of incurring the ill-will of radical members of both factions, because of the detrimental advertising Eugene has been given in the past two years. It is also most essential at this time to bring our people together in efforts that are being made to advance the common good.

Now that only two days more of the campaign remain we are glad to know that there has been little discussion in the newspapers and nothing of an acrimonious nature. The candidates on the municipal ticket have published a statement of their position, and today Mr. Osburn sets forth his views of municipal matters in a signed article.

In this connection we would say that the Guard would not decline to publish short articles, bearing on the real issues before the voters, signed by responsible and reputable persons, but it will reject now and at all times communications from anonymous sources, the authors of which are afraid or ashamed to stand sponsor for the statements they promulgate.

AS TO SENATOR TOM KAY
Senator Tom Kay, of Marion county, was a caller at the Guard office last evening and is inclined to think that he has been unjustly criticised for his opposition to the university appropriation. He explains that he was not opposed to spending the amount of money asked for upon the institution, and was disposed to be even more liberal, feeling that the university was in need of a large sum, especially for new buildings and equipment. It was only the method of lumping together the appropriation for maintenance and betterments that the senator opposed.

Well, it's all over anyway, and we'll all accept Tom Kay's explanation and let him ride in the band wagon with the other representative and progressive citizens of the state. There are many less capable statesmen in Oregon's legislative assembly and few harder workers, and we will concede him honesty of purpose if we can't agree with him on all things.

It takes a man of ability and perseverance to build up and operate big factories in the Oregon country, and when Senator Kay's achievements in that line in Salem and Eugene are considered—well, we feel that the state needs more men of his kind.

EUGENE'S BANK SHOWING.
The statement of the condition of the First National Bank of Eugene, published in today's Guard, shows deposits aggregating over \$1,600,000. This is important to the public as indicating that times are good and money unusually plentiful here, since the Eugene Loan and Savings bank and Chambers-Bristow bank also report their business rapidly increasing. Over \$3,000,000 are now on deposit in the three Eugene banks,

and every day adds to the big pile of money that is accumulating in their vaults.
More important than any other phase of the situation is the rapid increase in deposits during the past year—in fact, the amount of money has practically doubled in that time. Could there be any surer indication of Eugene's marvelous growth as a business centre?

The outlook is propitious for the greatest year in the city's history—if every business man and property owner will become a working member of the push club and put his shoulder to the wheel.
Judge Sutton minced no words in sentencing S. E. Howell, former president of the Omaha Coal Exchange, to pay a fine of \$1000 and serve six months in jail, as may be seen from these: "You have been convicted of organizing in restraint of trade. This is as serious a crime as robbing at the point of a revolver." That's the proper treatment for such robbers.

A Pennsylvania legislator is ambitious of giving every citizen the legal right to swat an editor whenever he thinks he has been libeled. Perhaps just as much satisfaction, and more safety, might be found by labeling a dummy figure "editor" and kicking it around an hour or two every day.
The Eastern university presidents are certainly a versatile lot. One of them, as a bid for big donations, declared that there was no such thing as tainted money, and the donations failing to materialize he delivered an address ripping corporate greed and monopoly up the back.
There's always something doing in Ohio politics, but Burton's attempt to snatch the senatorial toga from Foraker promises to be a scrap of unusual proportions and ferocity, owing to its connection with national politics.

Salem Moves Ahead.
(Salem Statesman.)
The city council sounded the note of progress for Salem last night by passing the ordinance for the permanent improvement of State street with bituminous pavement and from this time forth the idea which has thus been set in motion will not stop until the three principal business streets are similarly improved, because the property owners and occupiers on the other two streets will not be satisfied with mud while their neighbors on State street have a hard, smooth pavement. Actual work on State street is expected to begin between May 10 and 15, as the necessary notices and other preliminaries will take until about that time. The people of the city will rejoice in this good beginning.
