GEER, THE OFFICE SEEKER

Ever since the enactment by the late legislature creating a railroad commission ex-Governor T. T. Geer, of the Pendleton Tribune, has been more or less perturbed over the matter. In the first place he was greatly worried lest the bill creating a commission would give Governor Chamberlain the appointing power, which, by the way, would have been done had it not been for such everlasting office seekers that think nothing of the welfare of the state and its people more than to rant, cry and confuse, and trusting in the duplicity of the machine voters and members of the legislature to open the way for the distribution of the sack into the hands that will not give up any job, no matter how simple fact that too many strings are attached.

The good people of Oregon have faith in their governor, attested by the fact that he has twice been elected to this exalted position, and if the plain people could have had a voice in the matter Governor Chamberlain alone would have had the power to appoint and control the acts of that commission, thereby making him responsible for the trust imposed on the commission, and any member thereof not performing his duty toward the state could then have been removed. The question is will it be done under the present arrangement?

Take, for instance, one Mr. Achison, comparatively a new comer to this state, who before his appointment was a corporation attorney for a certain Portland trust company to whom Geo. A. Steele, state treasurer, may be indebted for his position—is it not difficult to see where Mr. Achison got his pull, leading such men as Judge Lowell and other Oregon Republicans of ability?

While this Steele appointment is under consideration it might not be out of place to call attention to the placing of Treasurer Steele's brother, James Steele, in the office of state bank examiner at \$3000 a year salary and expenses, over other aspirants endorsed by the most responsible men of the state, regardless of party affiliations. George A. Steele is one of the appointing board who voted for his brother for this position, the other being Frank Benson, secretary of state, who nominated James Steele "without any solicitation," as has been asserted, on the part of George A. Steele, though when the time comes for the appointment of superintendent of the state insane asylum as a matter of courtesy Geo. A. Steele will naturally support Dr. Steiner, of Salem, to whom Frank Benson is committed for the place.

In regard to Oswald West, the governor's choice on the commission, and to whom ex-Governor Geer takes exception, Mr. West was state land agent and his services were so satisfactory and his abilities so pronounced that his appointment was merely a promotion well deserved. Geer's contention that the governor should have appointed a Portland man therefore giving an Eastern Oregon man a chance on the commission, simply would have meant two Portland men for the position.

The truth of the matter is the Tribune is the rankest machine organ in the state, and its editor, by standing in with certain grafting politicians and chronic pap-suckers, hopes to land a United States senatorship, defeating Hon. C. W. Fulton. The latter is now being attacked on all sides by the members of the old Geer regime, and every political utterance in the Tribune is insincere because it only voices the perennial campaign of its editor for office of some sort.

HEAR THE ARGUMENTS

The municipal ownership people will hold a campaign rally tonight, and it ought to be well attended. In this country fair and fair discussion is the basis upon which rests the superstructure of our free institutions. The man who declines to listen to the arguments advanced by those who honestly hold to opinions differing from his can never be in the very nature of things make a model citizen. The high privilege of suffrage imposes an obligation upon all who enjoy it, and they owe it to the nation, the state, the municipality to consider all phases of the issues involved in every campaign; to read and listen, and vote honestly and intelligently. J. E. Young has arranged to start up the Klondike sawmill, which is on Brumback creek, ten miles from Cottage Grove, and was formerly operated by the Cottage Grove Lumber Company. The product will be principally ties, which will be driven to Walden, on the O. & S. E. Railway. The mill is situated in a good body of timber. Mr. Young has enough timber to keep him going several years. He will put in new machinery, including new carriage, conveyors, etc., and later engine and boiler to provide power in the dry season, as the water power now in use, while ample for the greater part of the year, is not sufficient in summer time.—Leader.
