BEGIN WORK ON STREETCAR LINE MONDAY

Several Car Loads of Rails Left Portland Yesterday Morning. Large Force of Men Will Be Put to Work Monday in Paving People Are Ready Then.

A. Welch, general manager of the Willamette Valley Company, arrived up from Portland last night and attended to business matters connected with the company's affairs here today. He told a reporter this morning that his company will be ready to begin the work of building the street railway next Monday morning, and if the paving people are ready at that time a large force of men will be put to work on the streets. Six or seven carloads of rails were shipped from Portland yesterday, and they were expected in today. They did not arrive this morning, as expected, but doubtless will be in tomorrow.

The paving people are progressing with the work of setting up their plant and will perhaps be ready for the beginning of the work Monday, although there may possibly be some further delay. It is expected that the rock crusher will be given a trial tomorrow. A large force of men is busily engaged in getting out the rock for the crusher on the west slope of the butte, and will have plenty on hand when the machine is ready to start up.

Willamette Bridge. Mr. Welch informed the reporter this morning that the plans for the bridge across the Willamette for the Eugene-Springfield line have been completed, and the contractors are now figuring on them. The contract will be let in the near future and the work of erecting it will commence immediately thereafter. There are two sites for the bridge in view, one near the wagon bridge in Eugene and the other at Springfield. The plans for the structure fit either site. Both routes have been surveyed and it is hard to determine which one is the best, although a final selection will be made within a short time.

ORCHARD'S AWFUL STORY

Pettibone and Mrs. Moyer. He was as little disturbed by the intense stare of Richardson as he was by the fierce eyes of Peter Breen. He talked to Hawley just as he had talked to me when I saw him three weeks ago in Warden Whitney's office at the penitentiary. He recited his crimes quite impersonally.

No Brutality in Voice. When he spoke of the exploding of a bomb or the shooting of a man there was no color of brutality in his voice.

They seemed to be only common mechanical operations. He was told to fire a bomb or pull a trigger and the price was named, and he did the work. The price, considering the work, was never high. Five hundred dollars for assassinating two important men in the Middle West, where wages are high, is almost as low a price as the blood money of a Paris cut-throat. Orchard did not seem at all bitter about that.

Whenever he was short of money—and he always seemed to be short of money—he asked for something on account and always got it. He indicated no animosity in his tones. He exhibited no emotion. He seemed as unconcerned and matter of fact as a man talking in a smoking room about the price of crops.

Talks in Level Tones. And today when he took the high chair at 9 o'clock he commenced talking in the level tones of yesterday. The shutters were closed on the court room windows to keep out the glare of the sun. The room was dark. Judge Fremont Wood sat in the shadow, a mass of pink penicils before him on his desk.

We had grown immune to the monotony of the horror. It was dull, revolting and abhorrent. It was a weariness of public debasement. But at 11 o'clock we were listening again in shuddering silence.

Orchard had reached the August of 1905, the place, Western Federation headquarters in Denver, the persons present Haywood, Moyer, and Orchard. The strain and horror of so many murders was telling on Moyer just then.

He wanted no more killings in Denver, or Colorado. A western empire of labor—socialism in the United States of America—might be a prodigious idea, but its attainment by assassination was wearing upon the nerves of Moyer. But his conscience was not troubled. He had, it seemed, no essential objection to assassination, but he wanted a recess for Colorado.

Steuensberg Brought In. There were other states, though. Idaho, for instance, and ex-Governor Frank Steuensberg. Steuensberg had sent the United States troops to the Coeur d'Alene to teach United States law to the Western Federation. It was nearly eight years ago, but Steuensberg must be taught that the federation never forget. Steuensberg must be assassinated.

Orchard was to go to Patterson, New Jersey, afterwards, and write letters to judges and officials in Denver and Colorado, telling them that the fate of Steuensberg would be their fate also. It seemed a pleasant scheme.

Haywood was then called in, according to the story, and he gave Orchard many instructions regarding the personal habits of Steuensberg. Orchard was detailing that matter in court and adjourned. They opened the shutters and let in fresh air, and we praised God for the respite.

gusted the blowing up of the mine and promised Orchard \$200 to touch it off.

Afternoon Session. Attorney Richardson at the afternoon session attempted to draw the admission from Orchard that railroad detectives had arranged to draw the spies in an apparent effort to wreck the train at Cripple Creek, and then charge the attempt to the federation. Richardson brought out the fact that Orchard took four gallons of Greek fire to Cripple Creek from Denver and buried the explosive there.

By its questions the defense admitted that Moyer and Orchard traveled together from Denver to Orray in 1904, and that Moyer was heavily armed. Richardson intimated that this arming was because Moyer was protecting union men from "official thugs."

Court adjourned at 3:30 until tomorrow.
