

ORCHARD STILL UNDER CROSS EXAMINATION TEST

Boise, June 8.—The Haywood trial was resumed this morning. Orchard still undergoing cross-examination. Orchard said he met Pettibone in 1904, and Attorney Richardson next questioned the witness as to why Orchard had gone to Cripple Creek to get Steve Adams to help in his attempts on Governor Peabody. Richardson asked if he wanted Adams because he was a federation man. Orchard said no, that it was because he wanted a partner. The question regarding Adams' membership in the union, is taken to indicate that the defense will contend that Orchard was in the employ of the Mine Owners' Association, and was trying to involve the federation and federation men in all his crimes, in pursuance of the plot by the mine owners to break up the miners' union, by having their lawless acts attributed to it. Richardson devoted much of his time to fixing dates, evidently laying ground for contradictory evidence, and then went into the Gregory assassination in Denver. The witness

said he did not know Gregory and killed him because of his opposition to the federation and the coal miners. Orchard said the federation did not have anything to do with the coal miners, but Gregory had been a deputy in the employ of the coal operators and had been a detective at Idaho Springs during the federation strike there. Pettibone had reported the proposed assassination of Gregory to the federation executive board, and said that the board thought it would be a good thing. Orchard said the executive board was composed of Jack Simpkins, Jas. Kirwan, E. C. Coakley and Jack Williams. Asked why he shot Gregory three times with a sawed off shot gun Orchard replied coolly: "He didn't go down until the third shot." "You kept pumping until he did go down?" "Yes; there were five or six shots in the gun." Gregory called out something when

HARRIMAN HAS ESCAPED PROSECUTION

Washington, June 8.—That E. H. Harriman, the railroad magnate, is immune from criminal prosecution as the result of this testimony before the interstate commerce commission in New York recently; that the question of the prosecution of bituminous coal carrying railroads for discriminating against independent operators should be left in the hands of the attorney-general, and that the prosecution of the anthracite coal roads for maintaining a trust will begin in Philadelphia next week, were conclusions reached at a notable conference held at the White House tonight. The Harriman case and the cases of the coal-carrying roads were discussed for three hours by President Roosevelt, five members of his cabinet, two members of the interstate commerce commission, and special counsel for the government. Following the general conference, Attorney-General Bonaparte remained with the president to discuss the harvester trust. It is thought not unlikely that the question of prosecution of that organization will be left in the hands of the attorney-general.

OREGON WON BOTH BASEBALL GAMES

The Oregon baseball team won two games yesterday, one from the Chemawa Indians in the morning and one from the Salem high. The result of the first game was 8 to 2, and the second 3 to 2. Hurd handled the Indians, and Beck pitched against the high school lads until the seventh inning, when Clifford went into the box. The Chemawa team proved easy meat, but the high school team put up their usual fine game and died hard. This afternoon Oregon is playing O. A. C. at Corvallis. Clifford will probably throw for the 'varsity' and Todd for the Farmers.

KILLED WIFE AND DAUGHTER AND HIMSELF

Providence, R. I., June 8.—At Olneyville today George W. Lonsdale shot and killed his 11-year-old daughter, seriously wounded his wife and fatally shot himself. He also tried to shoot a boarder in the house, but the bullet went wide. The cause is not known.

MIDDLE WEST STATES SUFFER FROM TORNADOS

VARIOUS TOWNS IN ILLINOIS, INDIANA AND KENTUCKY ARE VISITED BY SERIOUS STORMS

Gradyville, Kentucky, is Serious Sufferer from Wind and Electric Storm, Drowning Twenty-One Persons—Several Killed at York, Illinois, by Tornado—Wires Down and Particulars Meagre.

Chicago, June 8.—Dispatches from various places in southern Indiana, Illinois and Kentucky tell of severe storms of tornado severity, that have caused some loss of life and the destruction of much property. Early today a tornado visited New Minden, Illinois, 25 miles southeast of St. Louis, killing four and injuring a score of others.

At Gradyville, Kentucky, a cloud-burst caused the loss of twenty-one lives, washing out eight residences. Meagre details from West York, Ill., tell of a destructive tornado that visited York shortly after supper last night, attended by a spectacular electrical display. Two dead have been recovered from wrecked buildings and the number of injured is placed at 30. Forty or fifty houses were demolished. The wires are down and the details were not obtainable.

The storm was especially severe at Farmersburg and Sullivan in southern Indiana, where much damage was done by wind and rain. Duquoin, Ill., was also visited last night by the same storm that caused the destruction of York, but no lives were lost.

SWAM TWO MILES IN LESS THAN HOUR

Percy Bretherton, a Portland freshman at the university, this afternoon swam from the head of the millrace at Judkins' point to the Eighth street bridge in exactly fifty-six minutes and thirty seconds. Bretherton dove off a boom and kept up a remarkable pace from the start, the distance being nearly two miles.

HAVOC WROUGHT BY TYPHOON ON CAROLINE ISLANDS

San Francisco, June 8.—The first details of the havoc wrought by a typhoon and tidal wave in the Caroline Islands the latter part of March were brought here today by Rev. G. H. Jagnow, a missionary who arrived on the steamer Coptic. The tidal wave rendered 1500 people homeless and 250 persons were drowned on one island alone and a number of lives lost on other islands. The typhoon lasted three days. The German government is sending provisions until the next crop matures.

TRACK TEAM NINE BEATS DORMITORY

The baseball game between the university track team and the dormitory nine yesterday afternoon resulted in the score of 6 to 3 in favor of the track team. Zacharias, the holder of the Northwest hammer record, caught remarkably well, and Oliver Huston, the sprinter and hurdler, dealt out the curves. Big Henry McKinney misbehaved around centre field, but made two big hits at the bat. George Hug cawed all over the left field garden and succeeded in getting just one assist. Eberle Kuykendall made a few errors on second, but behaved so well, generally speaking, that Manager McCree, of the Portland losers, is thinking of signing him for shortstop, the place left open by Jimmie Shinn. McKinney tried some football dives and once landed on his head at the plate. His running bases was a feature, for a baseman had to get a yard away from the base to get out of line. McKinney took up so much room. Huston, the pitcher, had the strangest upshoots seen in a long time. He started them down by his feet and frequently they went clear to the library building, a distance of fifty or sixty yards. He was remarkable for his batting, for the balls that he hit seemed to get some of his speed. Jamison, the miller, and Billy Woods, the half and mile runner, did some fancy stunts around short stop and third base, each trying to do worse than the other. But for all their mistakes and track tricks, the team managed to win by the other nine's bad playing, and thereby proved themselves the "champion track team of the United States."

Dan Kelly acted as coach, while "Bill" Hayward tried to imitate Coach Bezdek with the first team.
