SOUTHERN PACIFIC KNOCKS

The biggest enterprise that Eugene had in prospect, that of the St. Joe-Bracher sawmill below town, has been knocked by the Southern Pacific. While it has not yet been killed off it must be postponed for a year, after all preliminary arrangements had been made for immediate construction, because of the railroad company refusing to keep its agreement in regard to a spur line into the company's timber. This news will not come as a surprise to the people of this section, since they have learned by bitter experience that the Harriman interests are for obvious reason interested in holding back the development of the Willamette valley and throttling every enterprise they have the power to destroy.

The most discouraging feature of the situation is the ability of the railroad company, through its paid emissaries and agents, to keep the people divided. Some they control by favors, others by threats, and more by false representation of the facts. They fear development and growth because the country in its present condition may be controlled absolutely, but with growing population and wealth competition in transportation must inevitably come; hence their anxiety to destroy every enterprise of magnitude that is projected and to discourage capitalists from making investment here.

This is the strongest reason that can be advanced for the building of a road to the coast, and if the people of Lane county refuse to do everything in their power to gain independence then they deserve to become the permanent slaves of the Southern Pacific railroad. The true friend of the Willamette valley, however, should not be unduly discouraged. Our people are slow to act, but we predict that some time their indignation will reach such a pitch that it will arouse a storm that even as strong a trust as that headed by Mr. Harriman will quail before it. A united and earnest people, working only for what is right and just, becomes a power that no tyranny, commercial or otherwise, is able to long prevail against.

THE OPPORTUNITY HERE.

There is no doubt but the most important proposition ever submitted to the people, is that of the construction of a railroad to Sulzlaw tidewater. It is more important because that point in the development of the country seems to have been reached where outside capitalists propose to tap the timbered sections in the western part of the county with a railroad line, and the alternative is presented of securing the junction of such a road with the Southern Pacific at Eugene or elsewhere in the county. That it would be an irretrievable loss to this city to have the future business of that section diverted elsewhere hardly admits of argument.

The business organizations of Eugene are now working on a very tangible proposition that will insure the immediate construction of such a road, and one that requires the investment of but a small amount of local capital—so small, indeed, that it should be subscribed within twenty-four hours. And while the business men of the city are giving the movement substantial encouragement some of the larger property owners are said to be backward in doing what they are naturally expected to do. It is a difficult question to discuss in the papers because the promoters, who have only the good of the community in view, have requested as little publicity as possible until the success of the project is assured. We believe, however, that if the people of Eugene knew how easily a railroad to the coast might be secured they would accept the conditions at once, and that no property owner would be so short-sighted, or exhibit such a lack of public spirit, as to refuse to do his part, when the matter is presented to him in a proper light.

Opportunity knocks at the door of the city frequently but once, as is said to be the case in the individual career, and upon whether advantage is taken of that one chance future success or failure depends. In this case the capitalists who have been patiently awaiting a definite answer for more than a month may become discouraged and turn to other localities. If so, who knows that the opportunity will ever again be so favorable, if it comes at all. And the conditions of the present proposition are so easy that it would seem that a dozen substantial citizens would be justified in guaranteeing their fulfillment so that work might be proceeded with at once.

The Oregon editorially calls attention to the fact that there is no need for young men of the West to spend a large amount of money in attending the large Eastern colleges, when every advantage is now afforded by the institutions of this coast. That paper says editorially: "The University of Oregon is honored in another graduate—this time from its mining department—Herbert G. Moulton, whose success in the vocation of mining engineer has been pronounced, and whose promotion in that profession has been rapid. He goes from the New Mexico Copper Company, at San Pedro, N. M., to the Cobalt Mining Company, of Cobalt, Ont., as chief engineer, the position carrying a large salary. The instance is cited in proof that it is not necessary for a young Oregonian of energy and capability to spend a large sum in taking a course in an Eastern college in order to become successful in a technical vocation. Mr. Moulton is a but one of many young men who have passed from a course of study at the State University of the State Agricultural College to a position of responsibility and emolument and are already on the high road to prominence in their chosen professions."
