THE OUTLOOK FOR CUBA

An American colonist living near Camaguey stated in a recent interview, says a writer in the Metropolitan Magazine: "Under annexation we would soon be on the same footing as to the tariff as Porto Rico, and that means fortunes for all of us, and such prosperity as the Cubans never saw for them. Last year Cuba paid the United States more than \$46,000,000 in duty. Think what saving this means. It means our natural market—in fact, for much that we raise our only one. With no duty or a fair reduction, one of which would come under annexation, we could control the fruit market alone east of the Mississippi.

"We know all this will come, so we have laid out fruit plantations here that will astonish the world. We already raise the best oranges, bananas and lemons that go to New York. Few realize that there are more than one hundred and fifty million dollars invested in various honest enterprises in Cuba, and until this last revolution and talk of another republic, it was coming at the rate of a million a month."

The present program in regard to Cuba contemplates the taking of a census, which will consume some six months, to be followed by a municipal election in the coming autumn; then, after another six months, the election of a president, after which the final evacuation of the United States troops is fixed for January 1, 1909. It may be that before this time, by the common consent and agreement of the people of both lands, the island may come under the permanent protection of the American flag.

Undoubtedly Cuba's present need is practical education in many things, and when the preservation of law and order and the protection of property shall be guaranteed there by the government of the United States, the island may then be safely trusted to work out its own abundant salvation.

This is "flag day." Its observance may in due time become a pretty custom, but really it is of little value in teaching patriotism to the youth of the land, as its originators contend. The fact is that the flag of itself is worthy of no more respect than any other piece of bunting—it is what the flag stands for that we venerate. The principles and institutions of free popular government, as long as they are maintained, will ever be defended by our people with their lifeblood if necessary, but when these are subverted, all the flag day education on earth will not avail to find it defenders in time of need. It is superficial, and even pernicious, to teach blind loyalty to any emblem. What should be taught in our schools is that good citizenship demands that every effort be put forth at all times and in all circumstances to maintain pure, honest government, in which the rights of every individual, high or low, are safeguarded and protected, and that the flag is worthy of respect only as long as it floats over the "land of the free and the home of the brave."

HOW OLD GLORY CAME TO BE NAMED

Old Glory, the story we're wanting to hear is what the plain facts of your christening were; For your name, just to hear it, repeat it and cheer it, is a tang to the spirit as salt is a tear.

And seeing you fly, as the boys marching by, There's a shout in the throat and a blur in the eye, And an aching to live always for you or die; And so, by our love for you floating above, And the scars of all wars, and the sorrows thereof, Who gave you the name of "Old Glory?"

With the ever-increasing popularity of the term, "Old Glory," as applied to the national flag, there has come an interest and curiosity in regard to its authorship. To an old resident of Nashville, Tennessee, who answered to the query publicly propounded through the famous lines of the Hoosier poet is not far to seek; for beyond doubt it is contained in the old city cemetery there, in an inscription on the monument to the memory of William Driver, which reads: "His ship, his country and his flag, Old Glory."

As has been conceded, the term was brought into general use during the Spanish-American war by the "long blended ranks of the gray and the blue," but its local use dates back to the day of the entrance of the federal army into the city of Nashville, after the fall of Fort Donelson, February, 1862, when the veteran old flag of Captain William Driver, which had figured as the campaign flag in the great Whig convention of 1840—a convention that played no unimportant part in defeating Van Buren and electing the first Whig president, William Henry Harrison—was hoisted over the capitol.

But long years before this Old Glory was named. William Driver was a native of Salem, Massachusetts. At the age of twelve years he left his native town and took to the seas as cabin boy of a merchant vessel. His eighteenth year found him master of the ship. More than once was his staunch vessel subjected to piracy and violent outrage, common to seafarers of an early day. But throughout his long career as master of a merchantman, the Stars and Stripes, under whose protecting folds he sailed, were never lowered from the masthead, nor were the colors ever sullied by stain or stigma of defeat or dishonor.

Seeing the old flag thus doubtless float above him through the shine and storm of a quarter of a century of years kindled the inherent love in

his heart for this symbol of his home and native land into such enthusiastic ardor that, first in thought and afterward in speech, he christened it "Old Glory," and never, until his death in 1886, referred to the Stars and Stripes but by that name.

At the outbreak of the civil war he avowed his Union sympathies, and stood openly to his convictions after the secession of the state, at the risk of social ostracism, business losses, and threatened banishment.

Just after the secession of the state (Tennessee) Captain Driver publicly proclaimed his sentiments by daintily flying the flag from his window. Then, fearing its confiscation—which his action had rendered liable—he procured a calico quilt of royal purple hue and himself sewed the flag between its coverings.

Under the purple Old Glory rested the flag of the Confederacy floated over the capitol, and the city in all the pride, splendor and prosperity of an almost unrivaled past basked in the sunshine of the promise of ultimate victory for the Southland.

But to a sudden and rude awakening was this fancied security foredoomed. Like the breaking of a terrible thunderclap above the city came the cry, "Fort Donelson has fallen!"

Terror-stricken, the people rushed wildly in every direction, and the most ill-founded reports found ready credence in the excitement. It was announced that Buell would soon arrive and open his batteries from across the river; that the gunboats would lay the city in ruins. Some of the citizens urged the burning of the city, that only the ruins might be left to the enemy.

The fine suspension bridge across the Cumberland was fired. The commissaries were thrown open and vast quantities of public stores amounting to millions of dollars were distributed among the inhabitants or destroyed. The archives of the state were hurriedly conveyed to Murfreesboro, in a mad desire to escape an impending doom of whose nature they were wholly ignorant, houses were hastily vacated and priceless furnishings left a prey to the invading army. On foot, on horseback, by wagon, by any available way that best favored their flight, the crowds surged out of the conquered city.

With the furling of the banner of the "lost cause" Old Glory was joyfully wrested from its secret hiding place by Captain Driver and triumphantly flung to the breeze—the first Union flag, it is said, displayed in Nashville on that occasion.

It was a week later before the advance of Buell's army reached the bank opposite Nashville, and the 25th before the gunboats and transports arrived.

On the morning of the 26th the Sixth Ohio debarked from one of the transports lying in the river. Lieutenant Thatcher was seen to leave his company and with Captain Driver and a small squad of men disappear in the direction of the Driver residence. When seen again they bore Old Glory with them.

From the levee came the clamor and shouts of men, the rattle of musketry and the din of many feet. From over the water came the continuous roar of cannon. Up the hill and into Capitol Square passed the blue-coated columns to the capitol.

For a moment a deep hush fell upon the waiting victors. Then the stirring strains of the "Star-Spangled Banner" burst upon the ear and amid wild hurrahs and cries of "Old Glory!" "Old Glory!" that echoed to the distant hills, the old Whig flag of Captain Driver straightened out and floated from the topmost pinnacle of the capitol.

And thus Old Glory received her formal christening.
