WILL EUGENE RISE TO THE OCCASION?

The Merchants' Protective Association has been for some time past working on a proposition by which at least thirty miles of a railroad from Eugene to Siuslaw tidewater are to be constructed at once. The matter requires only the raising of \$50,000 locally to carry it through, and probably half that amount has already been pledged in stock subscription, mostly by the business men. The discouraging feature of the situation is that some of the largest property owners approached by the soliciting committee have given them little or no encouragement.

Now Eugene ought to raise this amount without any difficulty, and without appealing to outside help in the county, or the big timber interests along the Siuslaw. The \$50,000 necessary to secure the building of the first section of the road should be raised in this city, and then the other interests should be appealed to in the endeavor to secure the completion of the line to tidewater. This could no doubt be easily accomplished with thirty miles of road in operation as a basis for credit.

The benefits of a road, even reaching no further than to the big timber district thirty miles to the west are too apparent to make their enumeration or discussion necessary. Lane county must act in the matter of securing better transportation facilities before we are completely bottled up by the big railroad corporations, and this proposed line would prove to be the beginning of a new and better era we earnestly believe. The proposition is businesslike and devoid of all hot-air features—one that ought to appeal to well-wishers of Eugene and all who have property interests here. There has already been too much time lost in accepting the conditions and property owners, instead of waiting for the committee to call on them, should seek the opportunity to subscribe to the stock of the road, the control of which is guaranteed to the Eugene stockholders.

It seems like a clean-out issue now—a case of put up or shut up. A great deal of talk has been indulged in about high freight rates and poor service, but there are some persons who have talked louder when there was nothing definite in sight who will not allow their money to even whisper when it ought to talk to a purpose.

Eugene must be known in the future as a very cheap town of 7500 people if it balks at \$50,000 to secure when almost any other town in Oregon would give many times that amount toward a similar enterprise. Roseburg, half as large, raised \$115,000 in twenty-four hours, with no definite plan or line of action mapped out, and Marshfield and other Coos county towns towns promise to do even better than the Douglas county city. Thus it would seem that not only are Eugene's material interests affected, but her local pride as well is being weighed in the balance of public opinion.

Children and the Peace Crusade to The Hague.

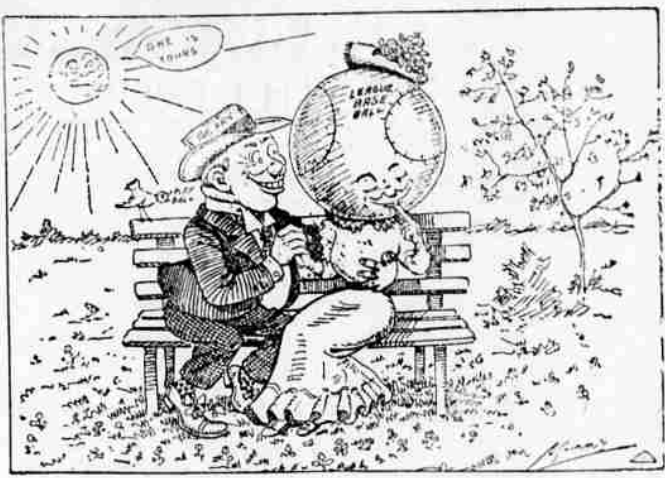
