NEXT SATURDAY SIUSLAW RAILROAD SOLICITING WILL END

On next Saturday morning the members of the railroad committee, who have worked so hard to secure sufficient pledges to guarantee the construction of an independent railroad to the Siuslaw, will cease their labors. Their list will then be submitted to Mr. Carver and if the necessary \$60,000 has been subscribed he will no doubt accept it and prepare for active operations in the way of railroad construction. This time limit was decided upon at a conference between Mr. Carver and the committee today.

Should the amount subscribed fall short of \$60,000 Mr. Carver will have his rails shipped to some other point when they arrive at Portland, and withdraw his proposition to the people of Eugene.

It is now up to Eugene to make every effort it purposes to make before the time limit expires. There should be a final effort made by every patriotic citizen to cause the supreme effort to build a city to result successfully.

It is no time for quibbling over trifles, or hesitating in reaching a conclusion. The proposition made by Mr. Carver is plain, clean-cut and business-like. It is the only proposition before the people and subscriptions must conform to it in every respect. Mr. Carver is a plain business man and says unequivocally what he will do. Eugene must either accept or reject, and whatever the decision he will accept it as final next Saturday morning.

The committee will make a special effort to see every property owner and business man who has not yet subscribed, and place many subscription papers in circulation. If they should fail Saturday morning, \$60,000, or even a few thousand more—the Siuslaw railroad will be assured, and Eugene will realize the dream of a decade. If the amount falls short, well, it will be in order to continue talking about building railroads some time in the future—because talk is cheap.

But the Guard does not believe the movement will fail; it expects to see a big committee of the whole, composed of every man and woman who loves Eugene—the queen city of Western Oregon—and has faith in her future working harder than ever for the next three days to accomplish a result that will mean almost everything in the nature of greatness that we have dreamed of for our growing city. Not only will the \$60,000 mark be reached by Saturday morning, but we predict that there will be a few thousands thrown in for good measure.

An Albany paper taunts the people of Eugene with building paper railroads, but before the winter season comes we purpose to show the people of Western Oregon the true spirit of our people, once fully aroused. Those who are so quick to taunt and sneer will be forced to acknowledge that Eugene is awake to the opportunities of the hour.

UNIVERSITY'S TRIBUTE TO LATE DR. CONDON ISSUED FROM PRESS

KANSAS "SOCIETY EDITRESS" DISPLAYS HER TALENTS IN REPORTING A FIRE

When "copy" gets scarce, as it sometimes does in the best regulated newspaper offices, the Sunflower state may always be depended upon to supply the deficiency. Now, when the mercury is hovering around 90 in the shade, and its too hot to hustle for a real live news item, some of our exchanges have sprung a story on a certain Kansas editor, whose staff consisted of one bibulous reporter and a "society editress," and who was impudent enough to take a vacation last month.

During his absence the inevitable happened—the reporter went on a howling spree and left the young lady, whose forte was descriptive stories of pink teas, to "hold down" the editorial and news end of the paper. Again, the inevitable happened—a big fire broke out in the residence district, and this was the account of it the editor read in his own paper a few days later:
