A deal for the sale of W. L. DeLano's drug store to A. W. Kuykendall was completed last evening and the new owner took charge of the business this morning. Mr. Kuykendall has sold his interest in the Yerington & Kuykendall drug store on East Ninth street to his partner, Geo. Yerington, who is now sole owner.

Mr. Kuykendall, who is an experienced druggist, will conduct the Delano store alone, keeping in his employ the present force of efficient clerks. It is learned that he has leased the north room of the Pratt block, now occupied by Quiner & Learned's millinery store and McJougall's tailor shop, and will move the store there some time in the near future. The First National Bank owns the building where the drug store is now located, and as has been stated by the Guard, will enlarge its banking rooms and utilize the building for that purpose some time in the future.

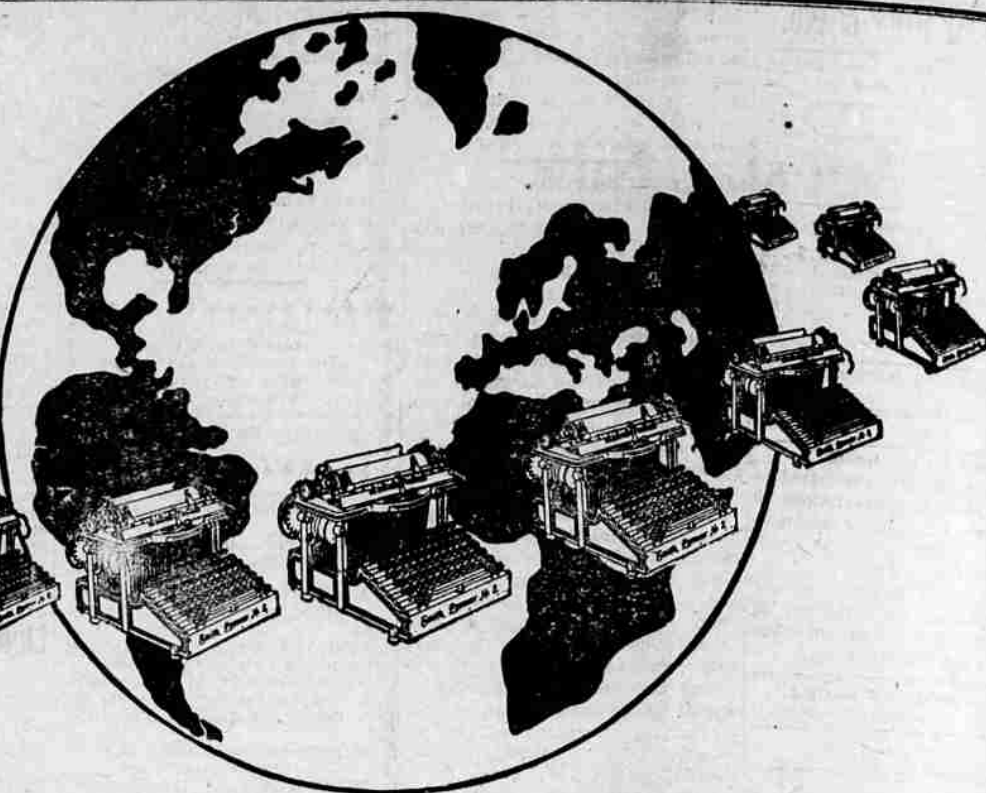
